Package Outline Dimensions

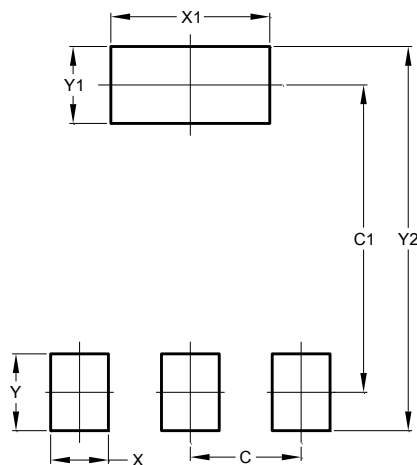
