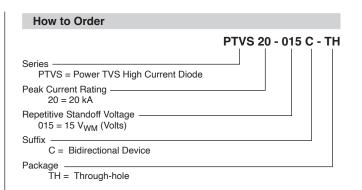

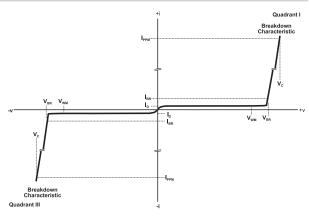

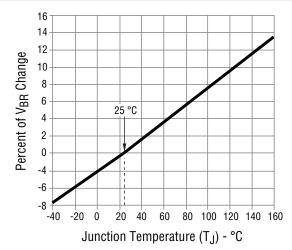

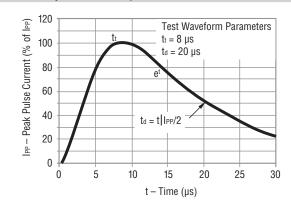
### V-I Characteristic

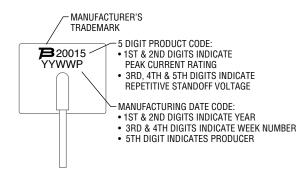

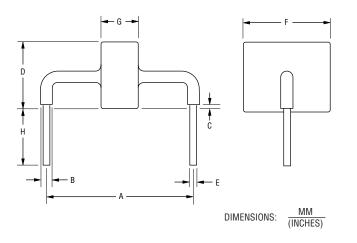
