#### **General Information**

Bourns offers small-signal Schottky Barrier Diodes for switching and rectification applications, in a compact chip package compatible with 0603 (1608 metric) size format. The Schottky Barrier Diodes offer a repetitive peak reverse voltage of 40 V with a choice of forward current of 200 mA and 300 mA.






#### Performance Graphs - Model CD0603-B0240R



#### **Typical Forward Characteristics**




#### **Typical Junction Capacitance**






Percent of Rated Peak Reverse Voltage (%)




#### Performance Graphs - Model CD0603-B0340R




#### **Typical Forward Characteristics**




#### **Typical Junction Capacitance**








#### **Typical Reverse Characteristics**



Percent of Rated Peak Reverse Voltage (%)


