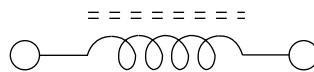

L vs. I Charts



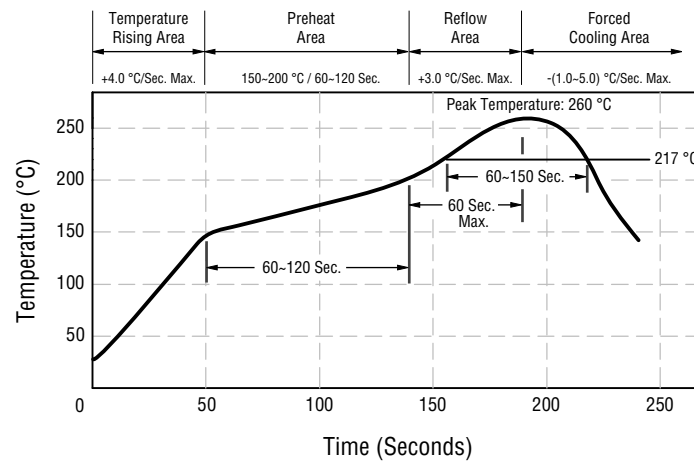

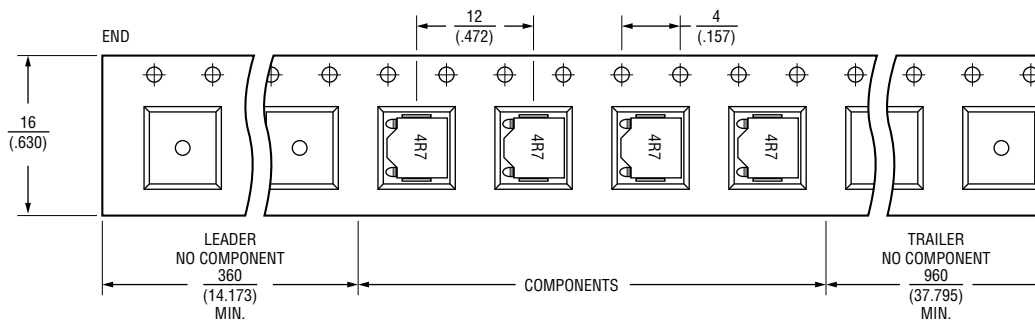
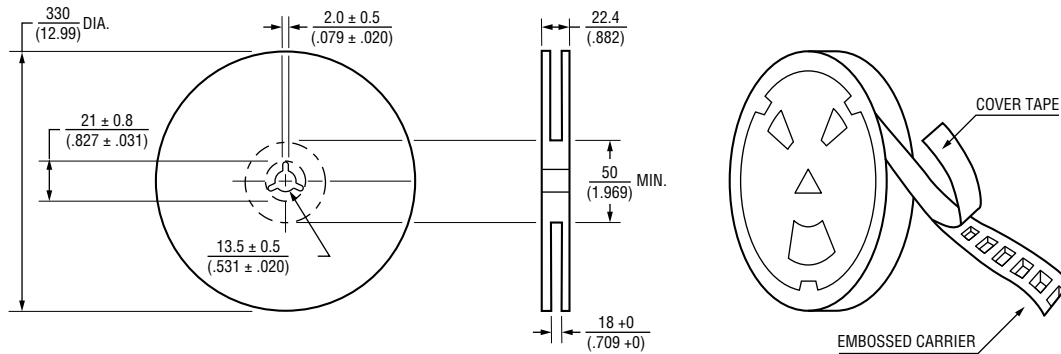
