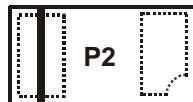

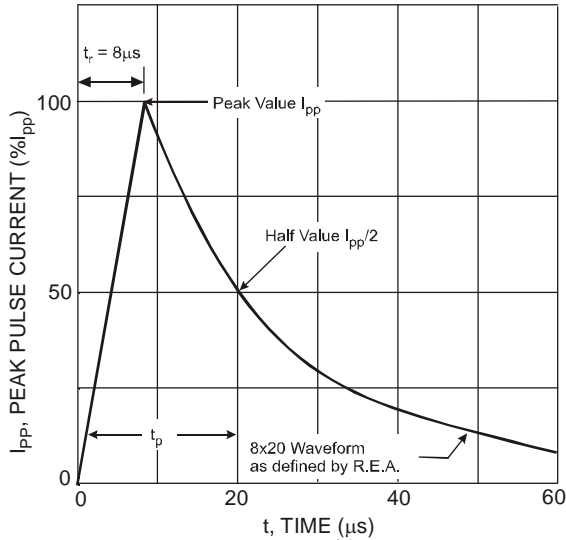


Figure 3 Typical 8 x 20µs Pulse Waveform

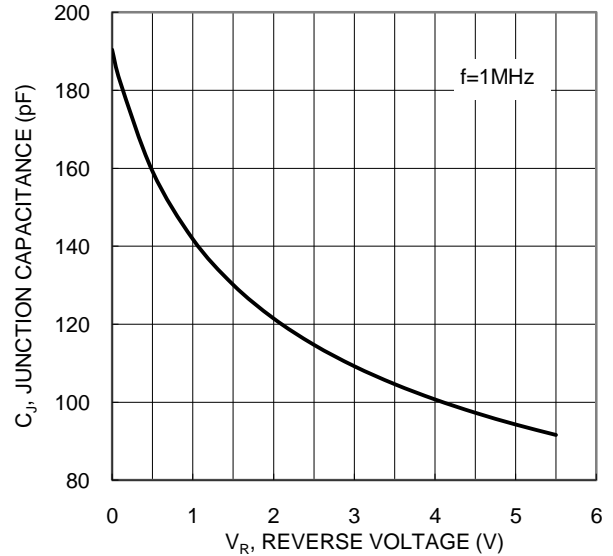
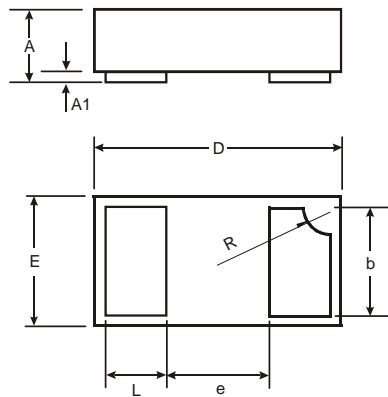


Figure 4 Typical Junction Capacitance

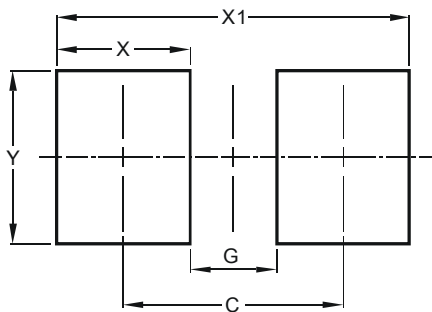
