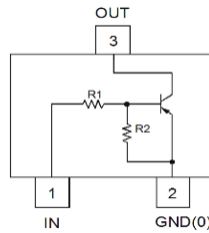

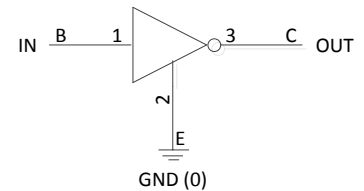

Equivalent Inverter Circuit

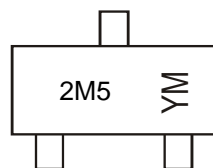
