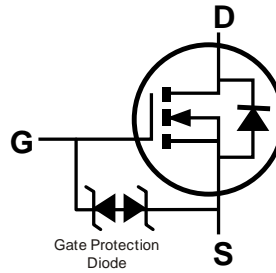

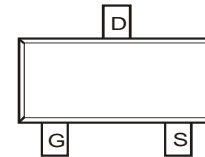

Equivalent Circuit



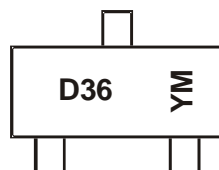

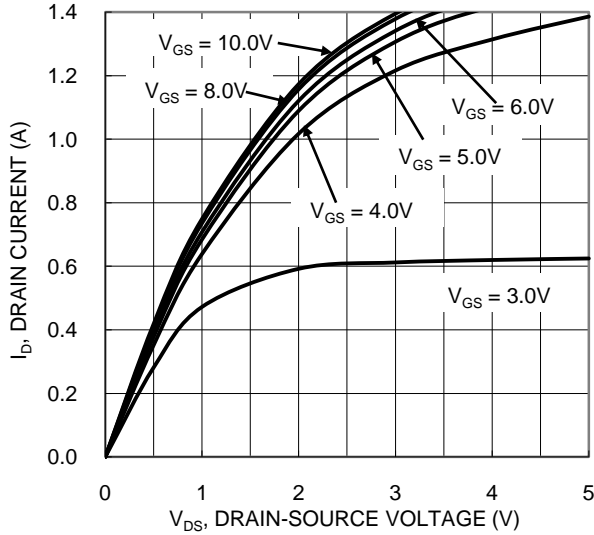


Figure 1. Typical Output Characteristic

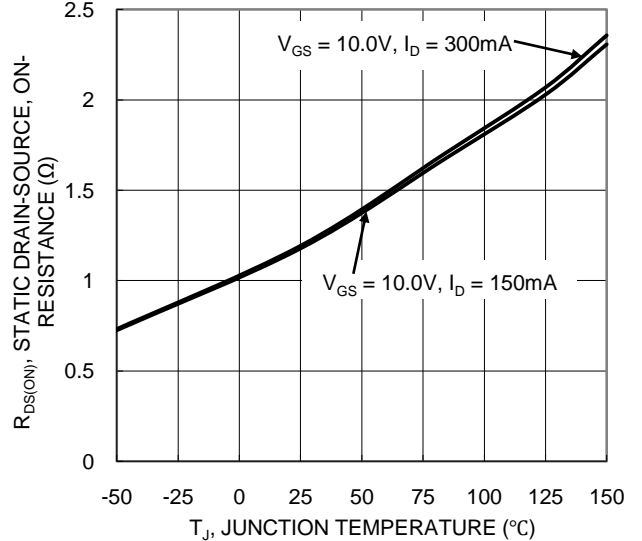


Figure 2. On-Resistance Variation with Temperature

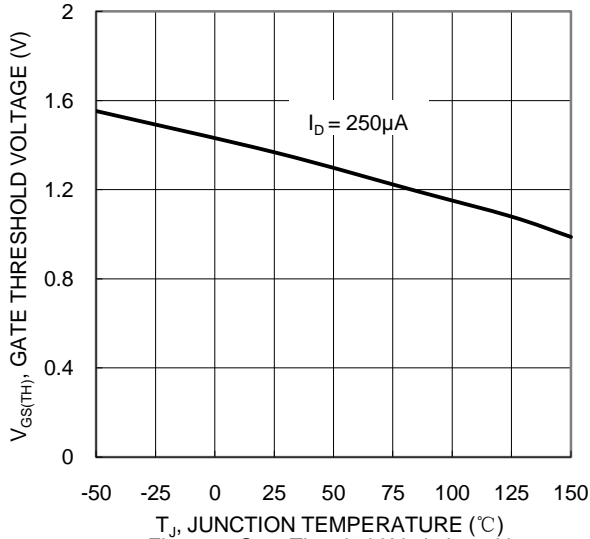


Figure 3. Gate Threshold Variation with Temperature

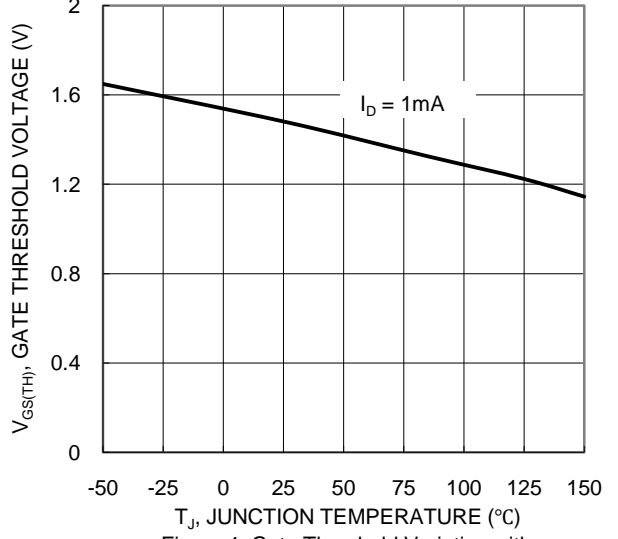


Figure 4. Gate Threshold Variation with Temperature

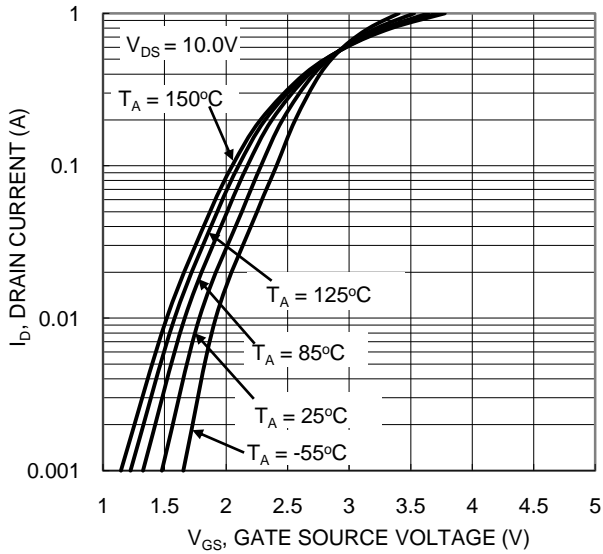


Figure 5. Typical Transfer Characteristics

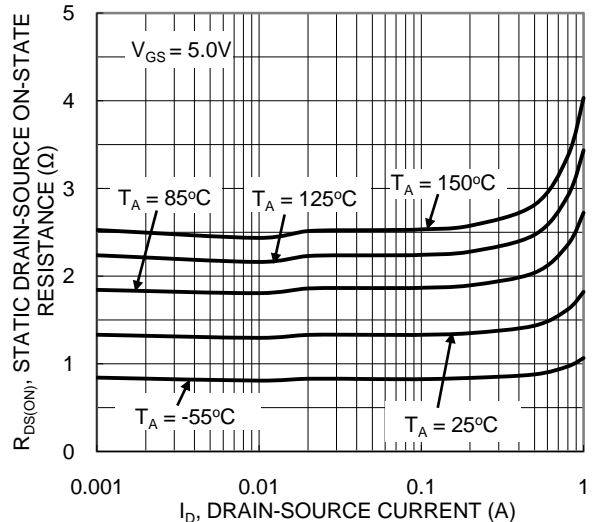


Figure 6. Static Drain-Source On-Resistance vs. Drain Current

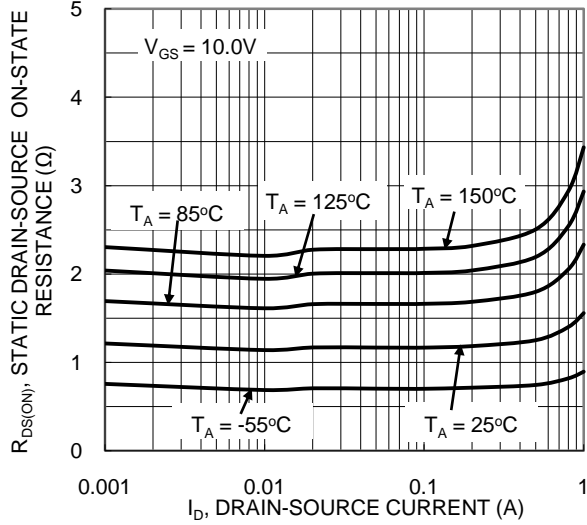


Figure 7. Static Drain-Source On-Resistance vs. Drain Current

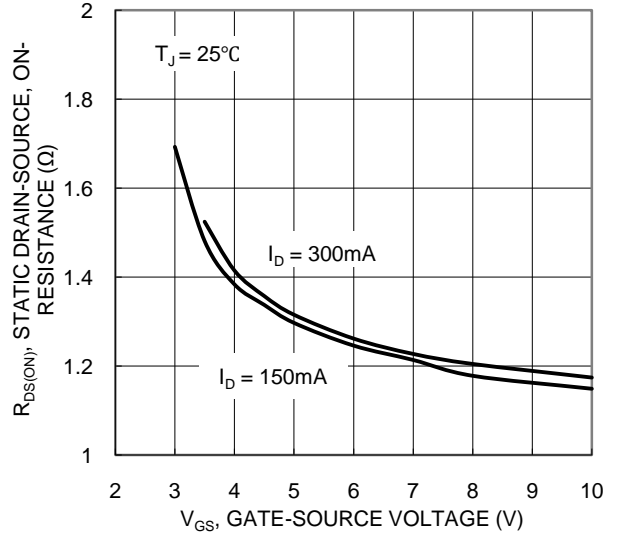


Figure 8. Static Drain-Source On-Resistance vs. Gate-Source Voltage

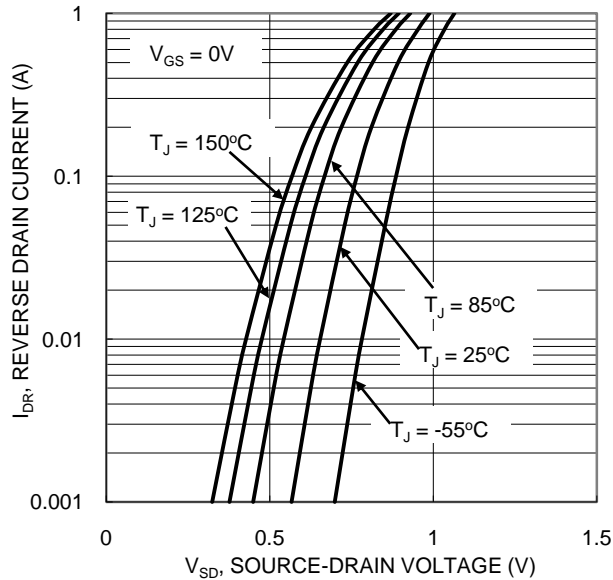


Figure 9. Reverse Drain Current

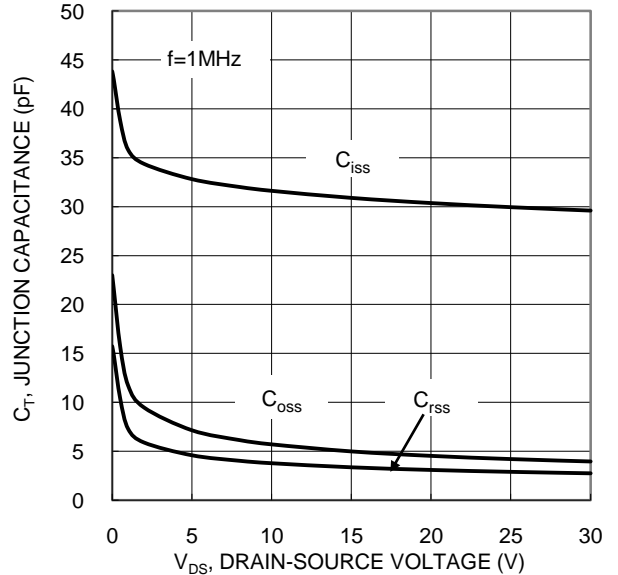


Figure 10. Typical Junction Capacitance

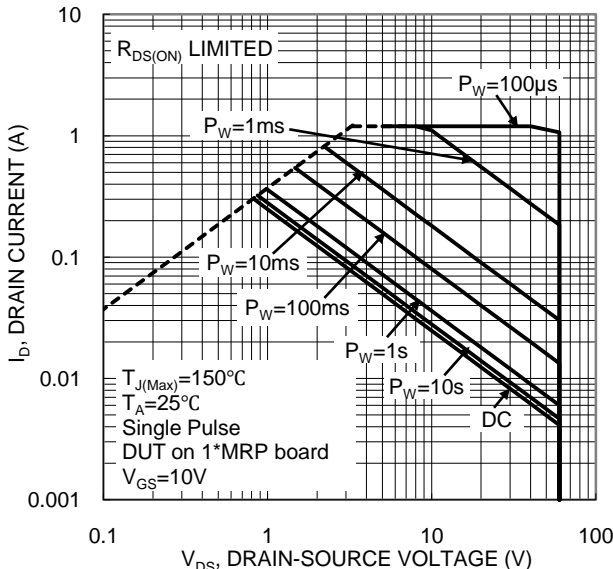


Figure 11. SOA, Safe Operation Area

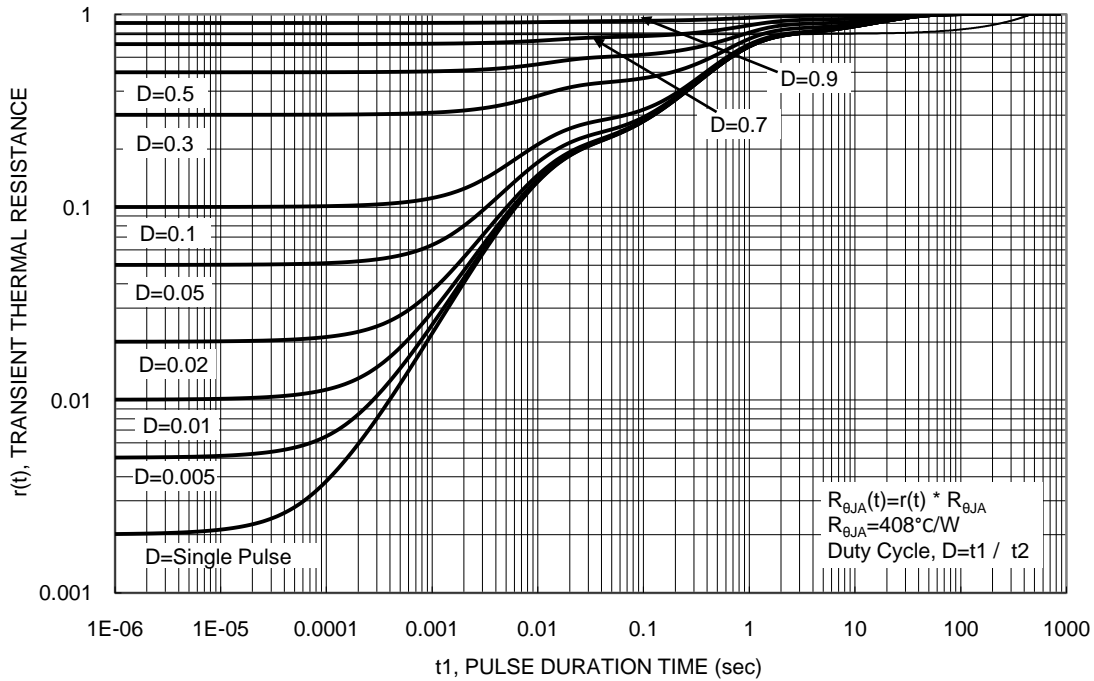
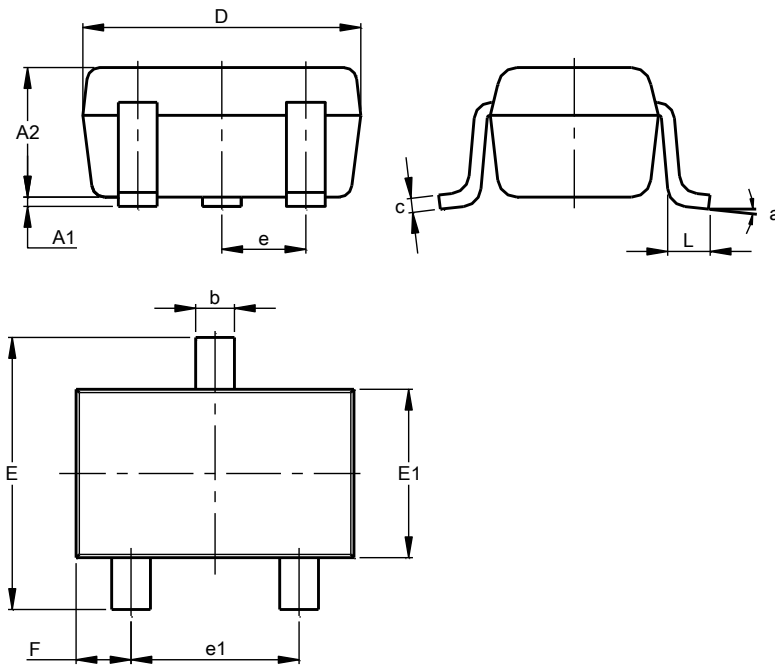


Figure 12. Transient Thermal Resistance

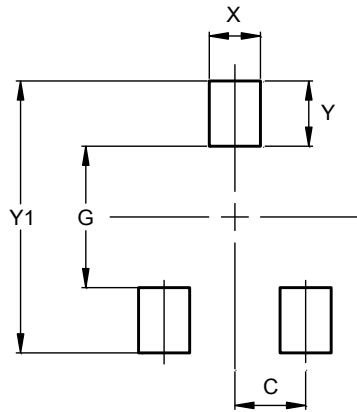
