


























Figure 6 On-Resistance Variation with Temperature









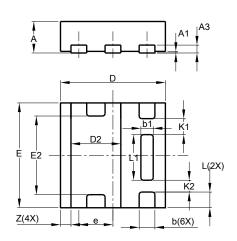


