



Max Power Dissipation vs. Copper Area





Transient Thermal Impedance
















 $V_{\text{CE(sat)}} vs I_{\text{C}}$








 $h_{\text{FE}} \text{ vs } I_{\text{C}}$

V_{BE(sat)} vs I_C




