

Description

The 74LVCE1G02 is a single 2-input positive NOR gate with a standard totem pole output. The device is designed for operation with a power supply range of 1.4V to 5.5V. The inputs are tolerant to 5.5V allowing this device to be used in a mixed voltage environment. The device is fully specified for partial power down applications using I_{OFF} . The I_{OFF} circuitry disables the output preventing damaging current backflow when the device is powered down.












Figure 1. Load Circuit and Voltage Waveforms










Package Outline Dimensions (All Dimensions in mm)

(1) Package Type: SOT25




(2) Package Type: SOT353





Package Outline Dimensions (All Dimensions in mm)


