




AVERAGE FORWARD CURRENT, (A)


#### FIG.1 FORWARD CURRENT DERATING CURVE




# FIG.2 NON-REPETITIVE PEAK SURGE FORWARD




#### FIG.3 TYPICAL FORWARD CHARACTERISTICS




#### FIG.4 TYPICAL JUNCTION CAPACITANCE

TOTAL CAPACITIVE CHARGE, (nC)


