






Pin1 **Bottom View**






Figure 5. Typical On-Resistance vs. Drain Current and Temperature






Figure 7. On-Resistance Variation with Temperature




Figure 9. Diode Forward Voltage vs. Current 10 8 6 $V_{GS}(V)$ $V_{DS} = 20V, I_{D} = 90A$ 4 2 0 0 60 20 40 80 Q_q (nC) Figure 11. Gate Charge






Figure 8. Gate Threshold Variation vs. Junction Temperature










Figure 13. Current De-rating





Figure 14. Transient Thermal Resistance


