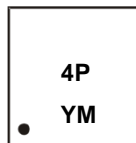
Device Schematic

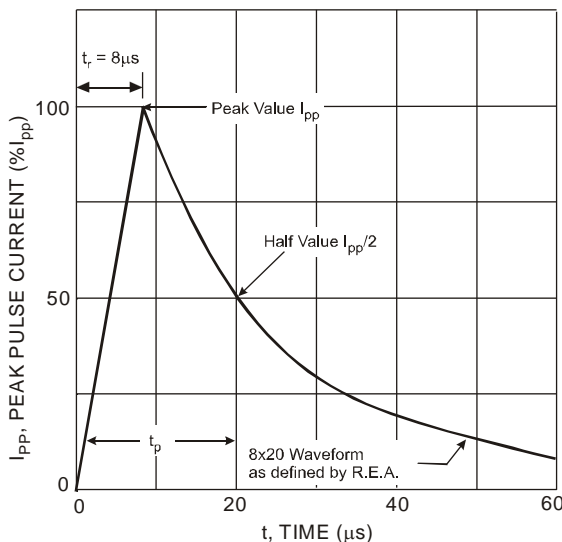


Figure 1 Typical 8×20μs Pulse Waveform

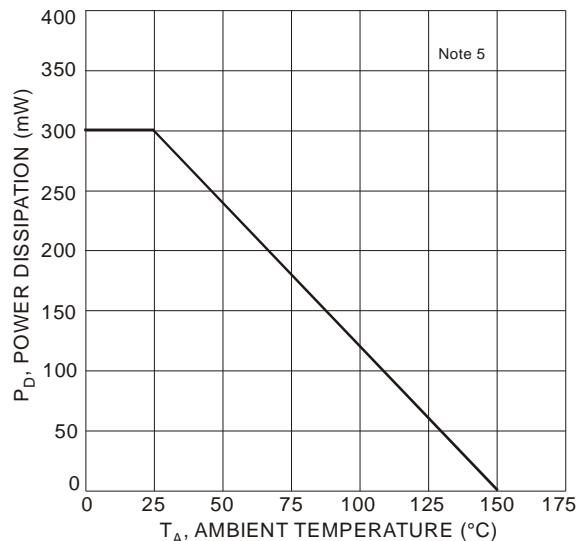


Figure 2 Power Derating Curve

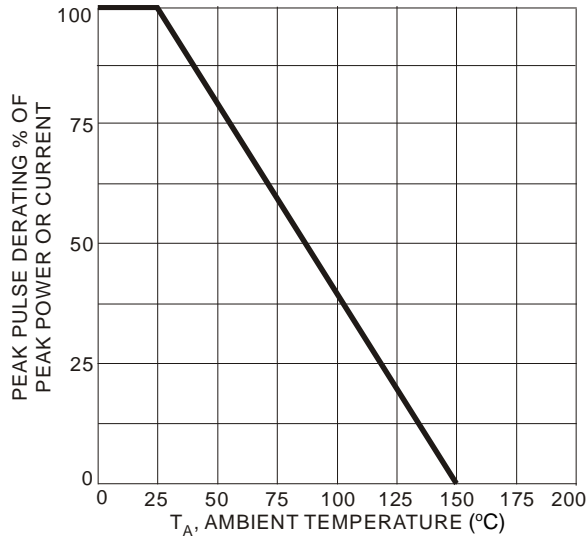


Figure 3 Power Dissipation vs. Ambient Temperature

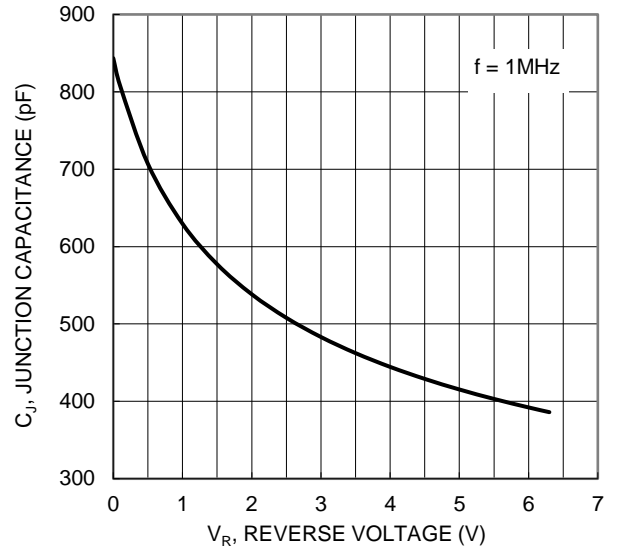


Figure 4 Typical Junction Capacitance

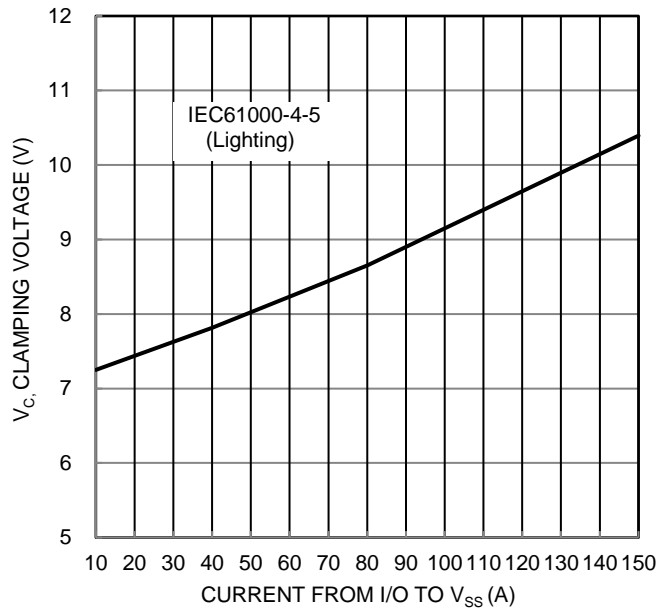


Figure 5 Clamping Voltage Characteristic

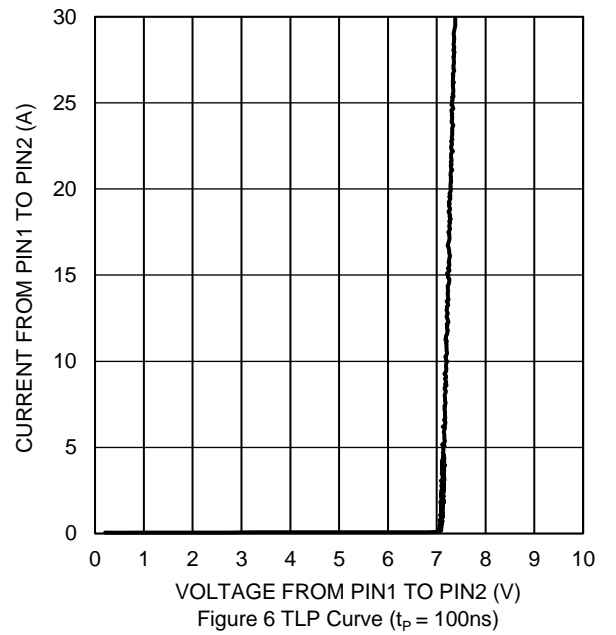
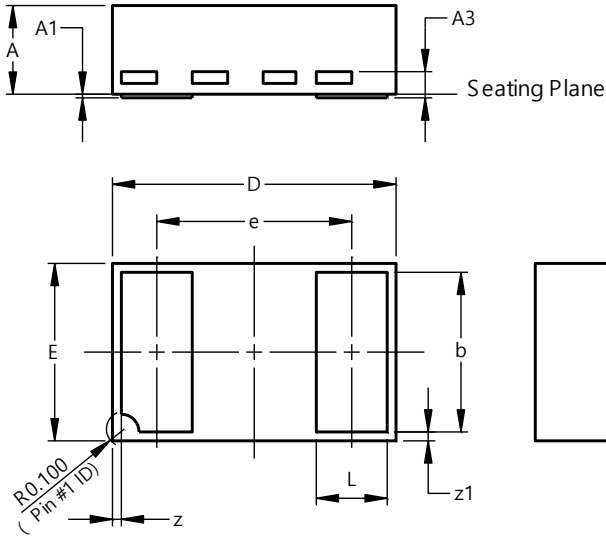


Figure 6 TLP Curve (t<sub>p</sub> = 100ns)

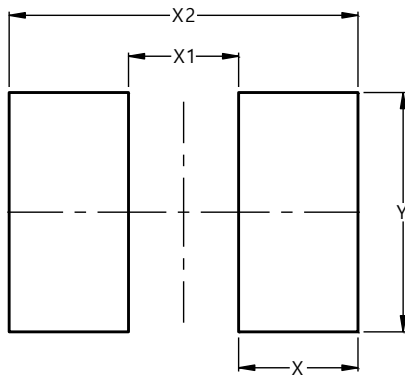
