




FIG.1- FORWARD CURRENT DERATING CURVE




FIG.3- TYPICAL FORWARD CHARACTERISTICS




FIG.5- TYPICAL REVERSE CHARACTERISTICS




FIG.2- MAXIMUM NON-REPETITIVE SURGE CURRENT





FIG.4- TYPICAL TOTAL CAPACITANCE


