










NUMBER OF CYCLES AT 60Hz
Fig. 3 Max Non-Repetitive Peak Forward Surge Current





 ${\sf V_R}$, INSTANTANEOUS REVERSE VOLTAGE (V) Fig. 2 Typical Reverse Characteristics
