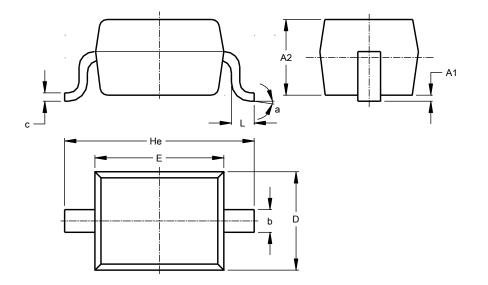






Package Outline Dimensions

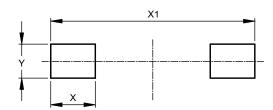
