Package Outline Dimensions

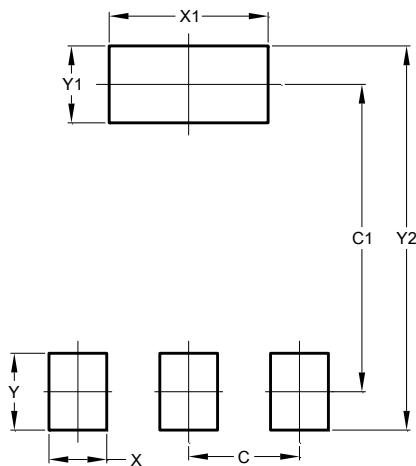
