






Top View

Pin-Out Top View










Safe Operating Area

Pulse Power Dissipation







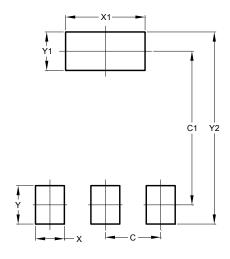
