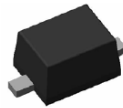

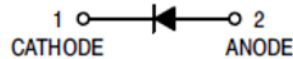

Schematic View

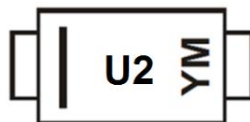
