




FIG. 1 FORWARD CURRENT DERATING CURVE




FIG. 3 TYPICAL FORWARD CHARACTERISTICS




FIG. 5 TYPICAL REVERSE CHARACTERISTICS




FIG. 2 MAXIMUM NON-REPETITIVE SURGE CURRENT





FIG. 4 TYPICAL TOTAL CAPACITANCE


