







Figure 5 Typical Peak Clamping Voltage V<sub>C</sub> vs. Peak Pulse Current IPP






Figure 4 Typical Reverse Characteristics







Figure 6 Typical Clamping Voltage vs. Contact Discharge Voltage

+8kV Contact








