## Product description

This Infineon ESD (electrostatic discharge) protection device has a bi-directional and symmetric  $I/V$  characteristic with excellent clamping performance and high linearity.

## Feature list

- ESD / transient protection according to:
  - IEC61000-4-2 (ESD):  $\pm 14$  kV (air) /  $\pm 11$  kV (contact)
  - IEC61000-4-4 (EFT):  $\pm 1$  kV /  $\pm 20$  A (5/50 ns)
  - IEC61000-4-5 (Surge):  $\pm 2$  A (8/20  $\mu$ s)
- Bi-directional maximum working voltage:  $V_{WM} = \pm 5.5$  V
- Line capacitance:  $C_L = 0.12$  pF (typical) at  $f = 2.5$  GHz
- Clamping voltage:  $V_{cl} = 30$  V (typical) at  $I_{TLP} = 16$  A with  $R_{dyn} = 1.29 \Omega$
- Very low leakage current:  $I_L < 1$  nA (typical)
- Small form factor SMD size 0201, low profile (0.58 x 0.28 x 0.15 mm<sup>3</sup>)

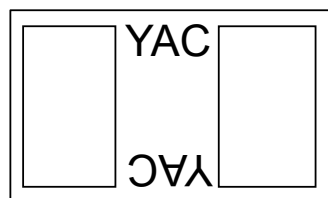


Figure 1 Pin configuration and marking (bottom view)

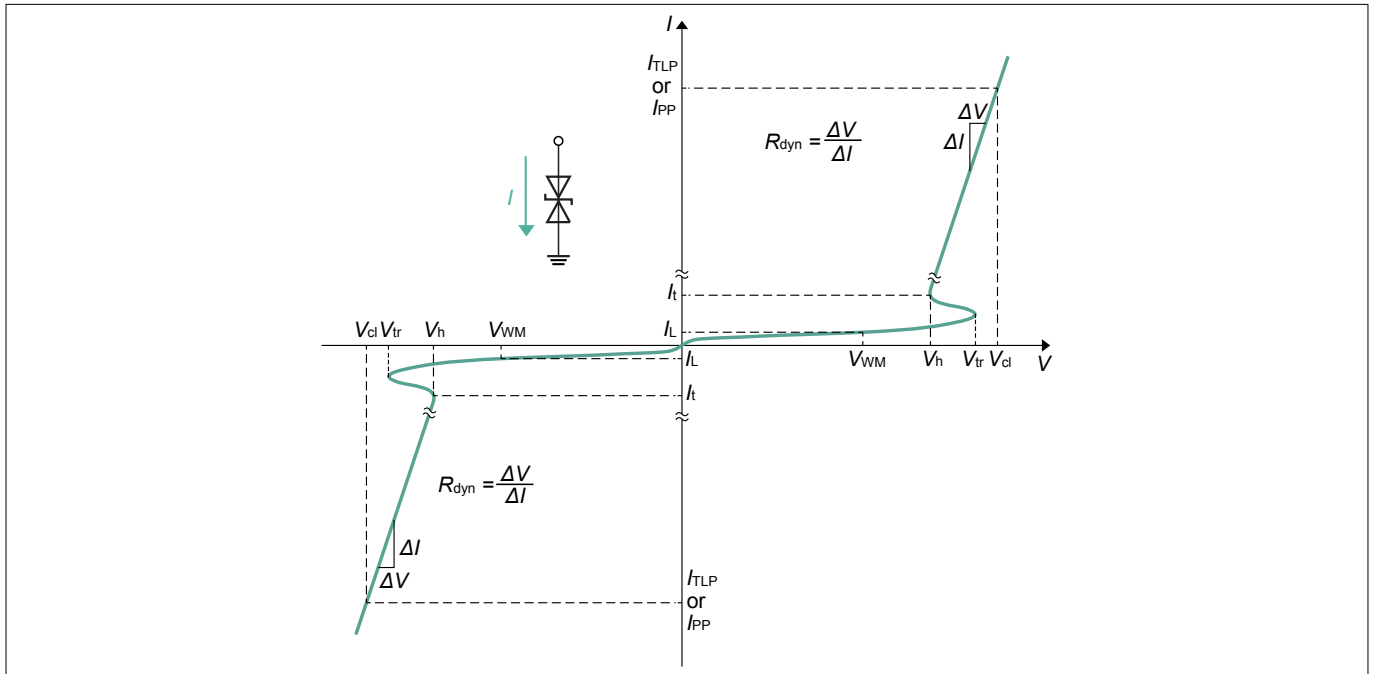

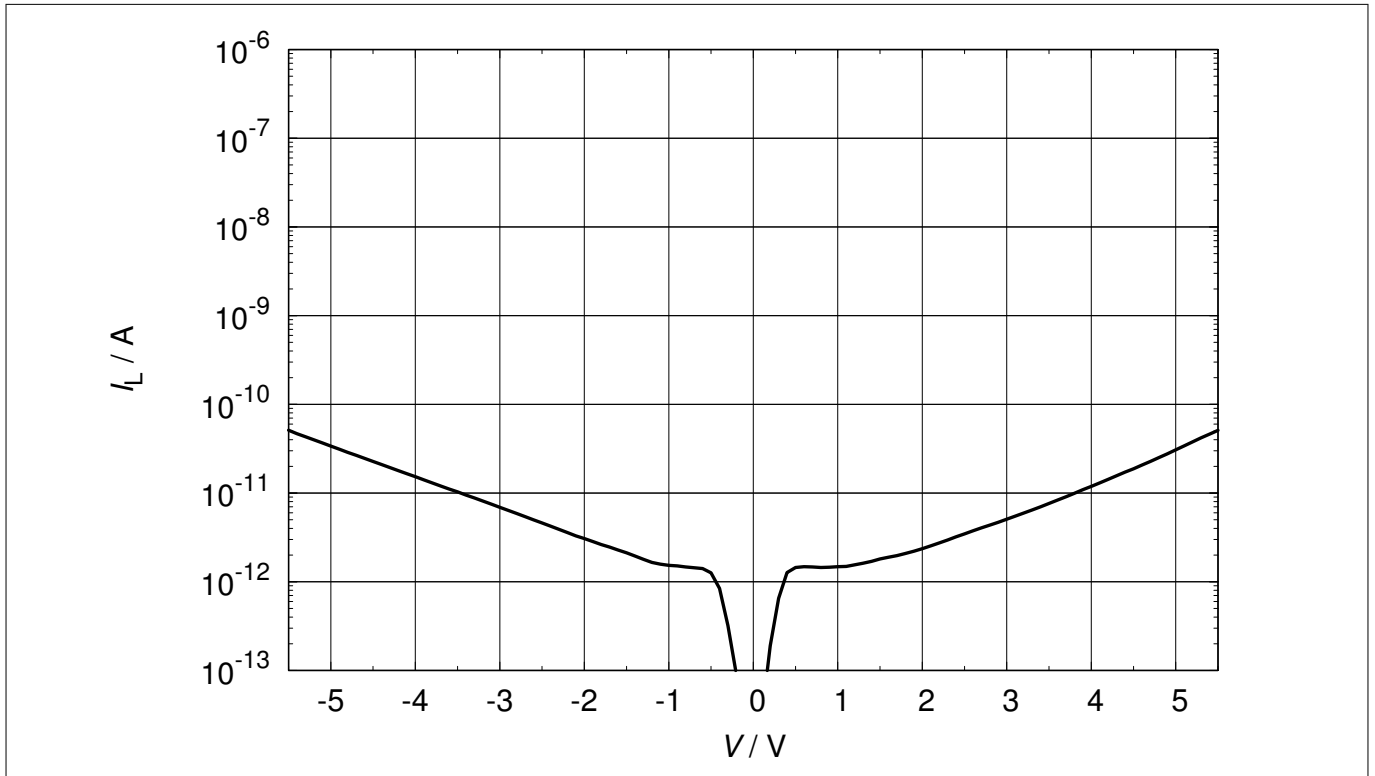


Figure 3 Leakage current:  $I_L = f(V_t)$

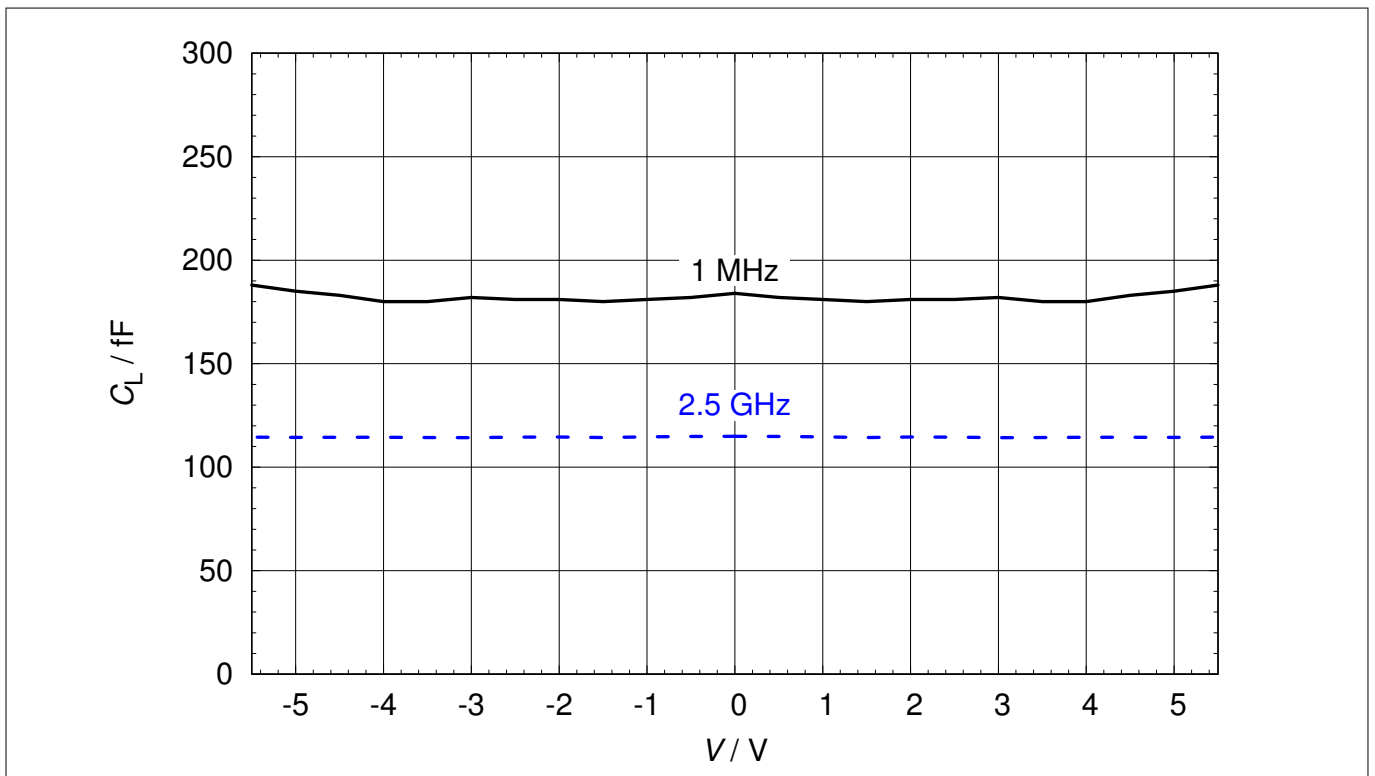
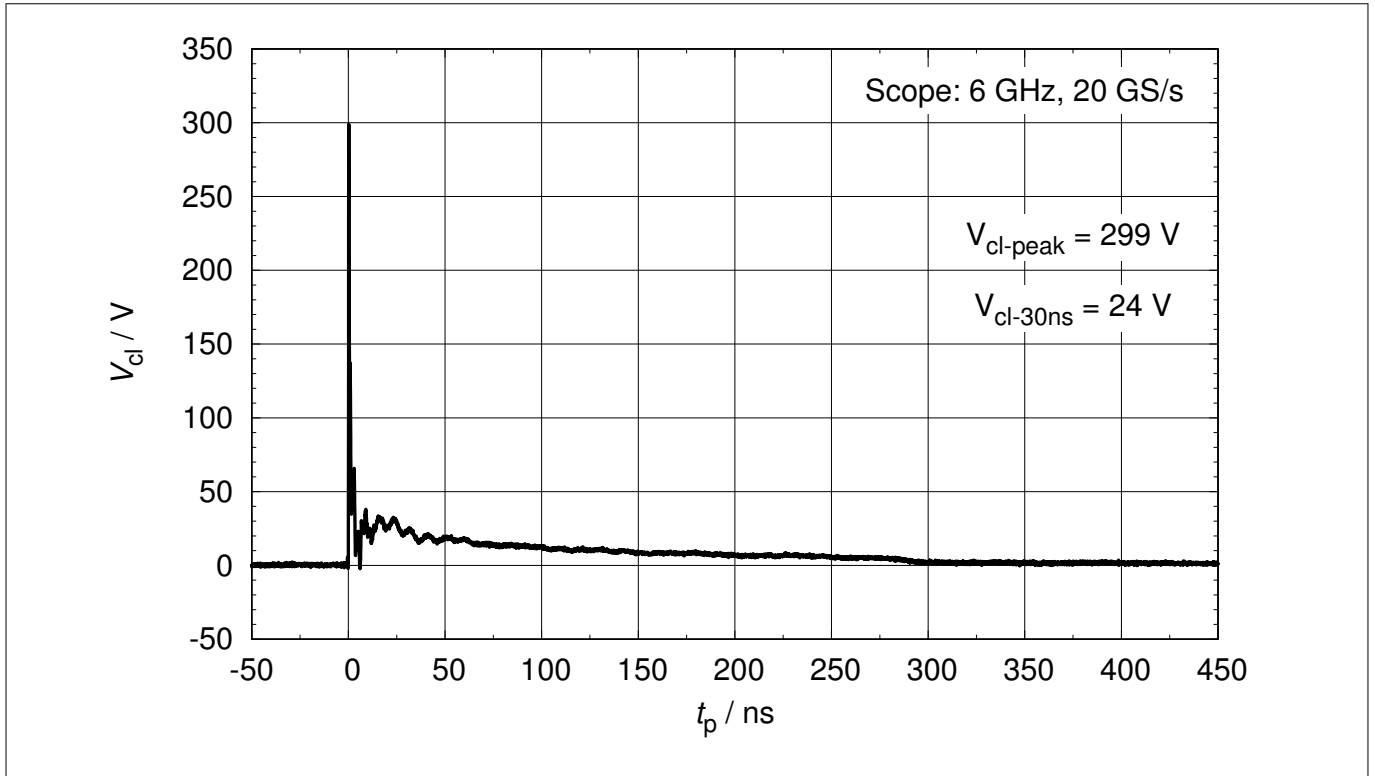
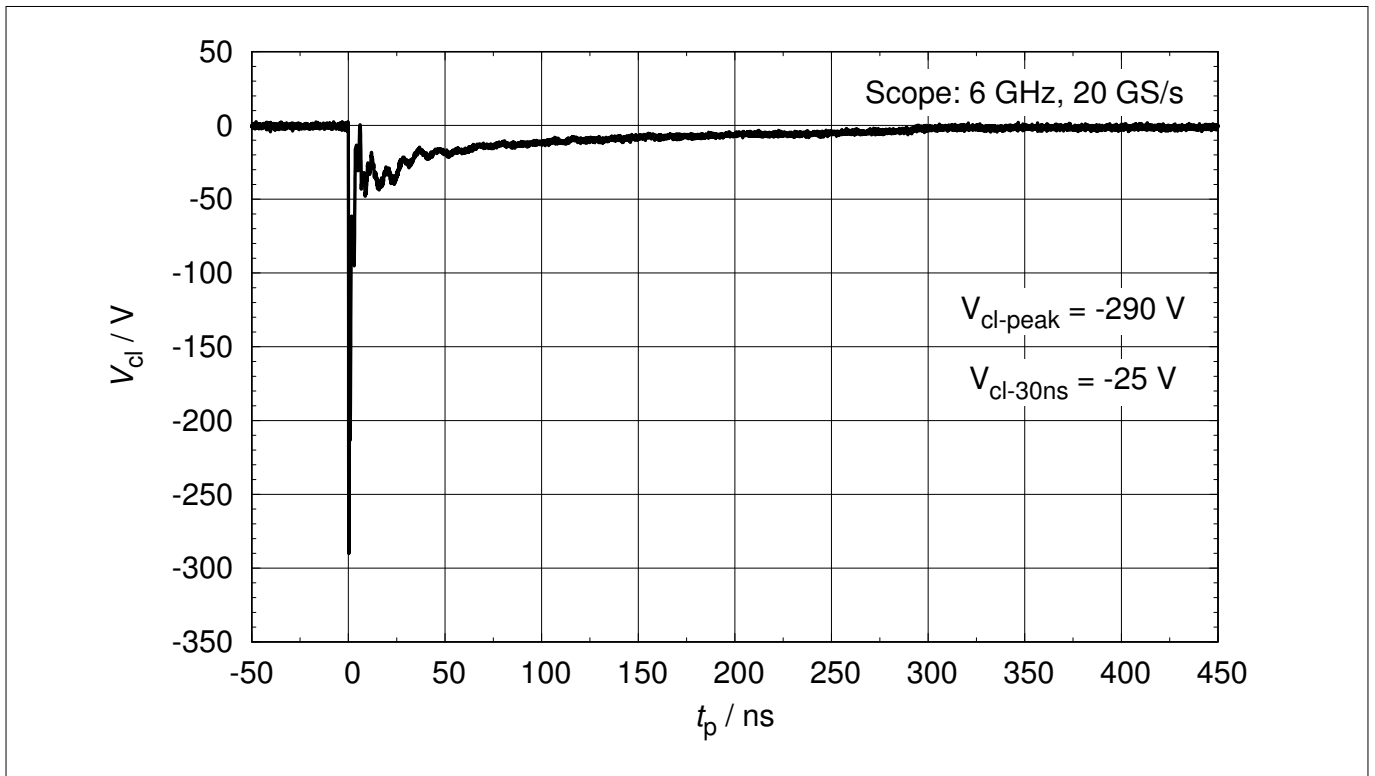


Figure 4 Line capacitance:  $C_L = f(V_t)$ ,  $f = 1\text{ MHz}, 2.5\text{ GHz}$

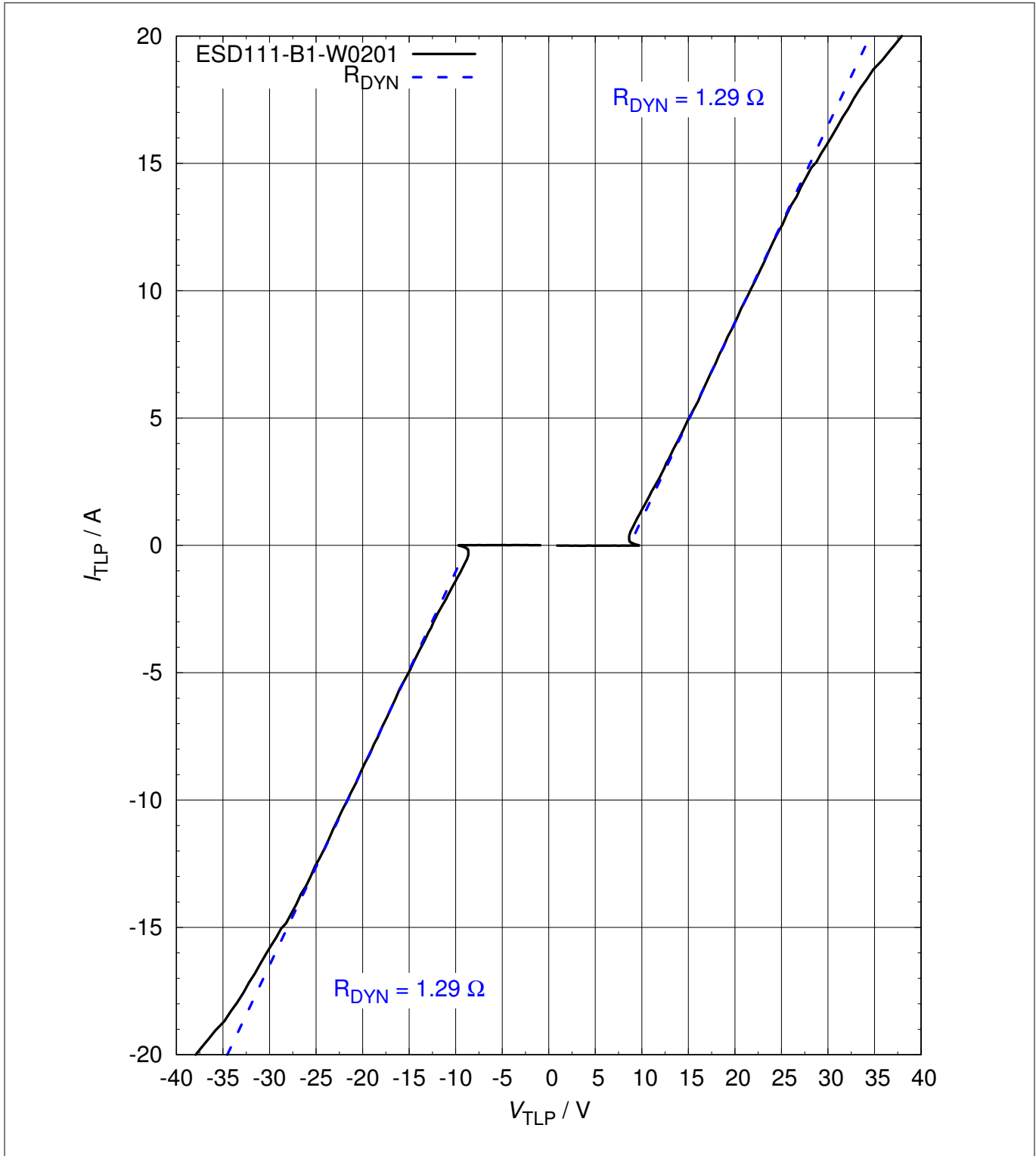


**Figure 5 Clamping voltage (ESD):  $V_{cl} = f(t_p)$ , 8 kV positive pulse based on IEC61000-4-2**



**Figure 6 Clamping voltage (ESD):  $V_{cl} = f(t_p)$ , 8 kV negative pulse based on IEC61000-4-2**

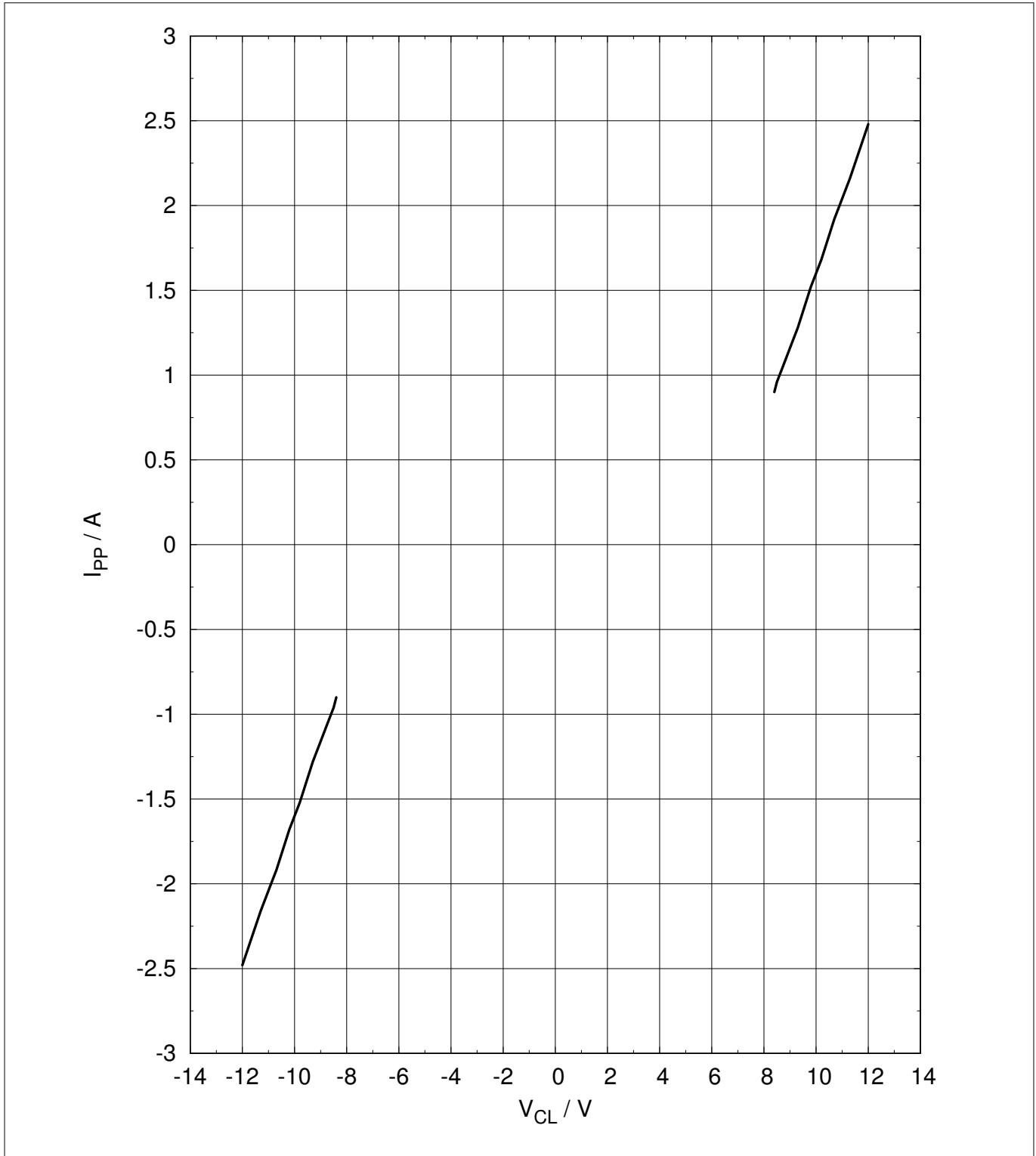

**Figure 7** Clamping voltage (TLP):  $I_{TLP} = f(V_{TLP})$

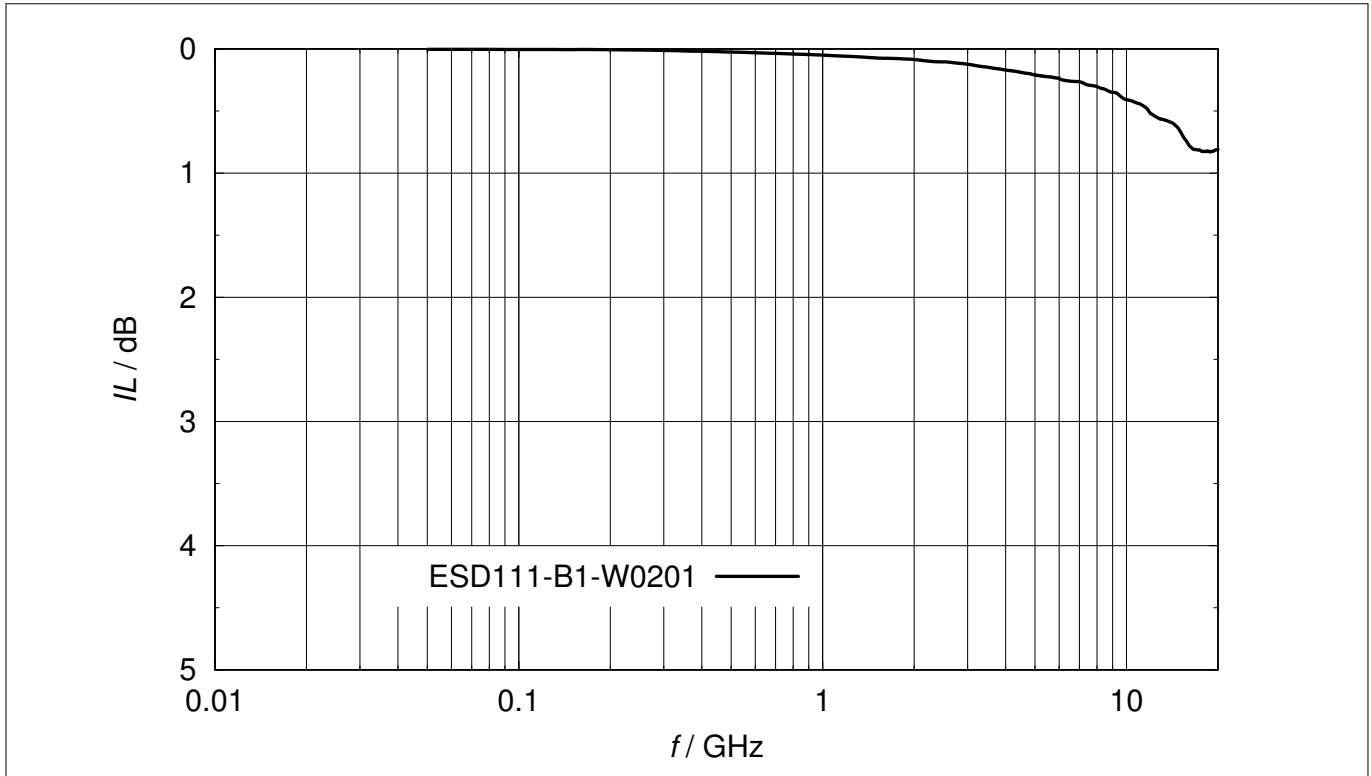


**Typical characteristic diagrams**

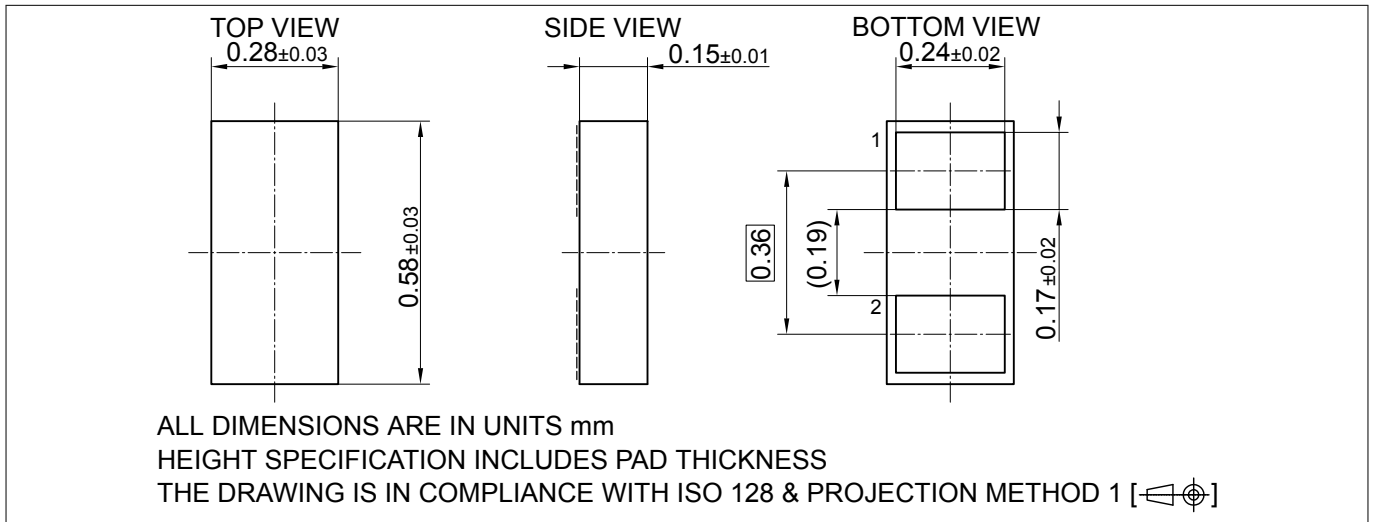


Figure 10 Package outline
