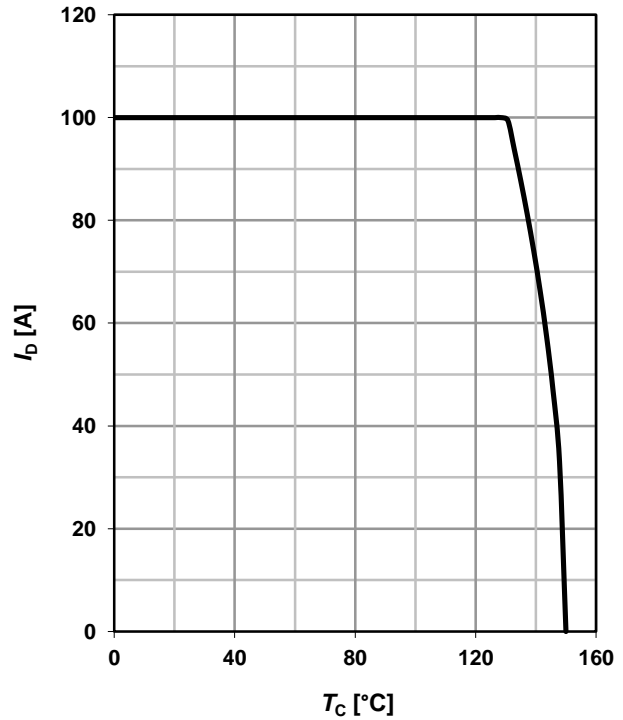

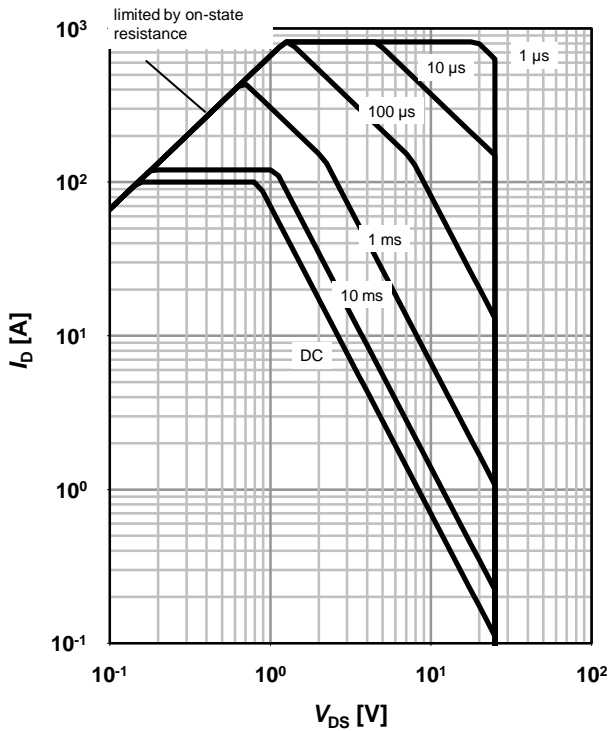

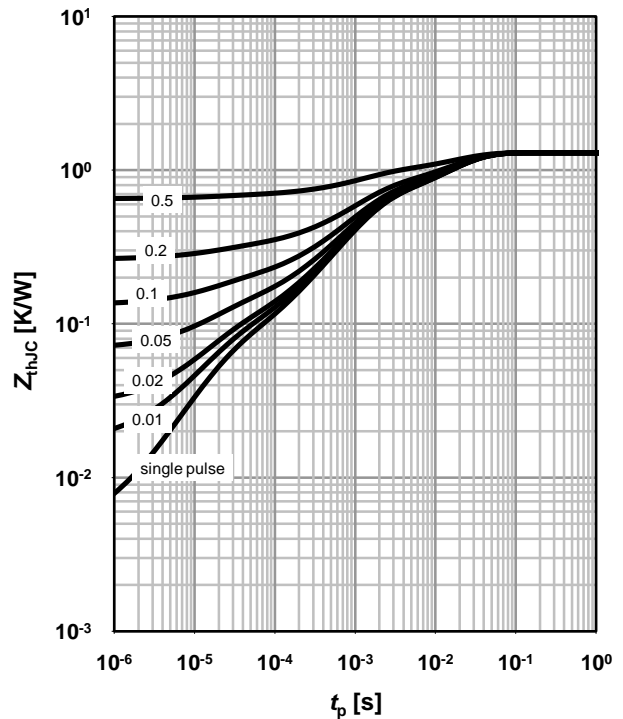

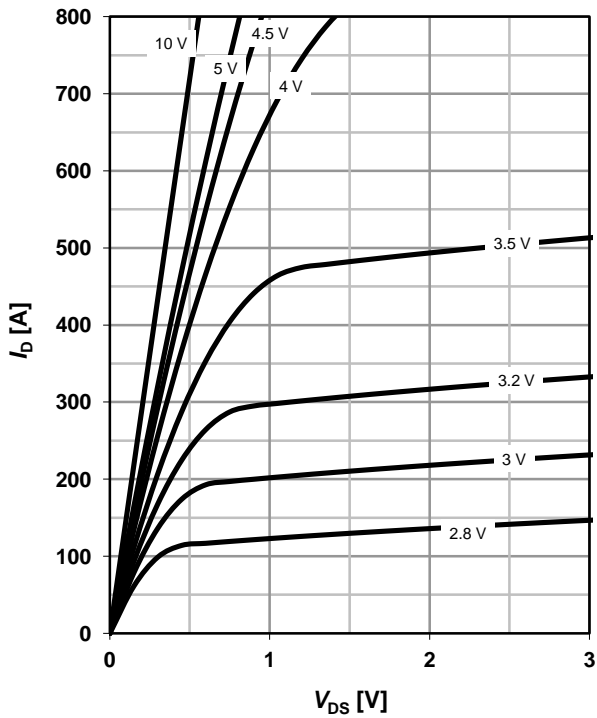

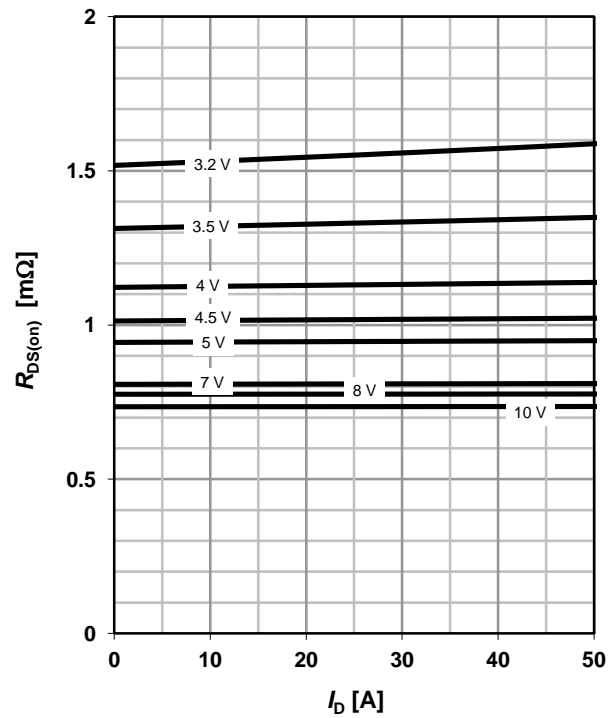

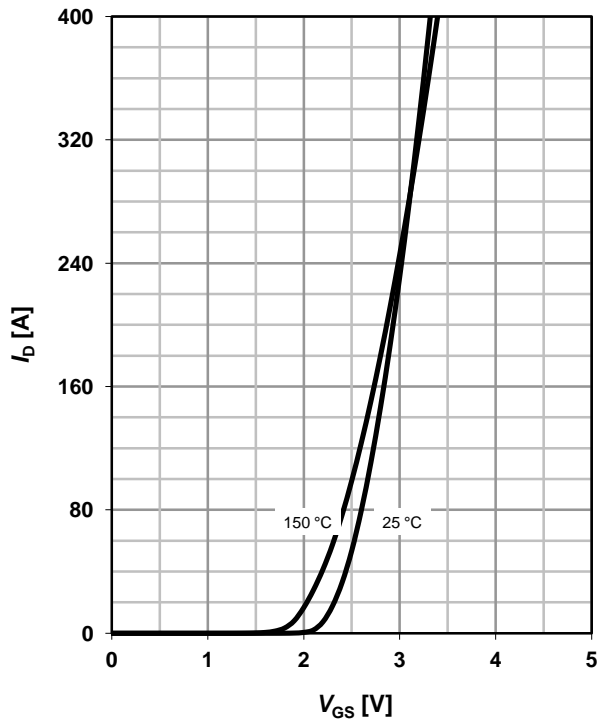

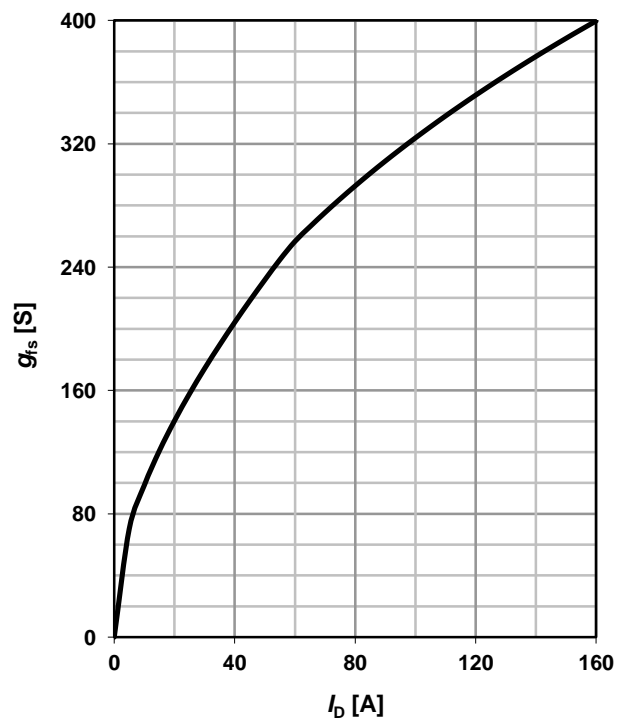

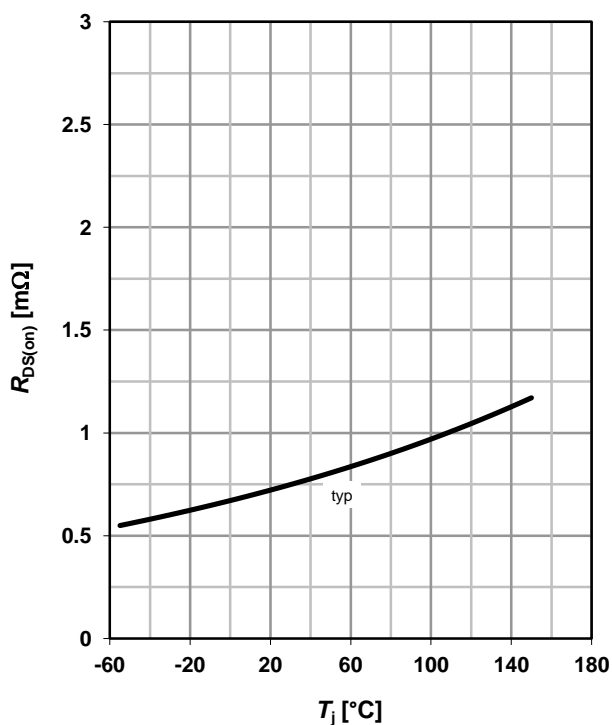
8 Typ. forward transconductance

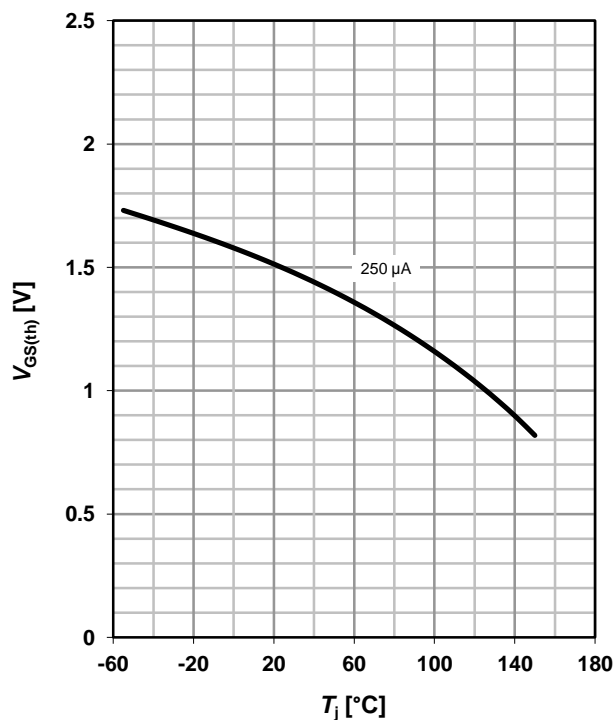

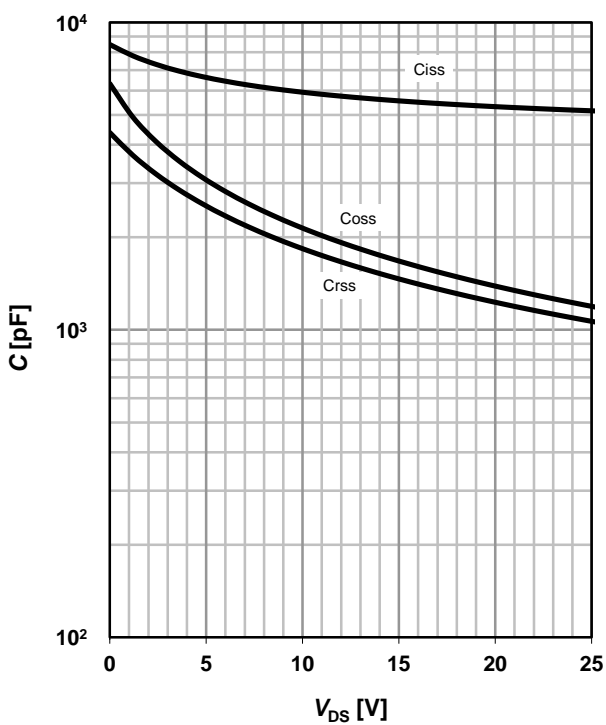

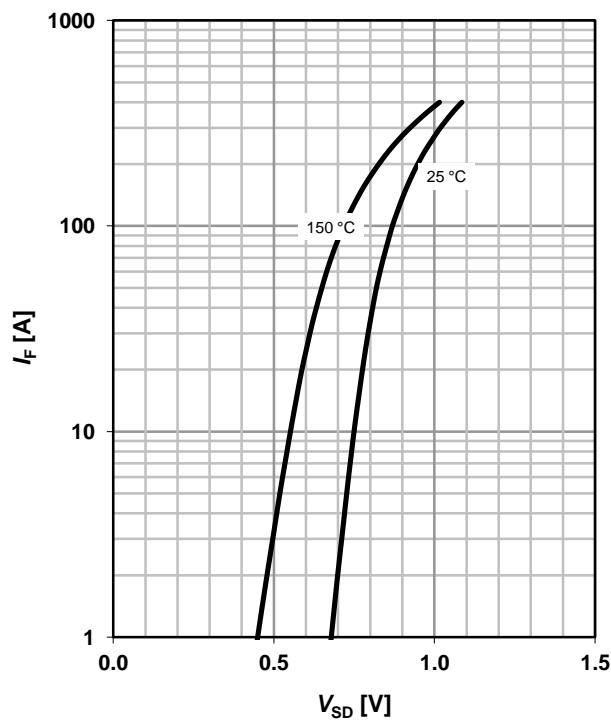

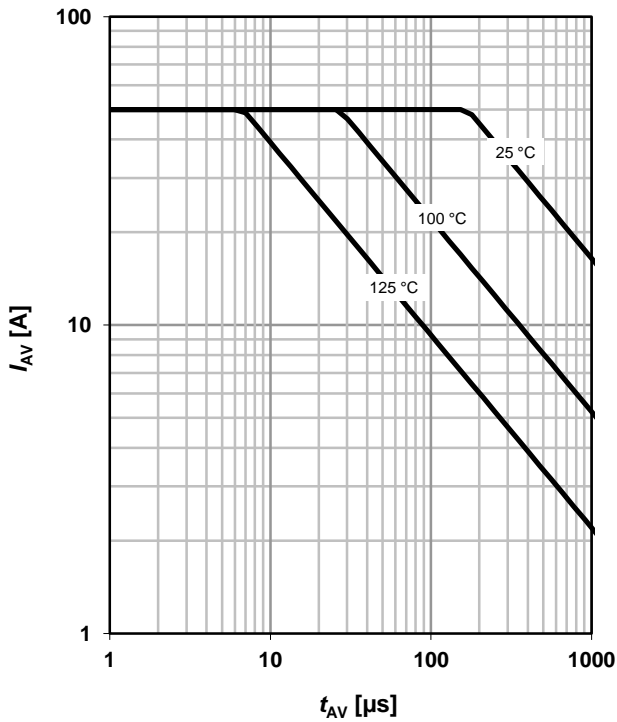

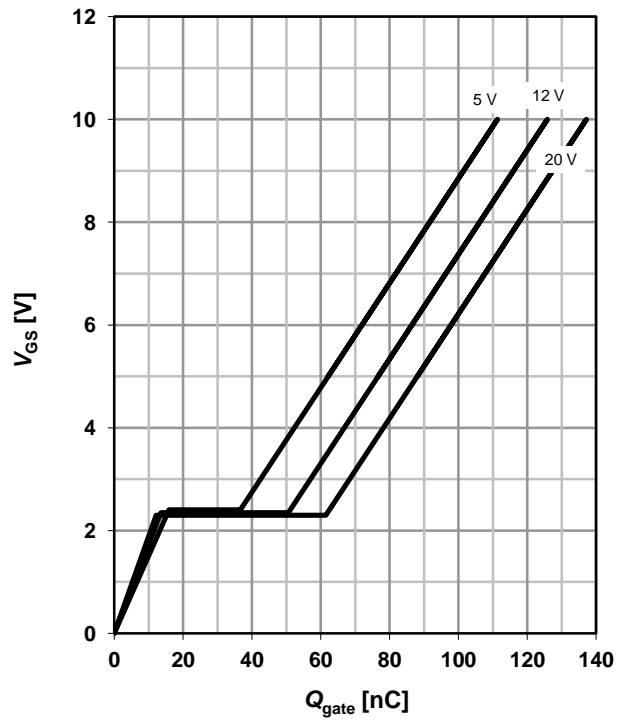

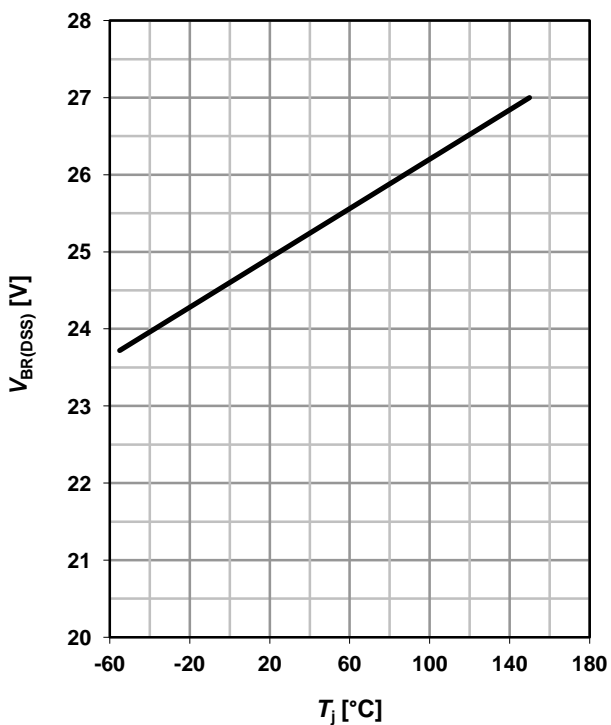

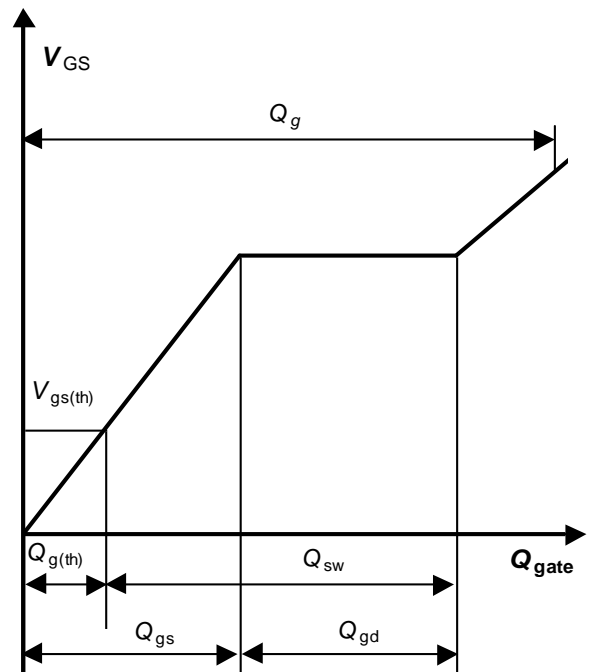


15 Drain-source breakdown voltage

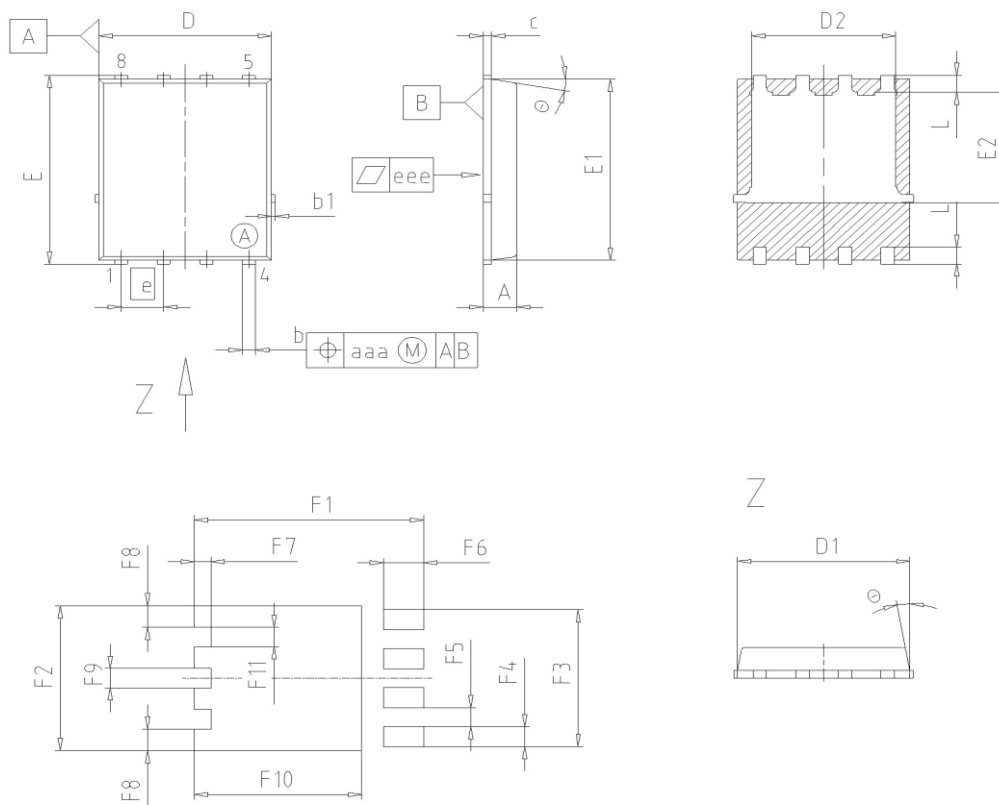
16 Gate charge waveforms

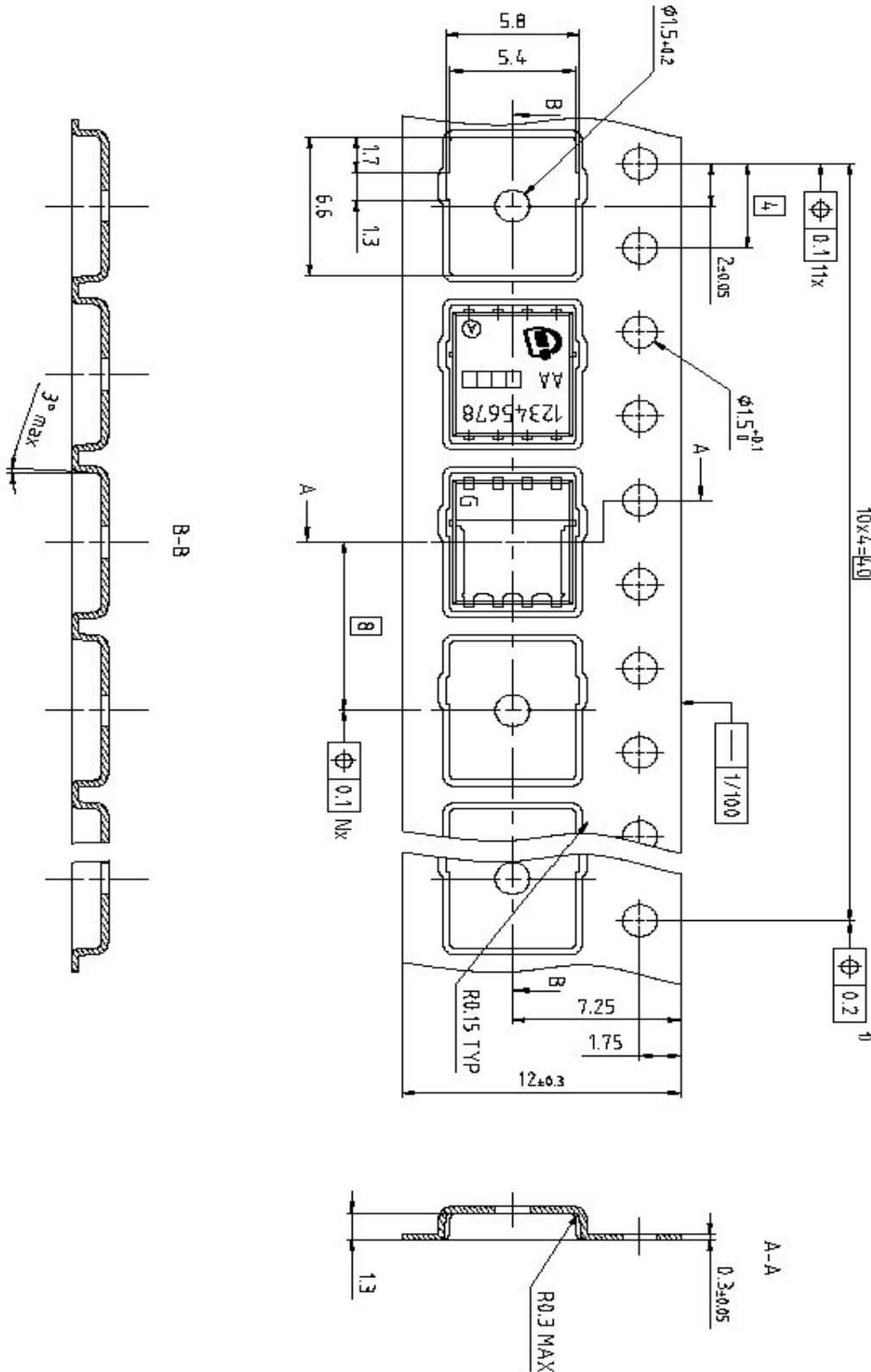
