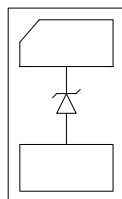

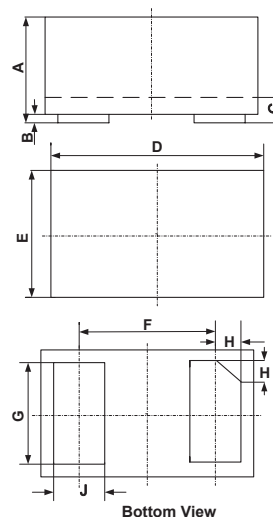

**Circuit and Pin Schematic**



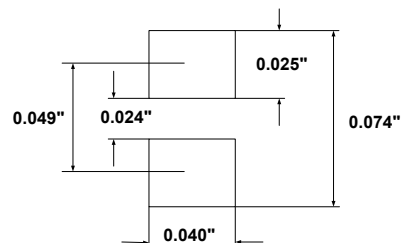

Fig. 1 - 8 X 20 $\mu$ s Pulse Waveform

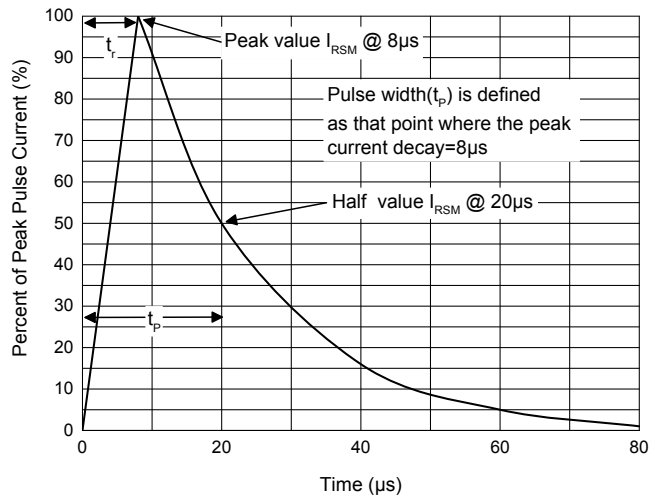


Fig. 2 - Non-Repetitive Peak Pulse Power

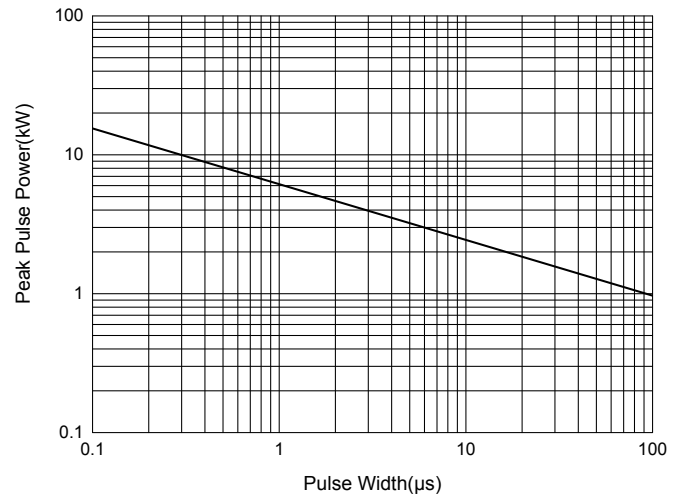
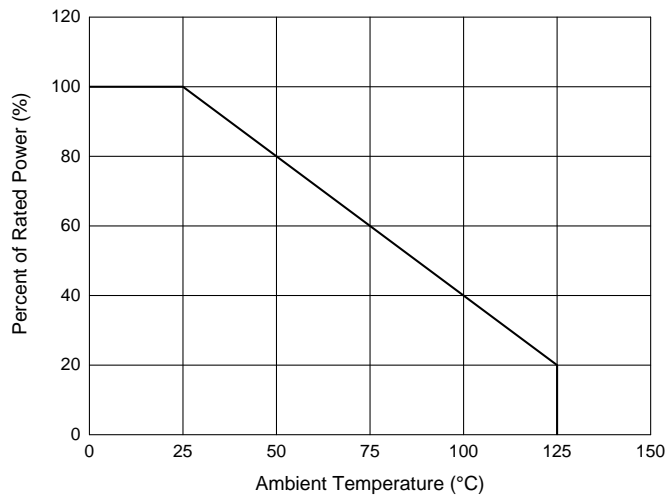


Fig. 3 - Pulse Derating Curve
