1. General description

Unidirectional double ESD protection diode in a SOT23 plastic package. Designed to protect up to two transmission or data lines from ElectroStatic Discharge (ESD) damage.

2. Features and benefits

- Unidirectional ESD protection of up to two lines
- Max. peak pulse power: $P_{pp} = 160 \text{ W}$ at $t_p = 8/20 \text{ us}$
- Low clamping voltage: $V_{(CL)R} = 70 \text{ V}$ at $I_{pp} = 3 \text{ A}$
- Ultra-low reverse leakage current: $I_{RM} < 20 \text{ nA}$
- ESD protection $> 23 \text{ kV}$
- IEC 61000-4-2; level 4 (ESD)
- IEC 61000-4-5 (surge); $I_{pp} = 3 \text{ A}$ at $t_p = 8/20 \text{ us}$.

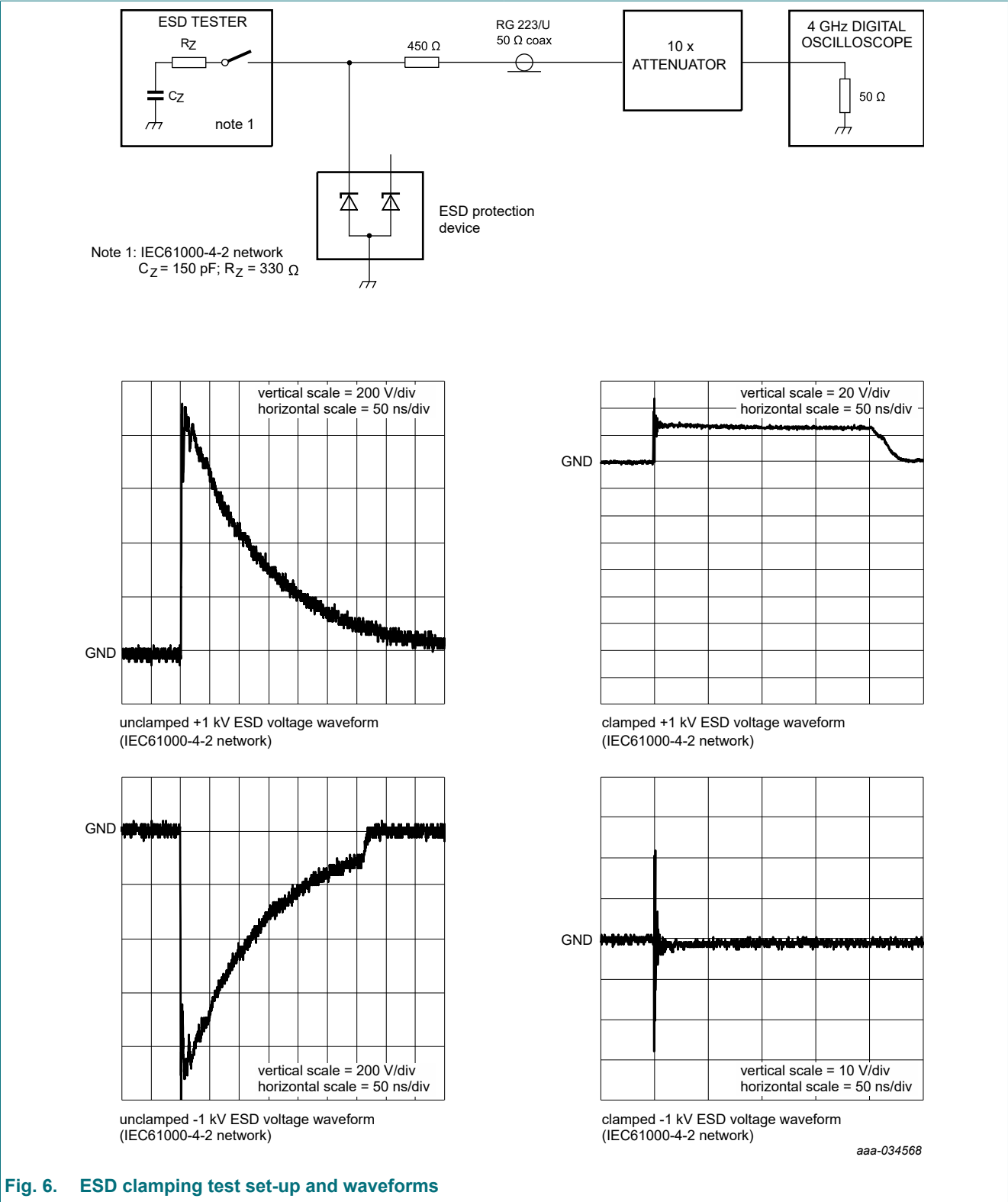


Fig. 6. ESD clamping test set-up and waveforms

10. Application information

The device is designed for the protection of up to two unidirectional data or signal lines from the damage caused by ESD and surge pulses. The devices may be used on lines where the signal polarities are either positive or negative with respect to ground.

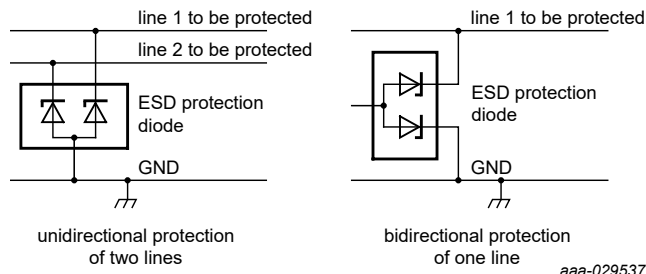


Fig. 7. Application diagram

Circuit board layout and protection device placement

Circuit board layout is critical for the suppression of ESD, Electrical Fast Transient (EFT) and surge transients. The following guidelines are recommended:

1. Place the device as close to the input terminal or connector as possible.
2. Minimize the path length between the device and the protected line.
3. Keep parallel signal paths to a minimum.
4. Avoid running protected conductors in parallel with unprotected conductors.
5. Minimize all Printed-Circuit Board (PCB) conductive loops including power and ground loops.
6. Minimize the length of the transient return path to ground.
7. Avoid using shared transient return paths to a common ground point.
8. Use ground planes whenever possible. For multilayer PCBs, use ground vias.

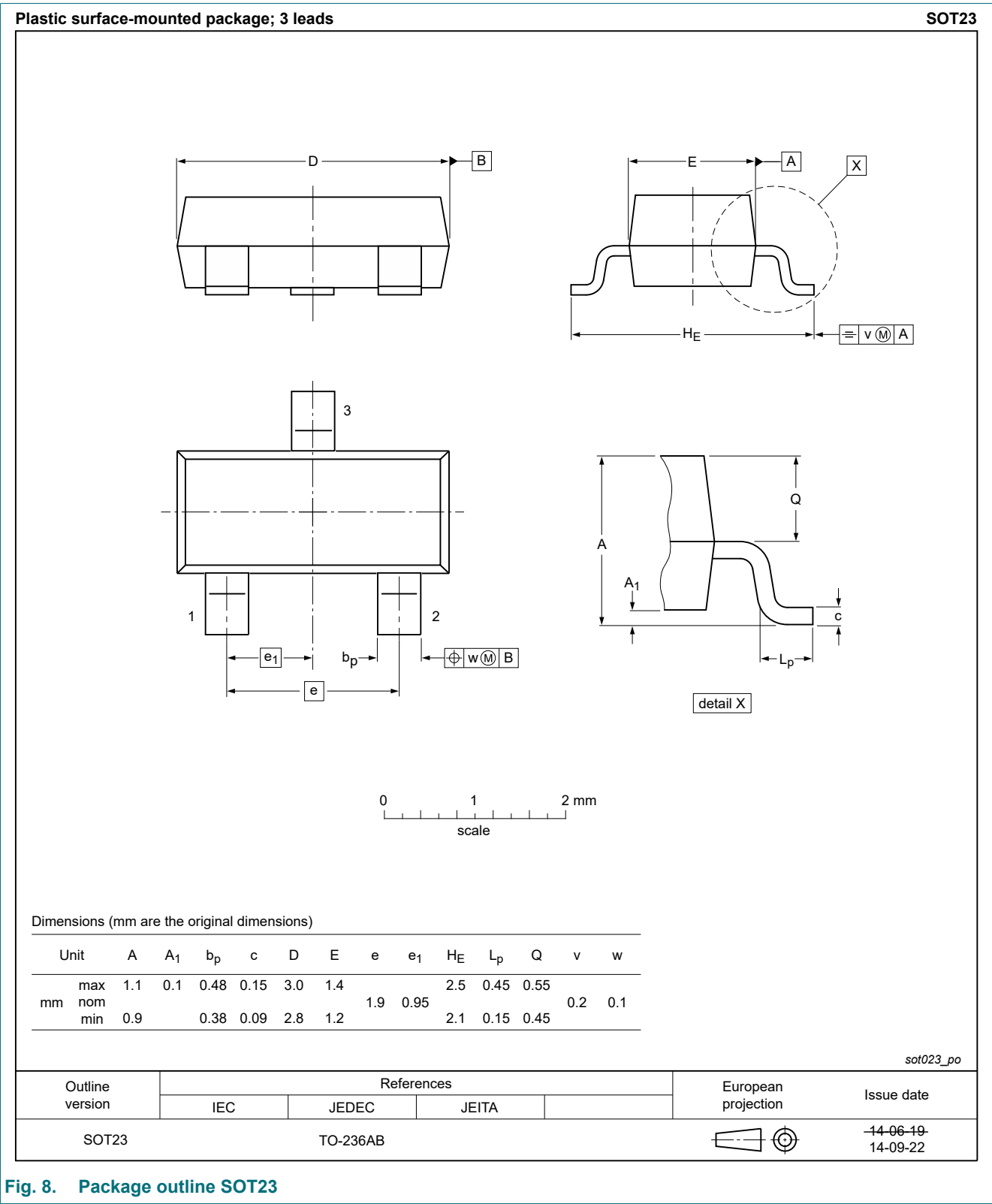


Fig. 8. Package outline SOT23

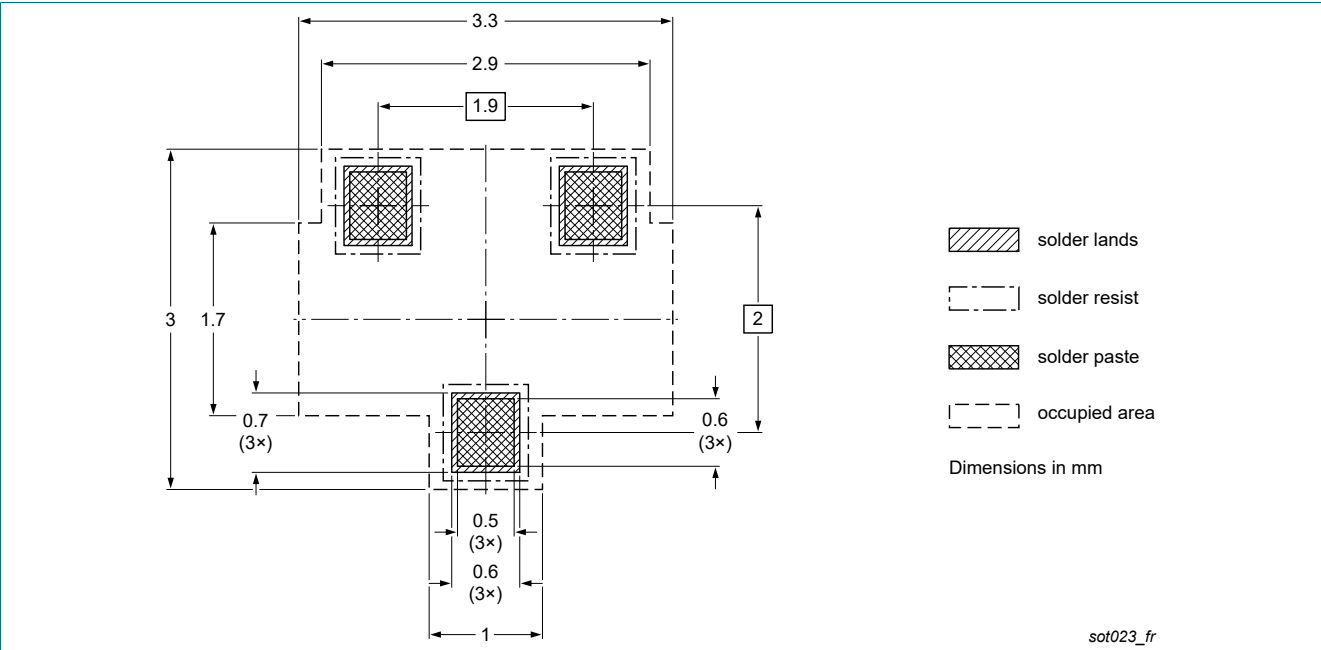


Fig. 9. Reflow soldering footprint for SOT23

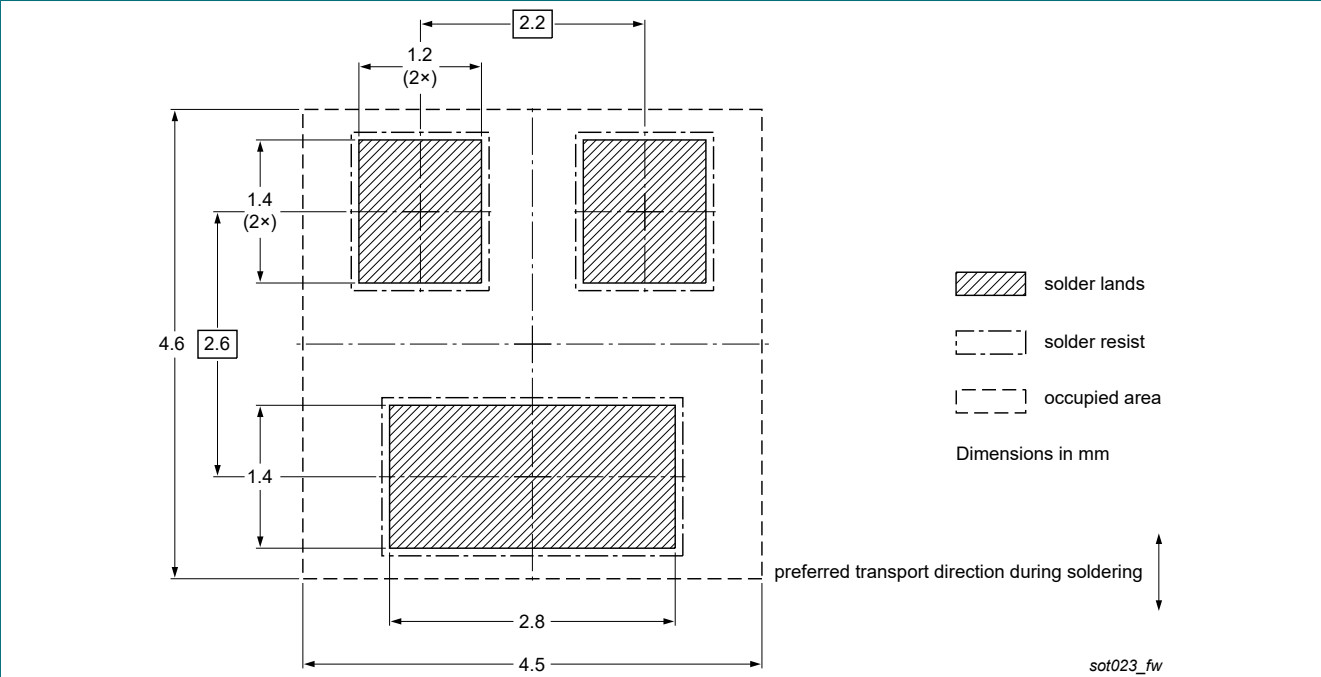


Fig. 10. Wave soldering footprint for SOT23
