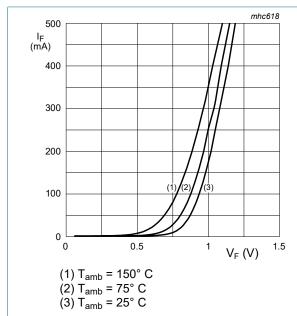


Fig. 1. Forward current as a function of forward voltage; typical values

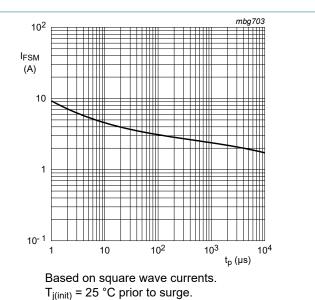
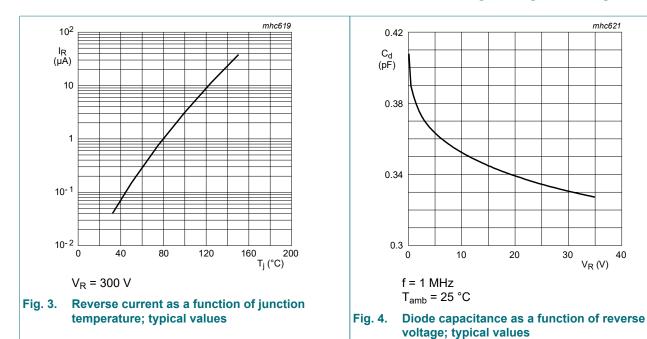


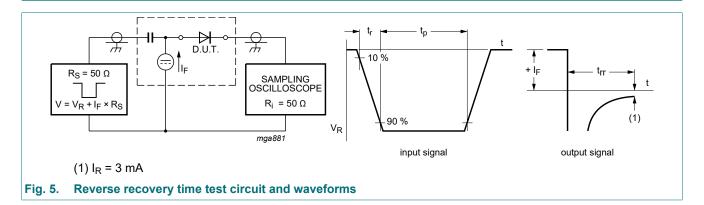
Fig. 2. Non-repetitive peak forward current as a function of pulse duration; maximum values
