

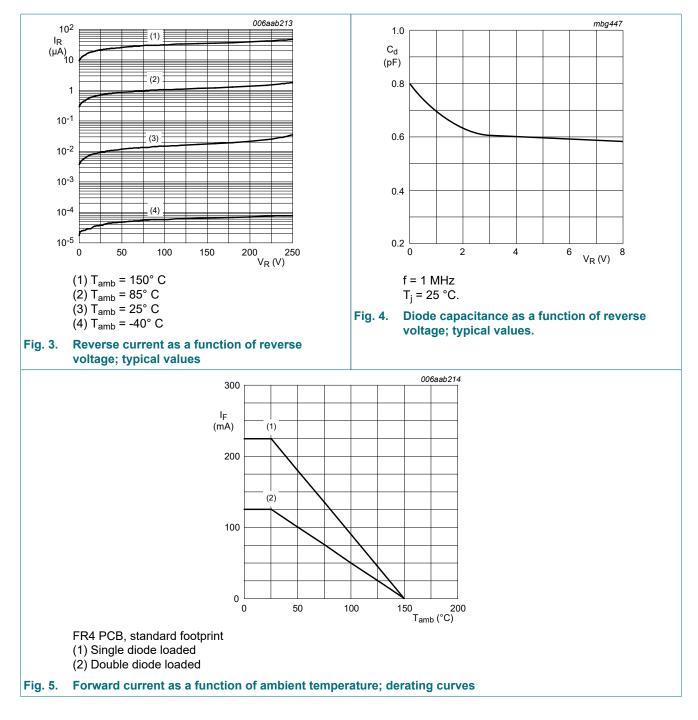



Dual high-voltage switching diodes






