

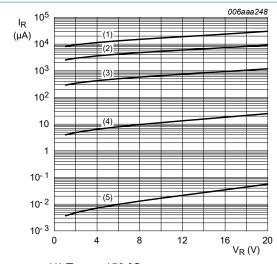


Forward current as a function of forward Fig. 1. voltage; typical values

Fig. 2. Reverse current as a function of reverse voltage; typical values




 T_{amb} = 25 °C; f = 1 MHz




