

1. General description

The 74HC27-Q100; 74HCT27-Q100 is a triple 3-input NOR gate. Inputs include clamp diodes. This enables the use of current limiting resistors to interface inputs to voltages in excess of V_{CC} .

This product has been qualified to the Automotive Electronics Council (AEC) standard Q100 (Grade 1) and is suitable for use in automotive applications.







Fig. 4. Input (nA, nB, nC) to output (nY) propagation delays and output transition times




Fig. 6. Package outline SOT108-1 (SO14)

Triple 3-input NOR gate




Fig. 7. Package outline SOT402-1 (TSSOP14)

Triple 3-input NOR gate




Fig. 8. Package outline SOT762-1 (DHVQFN14)
