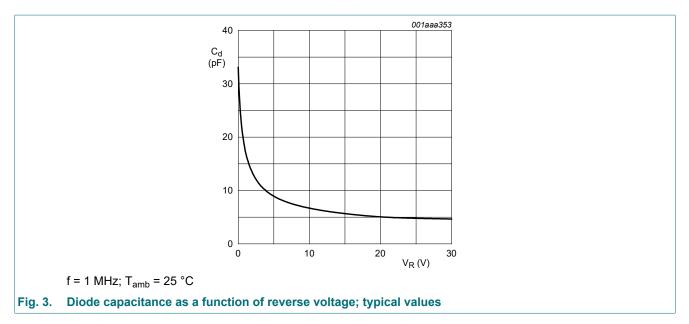

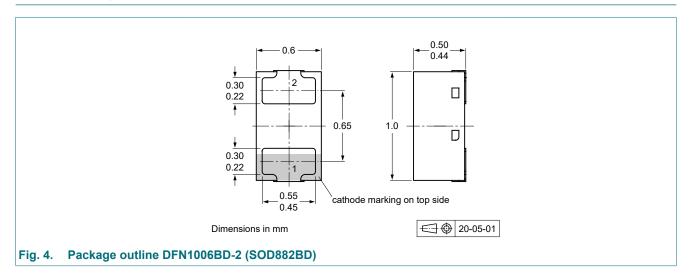

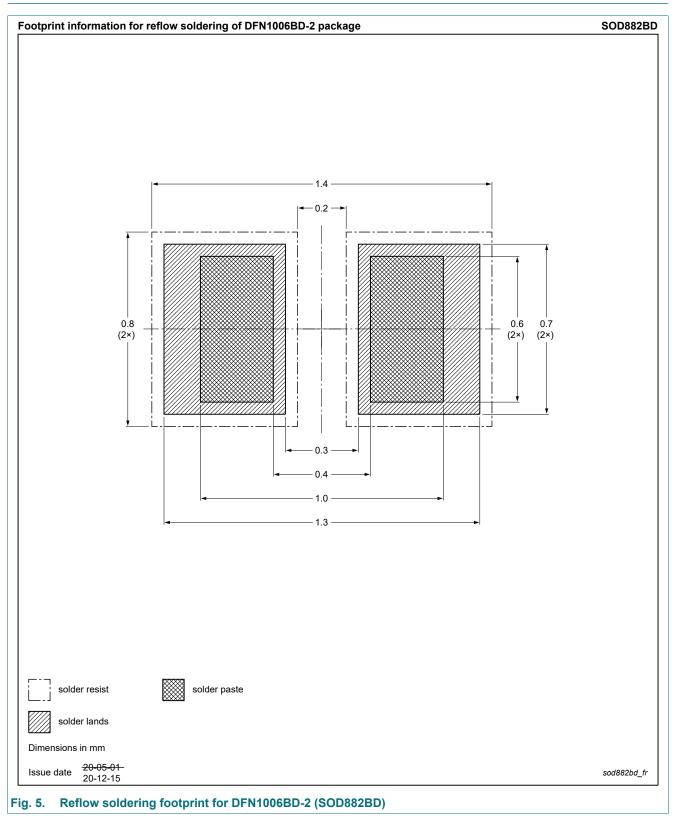


11. Package outline
