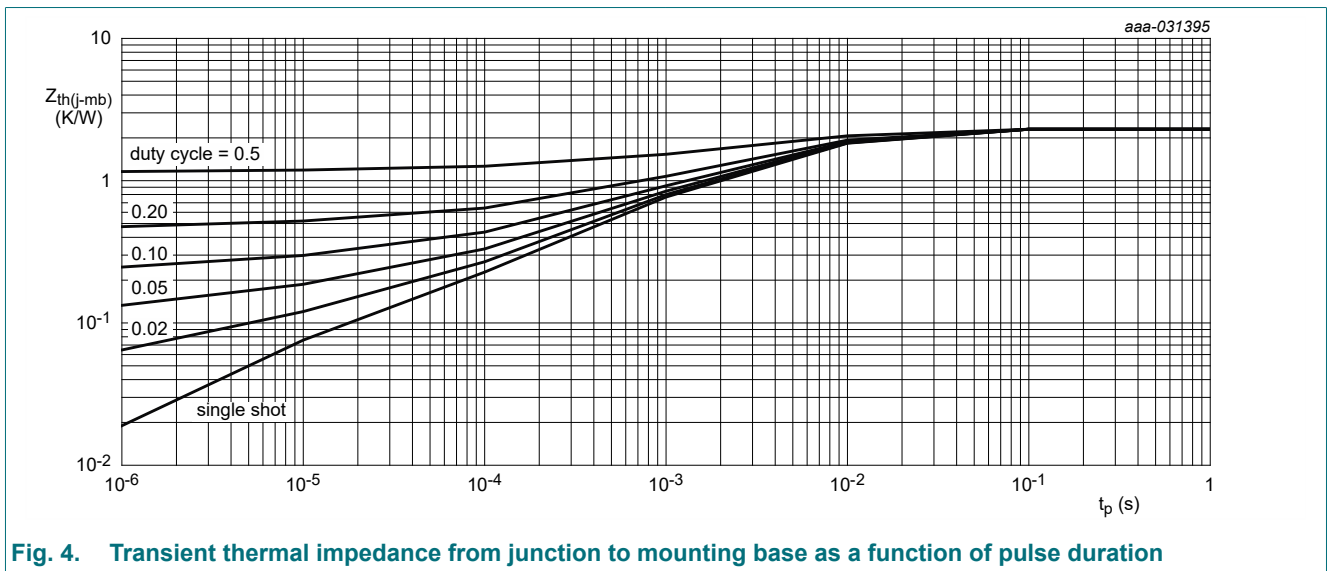

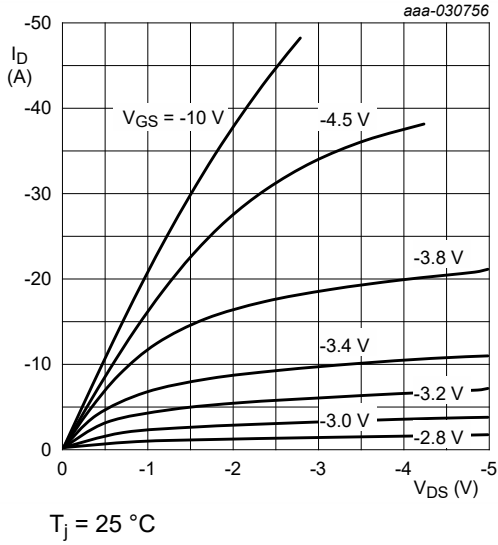


Fig. 5. Output characteristics: drain current as a function of drain-source voltage; typical values

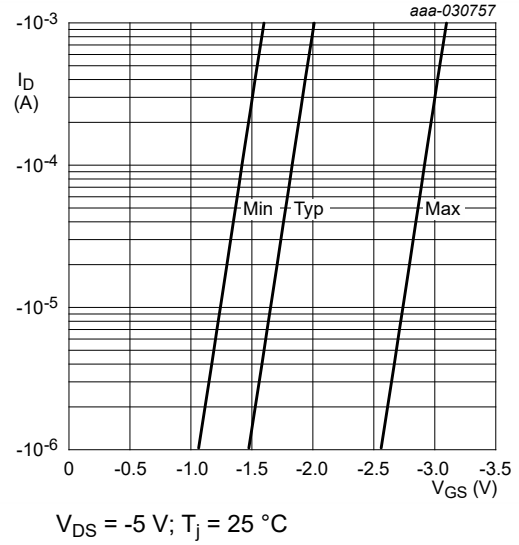


Fig. 6. Sub-threshold drain current as a function of gate-source voltage

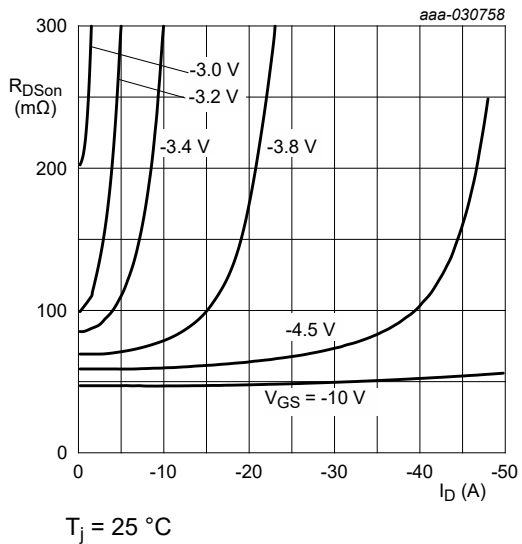


Fig. 7. Drain-source on-state resistance as a function of drain current; typical values

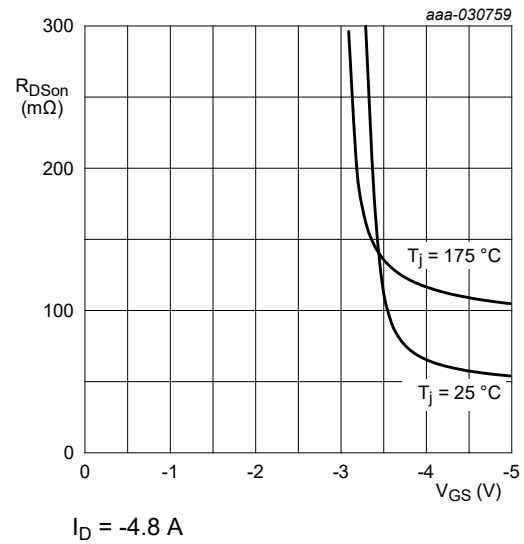


Fig. 8. Drain-source on-state resistance as a function of gate-source voltage; typical values

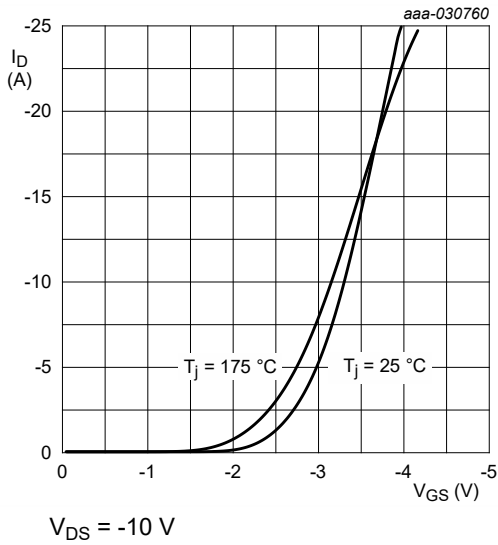
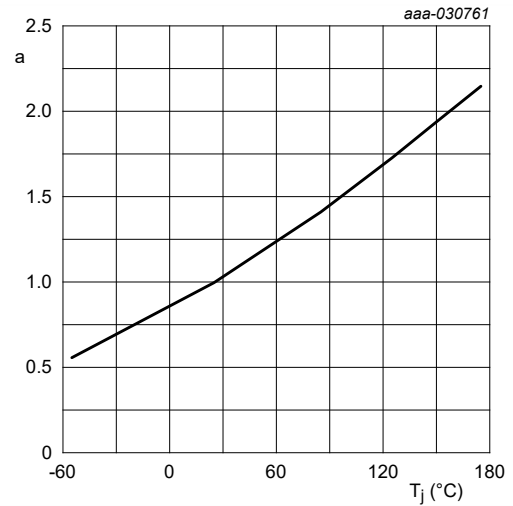


Fig. 9. Transfer characteristics: drain current as a function of gate-source voltage; typical values

Fig. 10. Normalized drain-source on-state resistance as a function of junction temperature; typical values

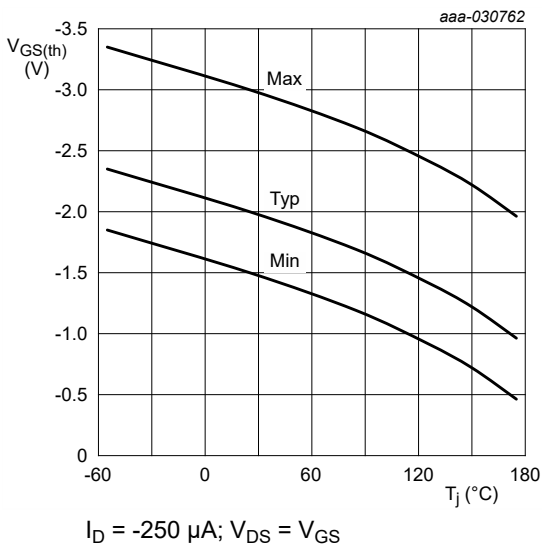


Fig. 11. Gate-source threshold voltage as a function of junction temperature

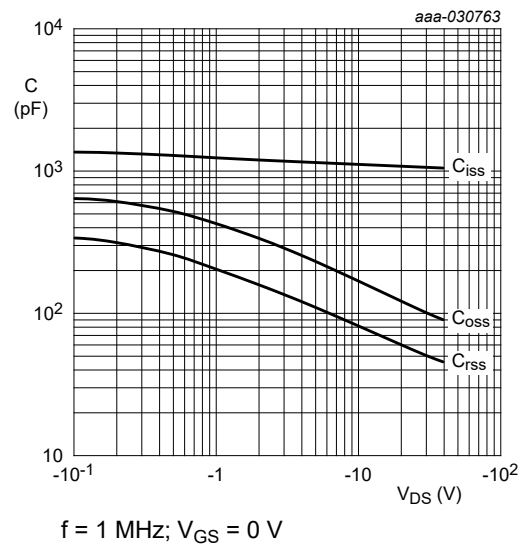
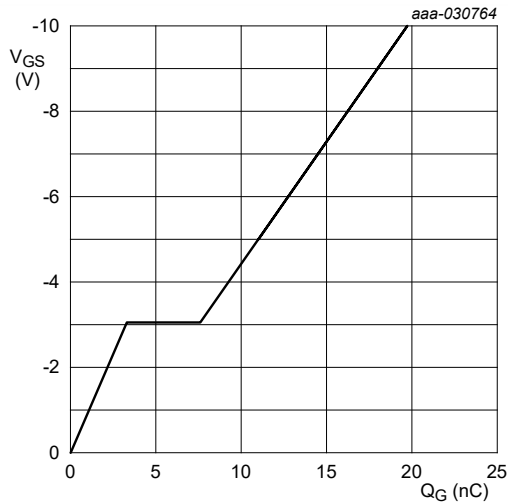


Fig. 12. Input, output and reverse transfer capacitances as a function of drain-source voltage; typical values

Fig. 13. Gate-source voltage as a function of gate charge; typical values

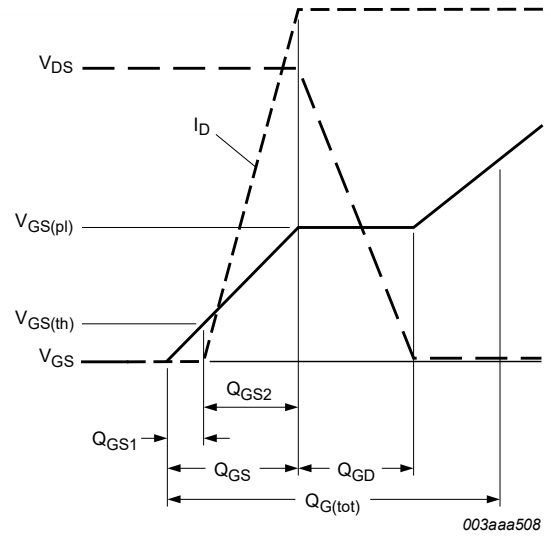
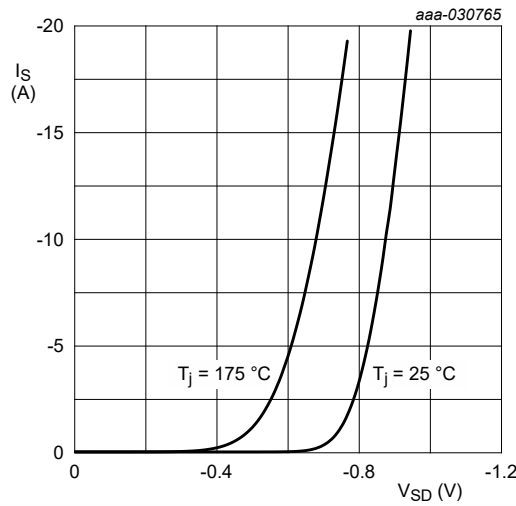


Fig. 14. Gate charge waveform definitions

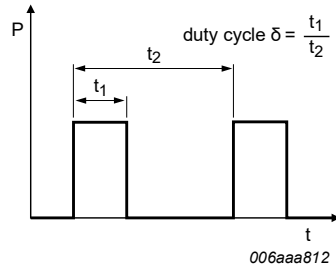


Fig. 16. Duty cycle definition

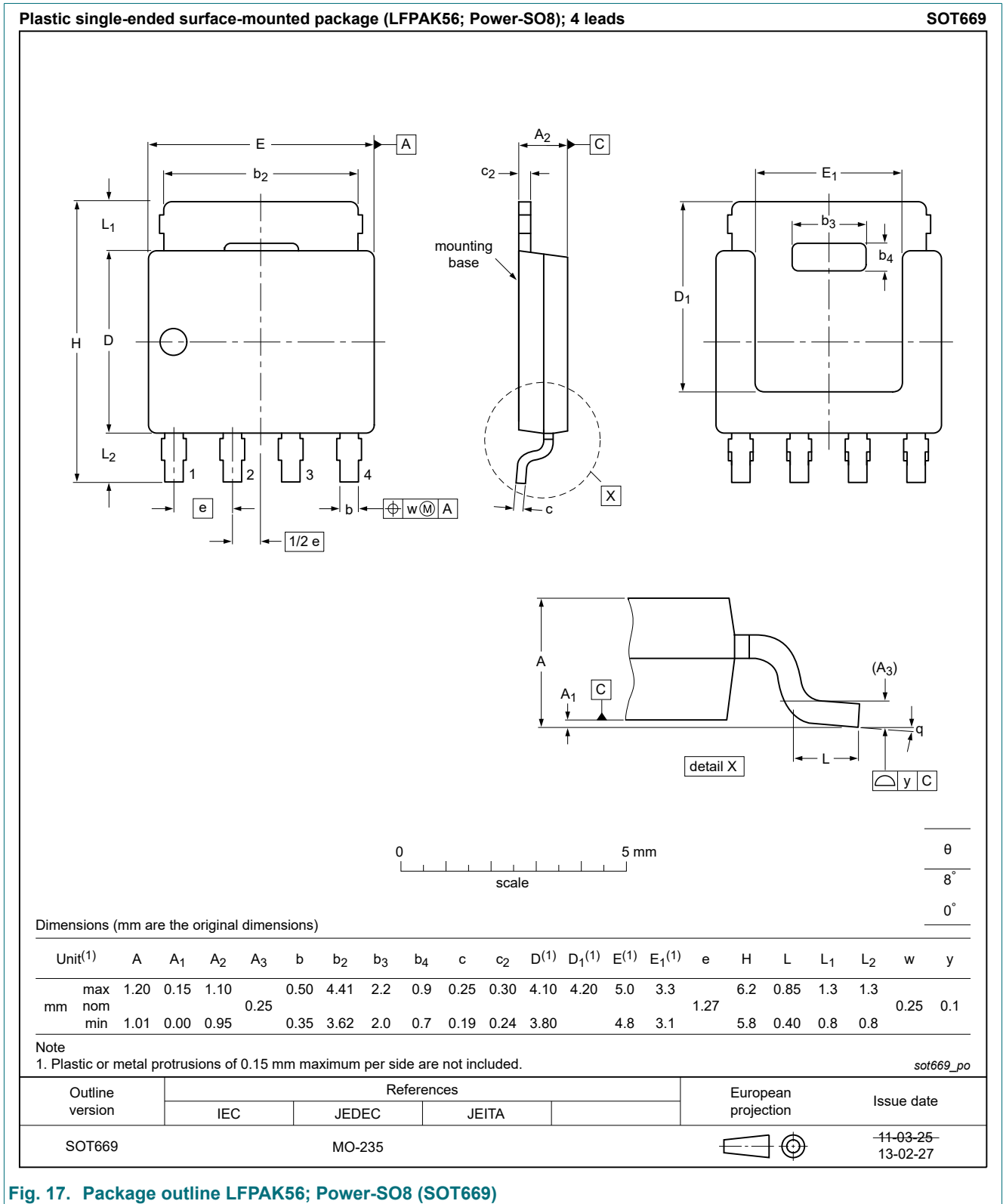


Fig. 17. Package outline LFAK56; Power-SO8 (SOT669)

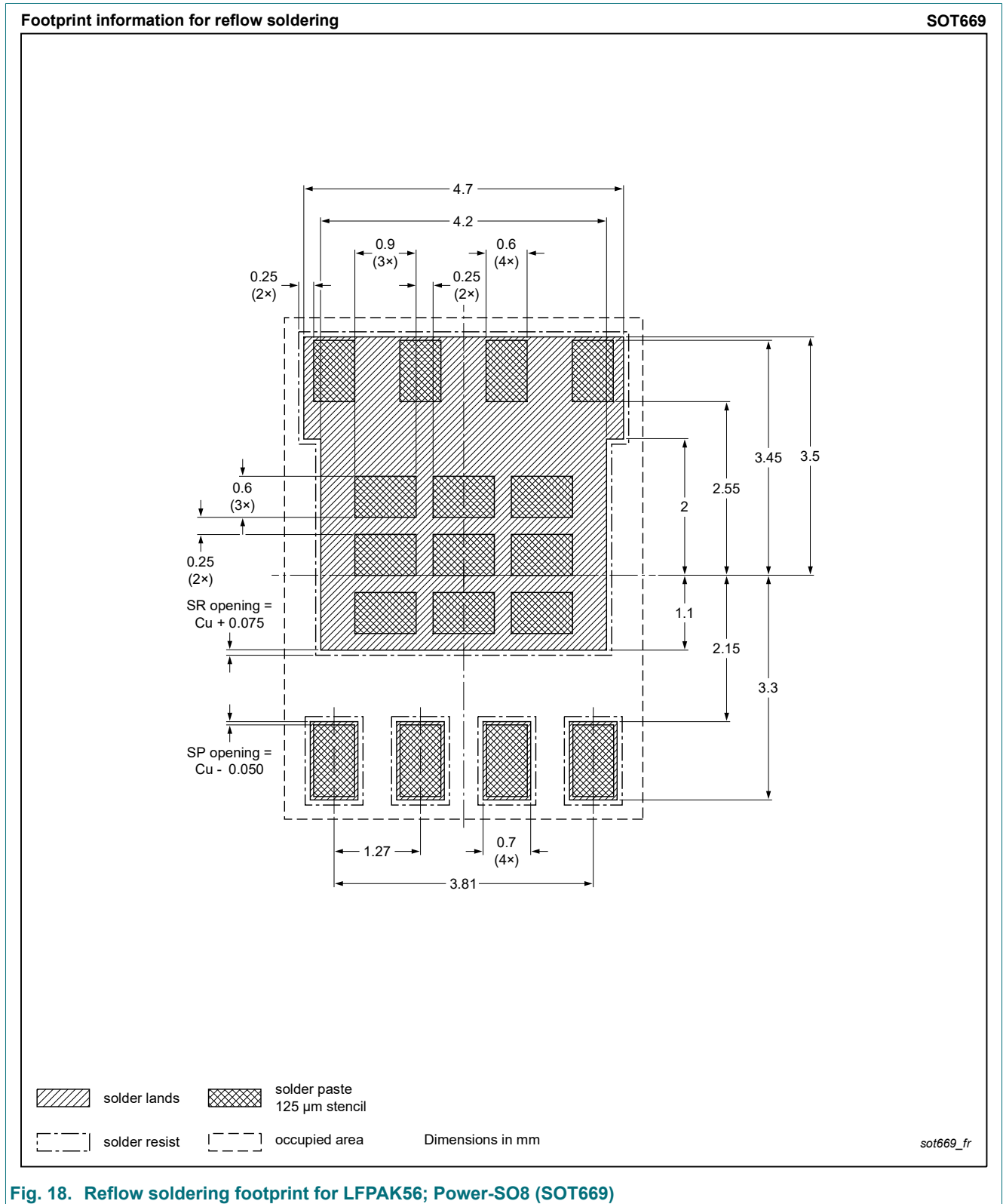
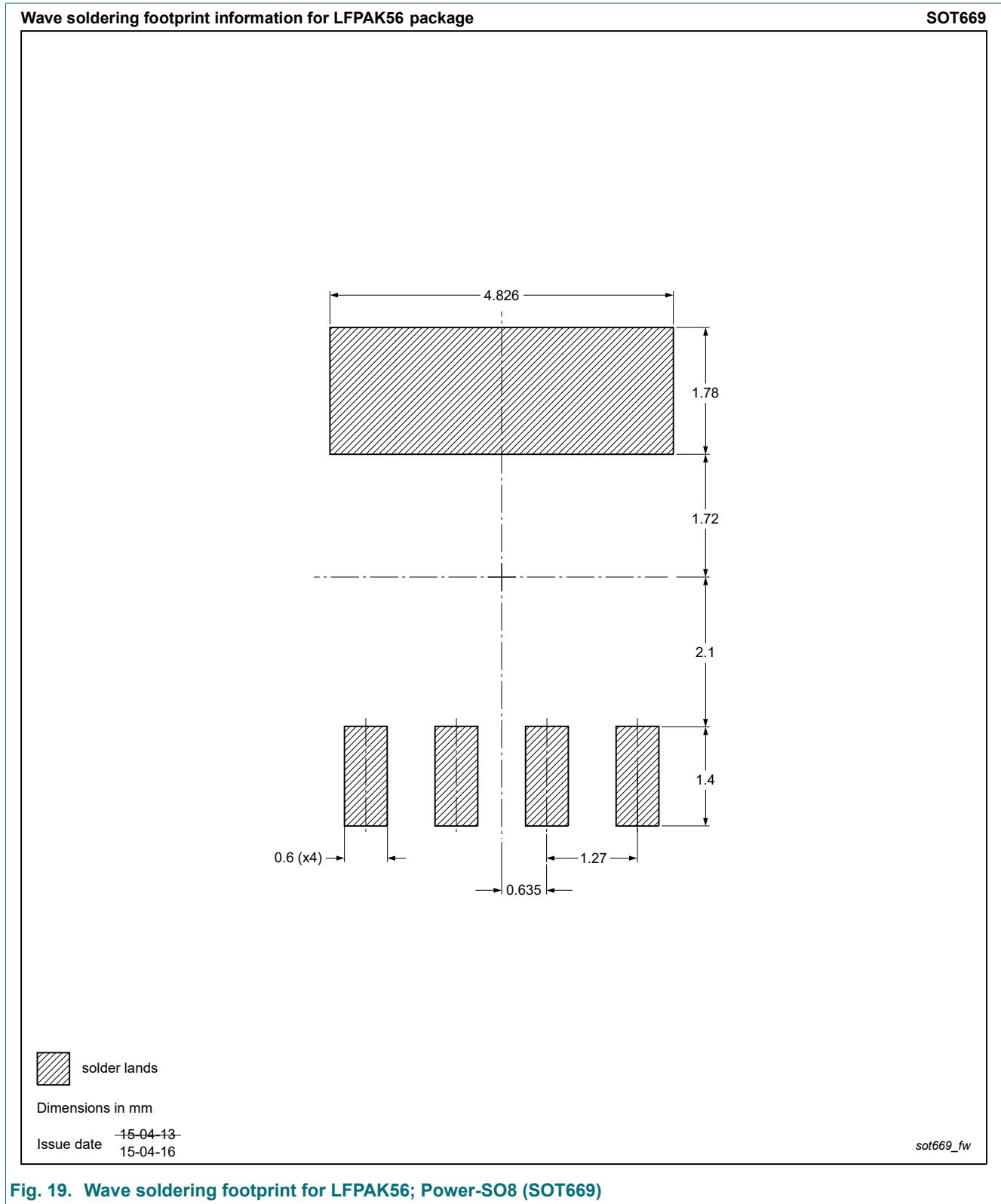


Fig. 18. Reflow soldering footprint for LFPAK56; Power-SO8 (SOT669)
