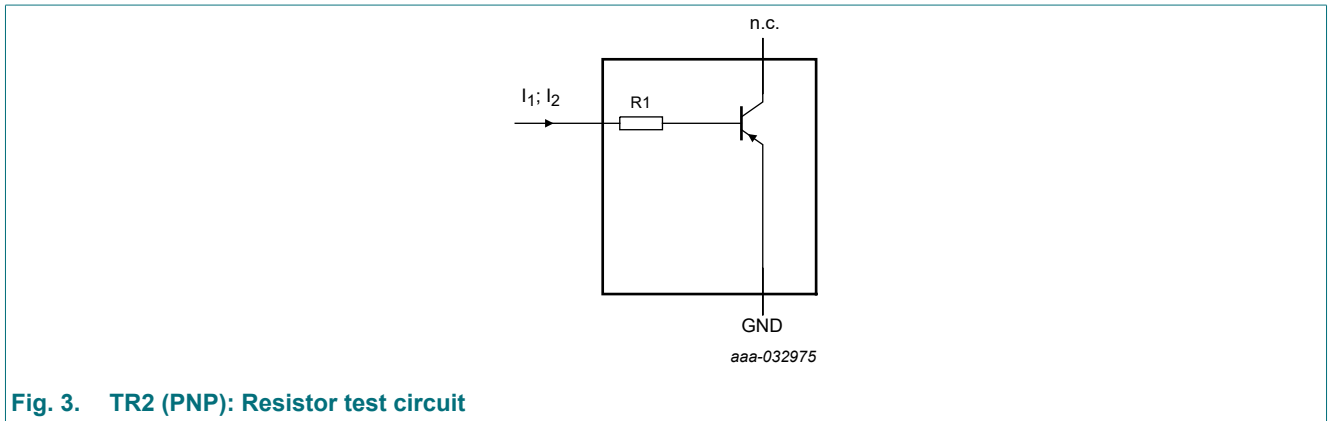


Fig. 3. TR2 (PNP): Resistor test circuit

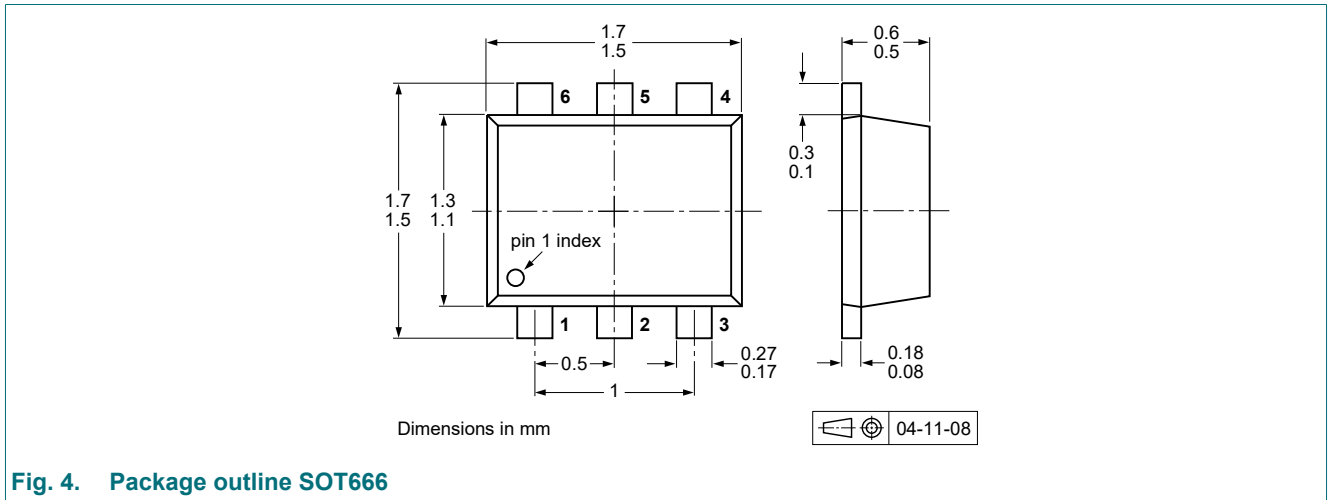


Fig. 4. Package outline SOT666

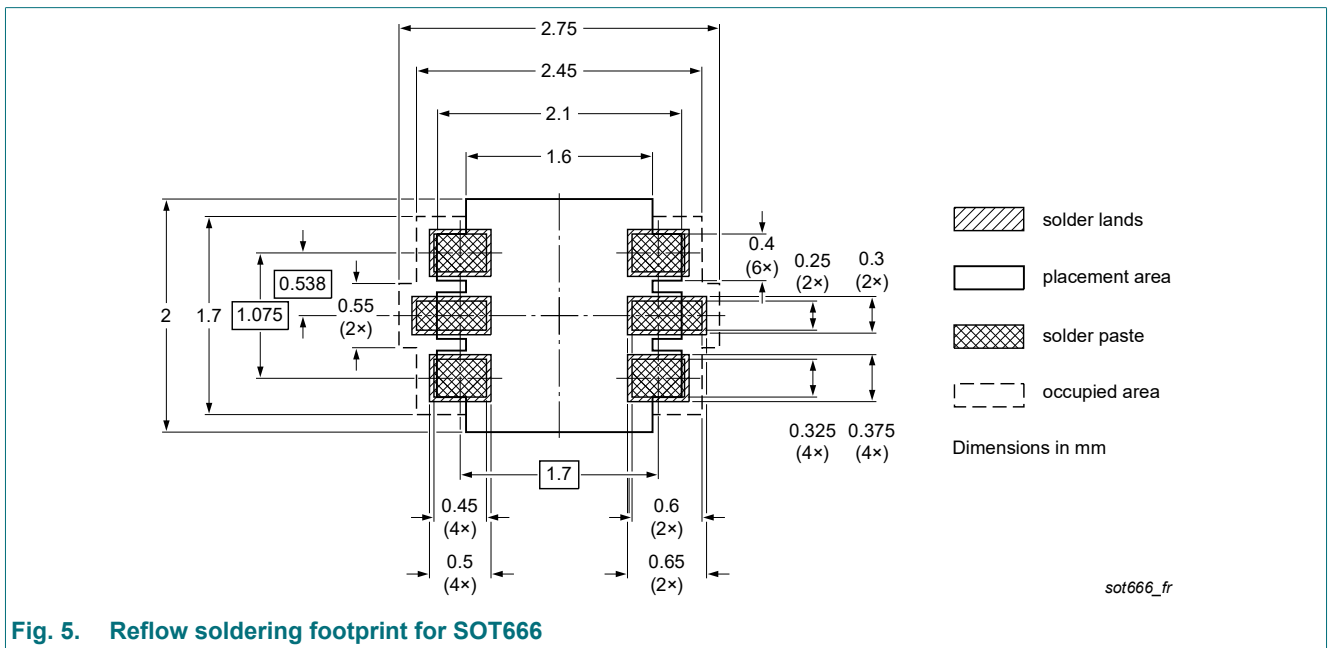


Fig. 5. Reflow soldering footprint for SOT666
