### 1. General description

XC7SET86 is a high-speed Si-gate CMOS device. It provides a 2-input EXCLUSIVE-OR function.

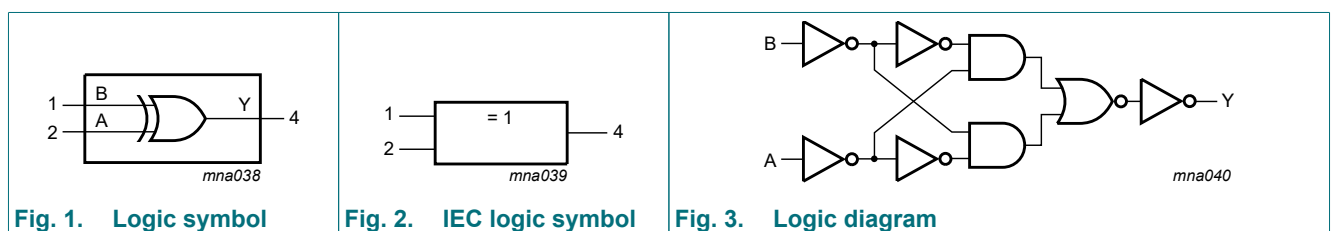

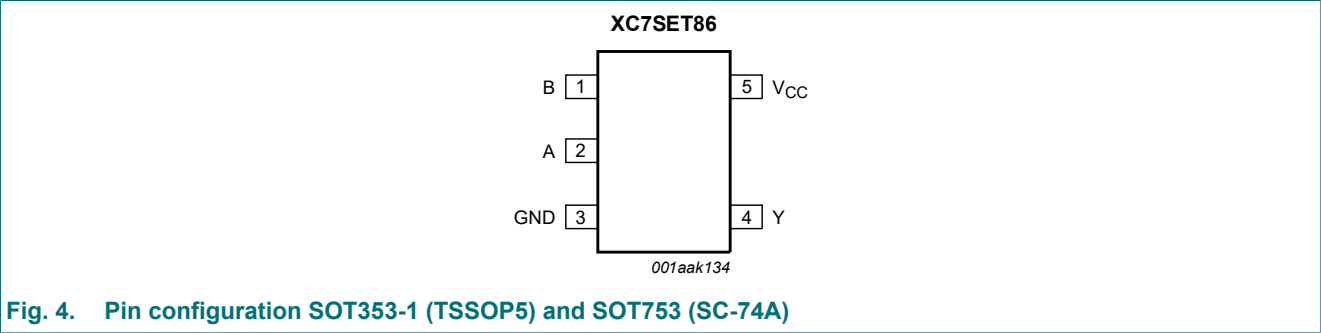


Fig. 4. Pin configuration SOT353-1 (TSSOP5) and SOT753 (SC-74A)

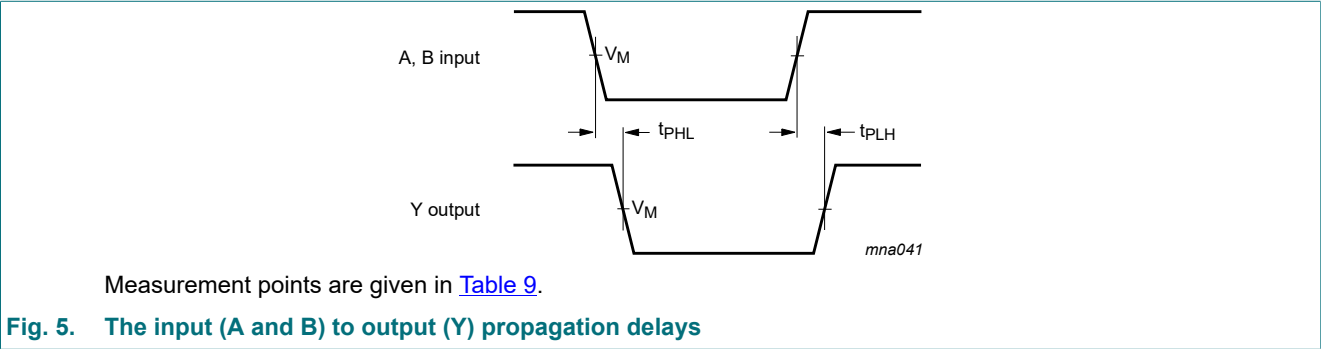

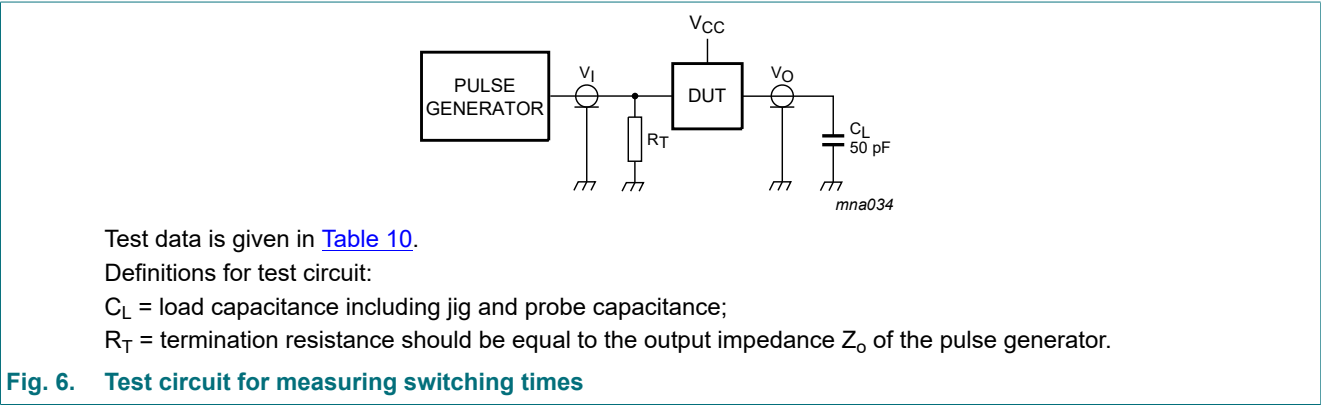

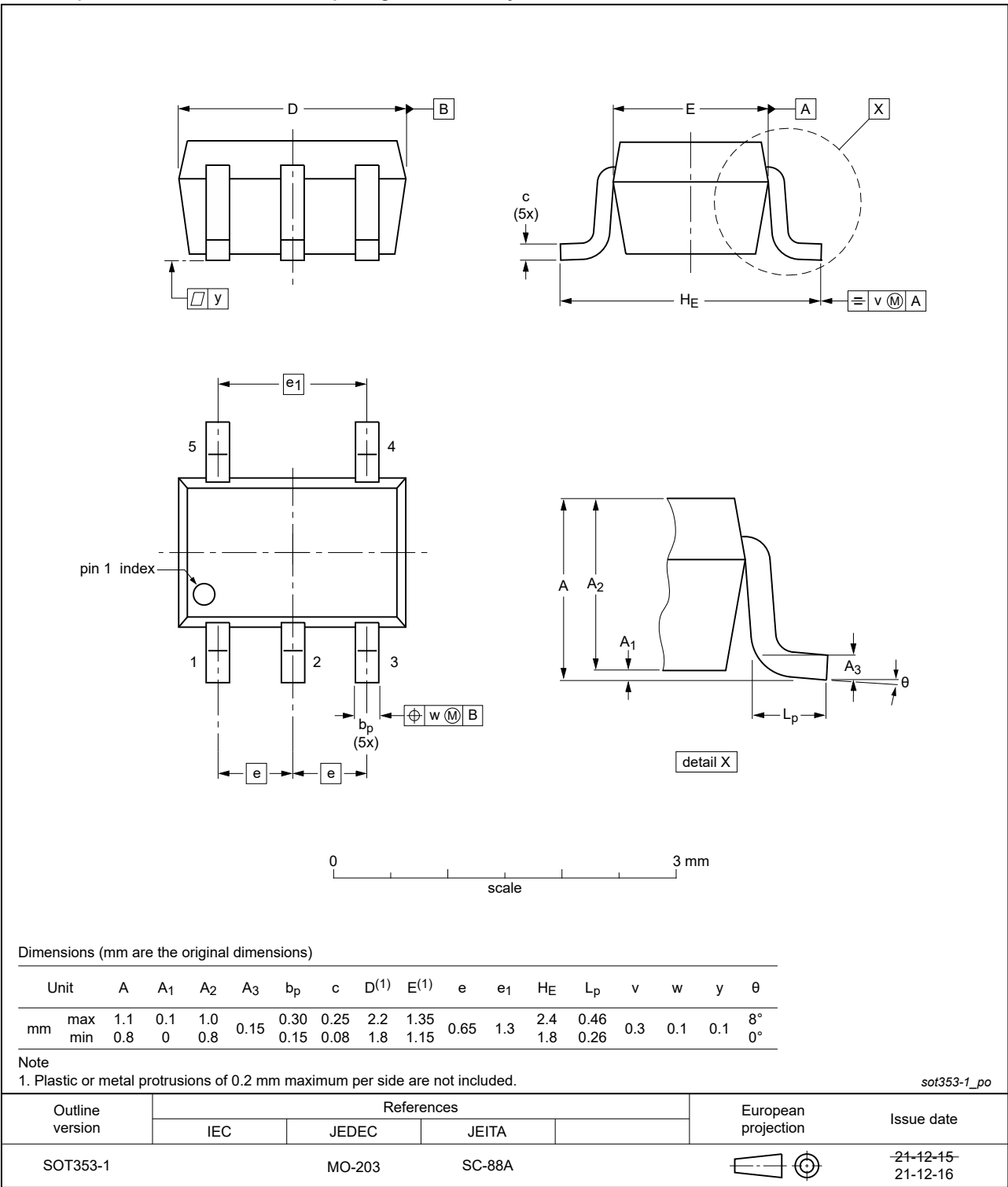


Fig. 7. Package outline SOT353-1 (TSSOP5)

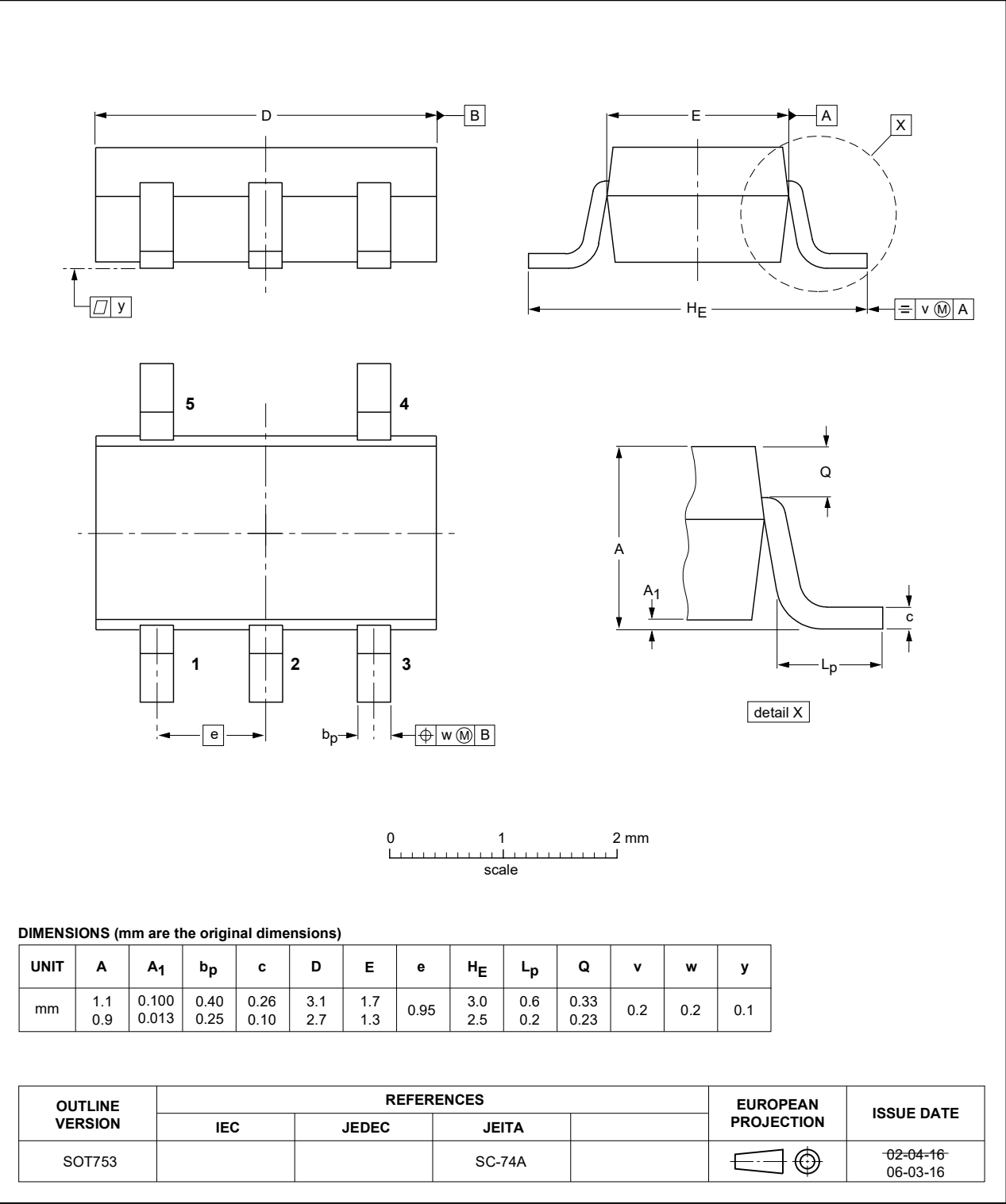


Fig. 8. Package outline SOT753 (SC-74A)
