1. General description

The 74ALVC14 is a hex inverter with Schmitt-trigger inputs.

This device is fully specified for partial power down applications using I_{OFF}. The I_{OFF} circuitry disables the output, preventing the potentially damaging backflow current through the device when it is powered down.










Fig. 4. Input (nA) to output (nY) propagation delays







Fig. 7. Typical transfer characteristic






Fig. 10. Package outline SOT108-1 (SO14)




Fig. 11. Package outline SOT402-1 (TSSOP14)




Fig. 12. Package outline SOT762-1 (DHVQFN14)
