


6. Functional diagram











Fig. 10. Relaxation oscillator




Fig. 11. Typical K-factor for relaxation oscillator

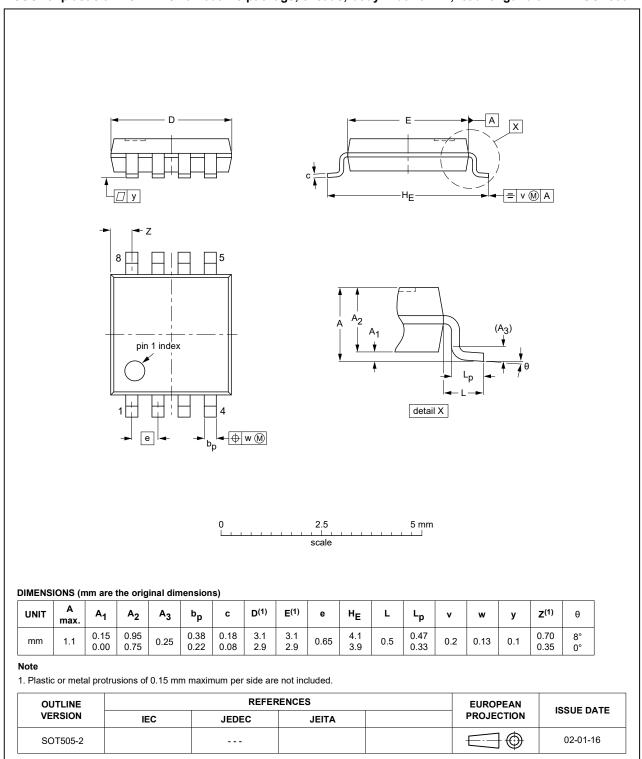


Fig. 12. Package outline SOT505-2 (TSSOP8)




Fig. 13. Package outline SOT765-1 (VSSOP8)




Fig. 14. Package outline SOT833-1 (XSON8)




Fig. 15. Package outline SOT1116 (XSON8)




Fig. 16. Package outline SOT1203 (XSON8)
