1. General description

The 74ABT20 high-performance BiCMOS device combines low static and dynamic power dissipation with high speed and high output drive.

The 74ABT20 is a dual 4-input NAND gate.

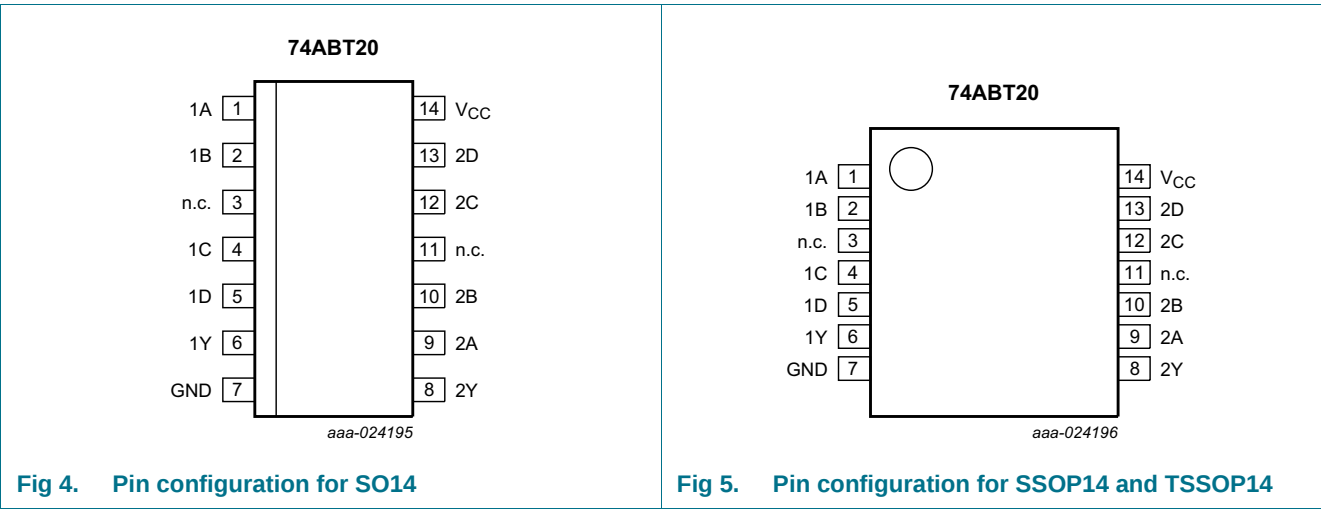

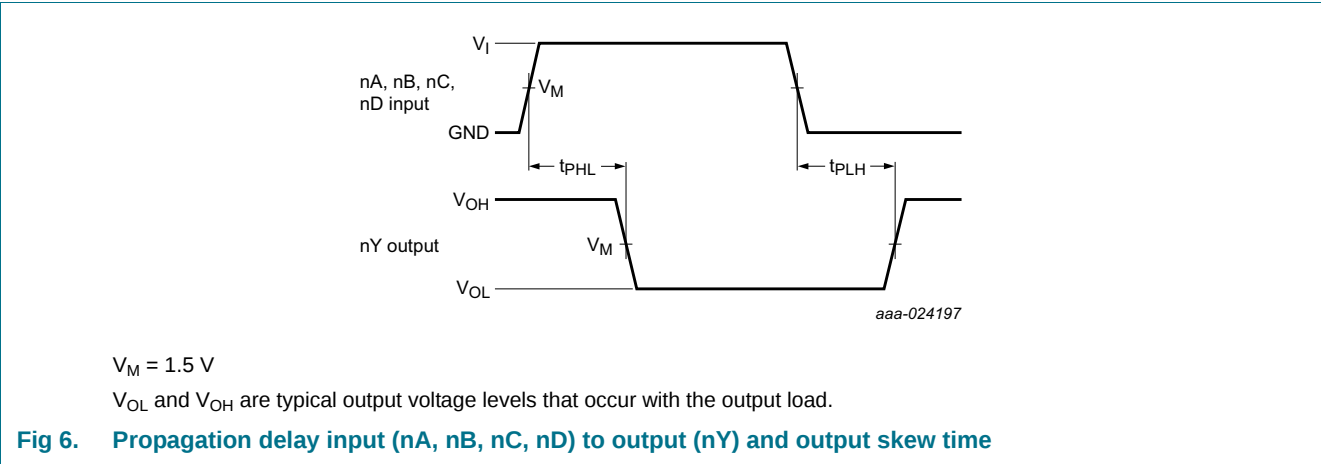

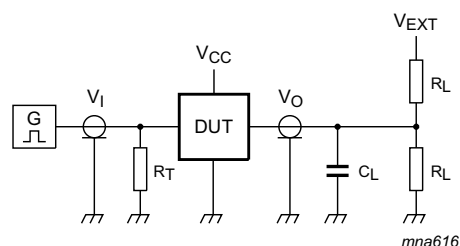
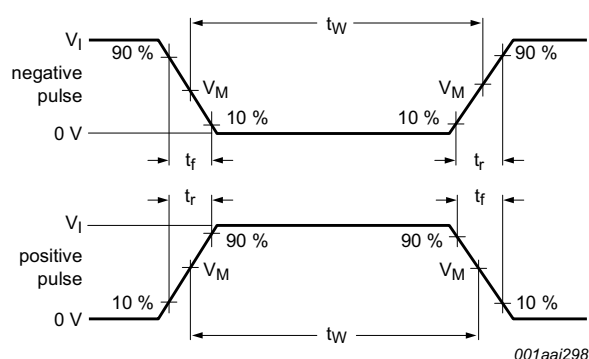

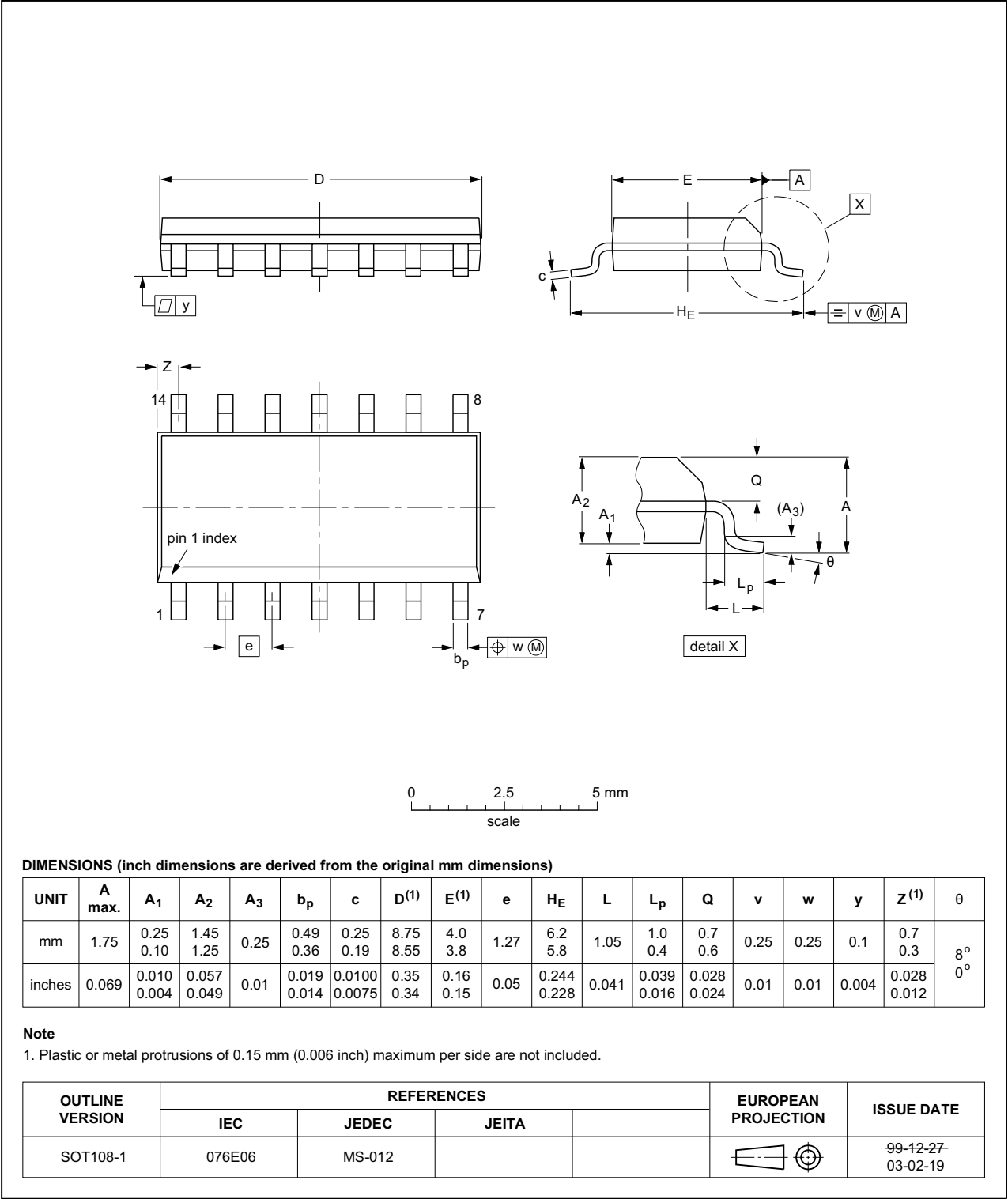


Fig 8. Package outline SOT108-1 (SO14)

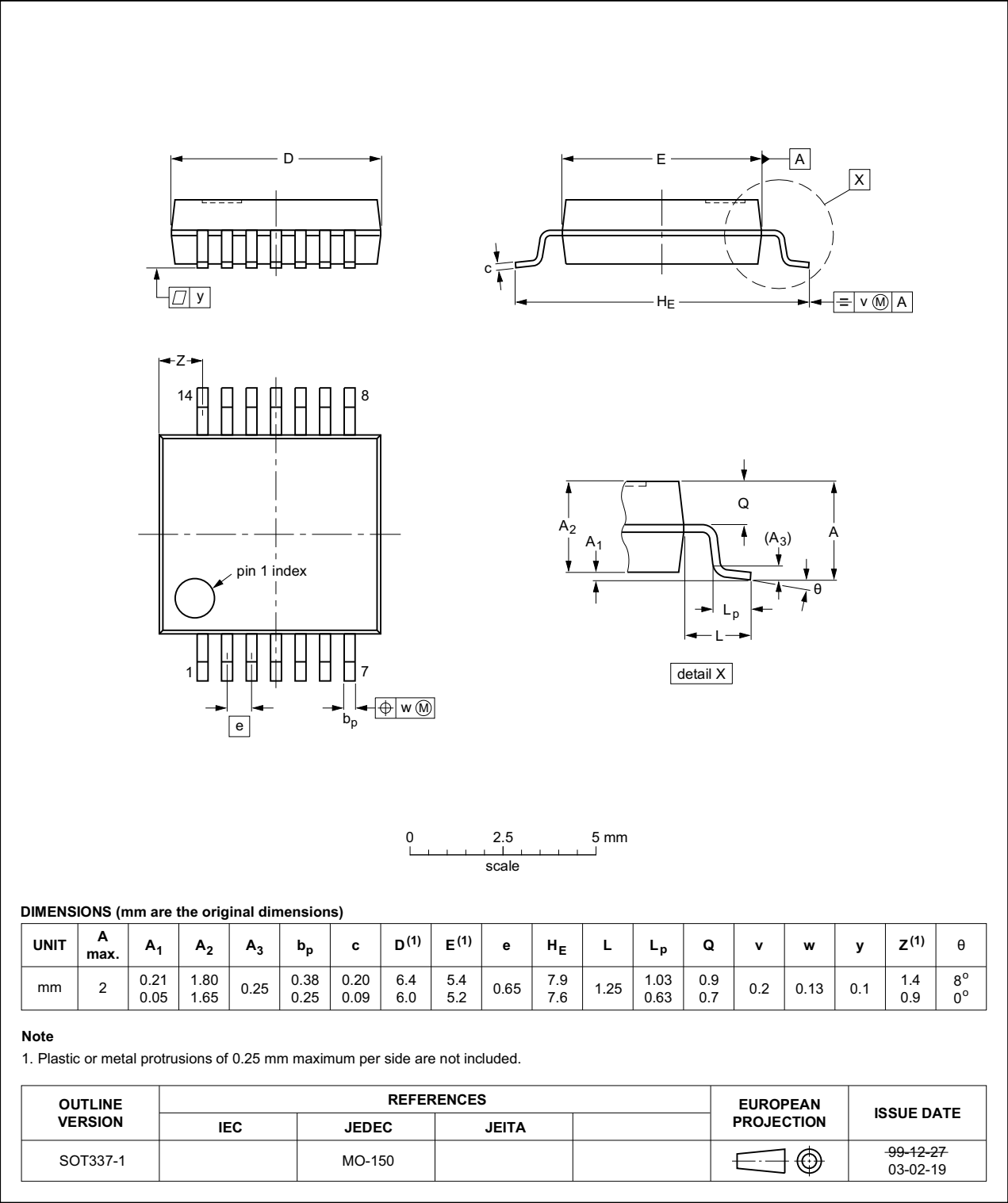


Fig 9. Package outline SOT337-1 (SSOP14)

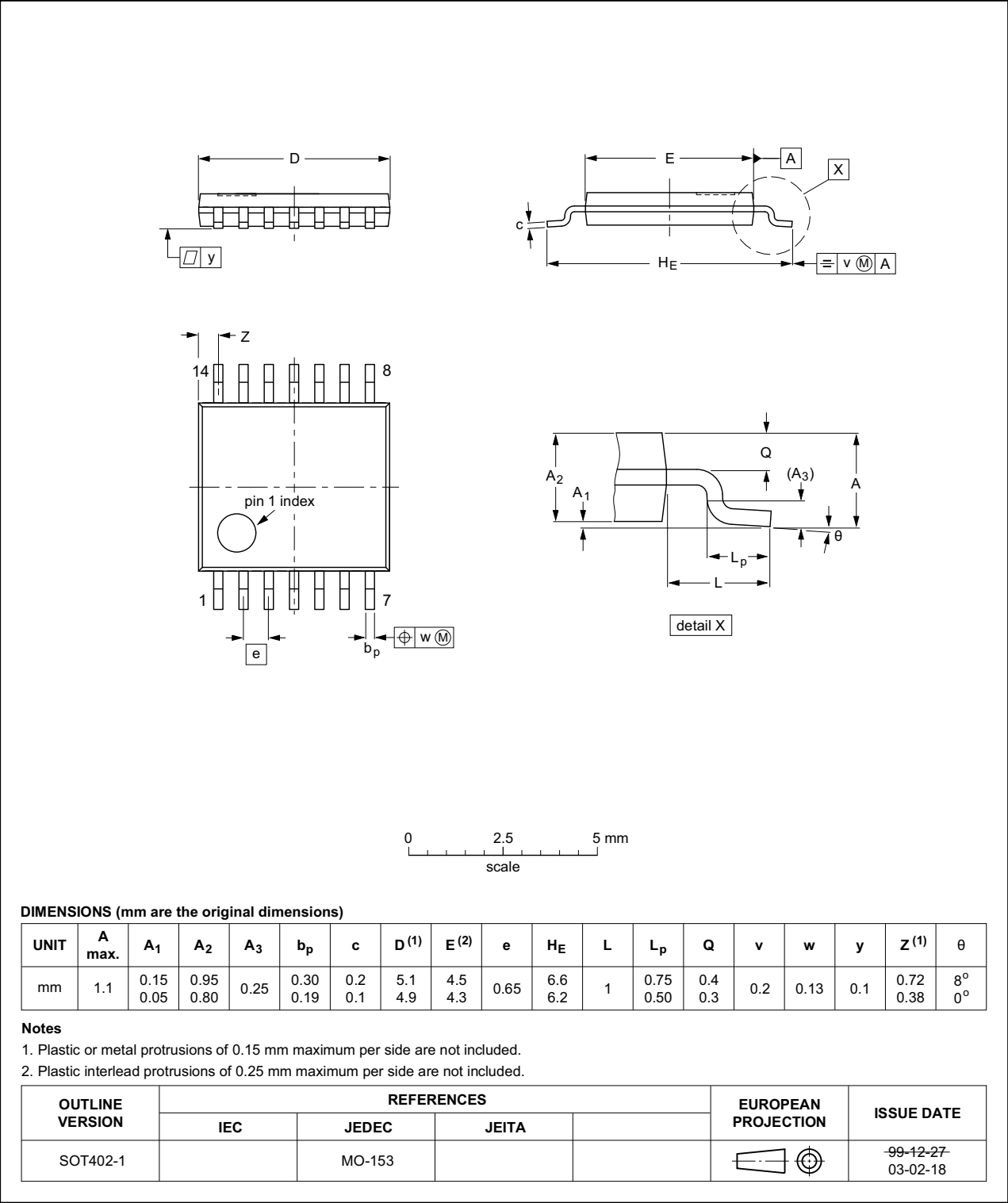


Fig 10. Package outline SOT402-1 (TSSOP14)
