XC7SH04 is a high-speed Si-gate CMOS device. It provides an inverting buffer.

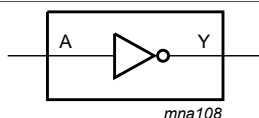


Fig. 1. Logic symbol

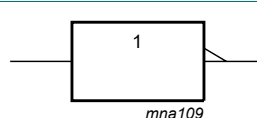


Fig. 2. IEC logic symbol

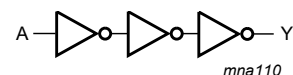
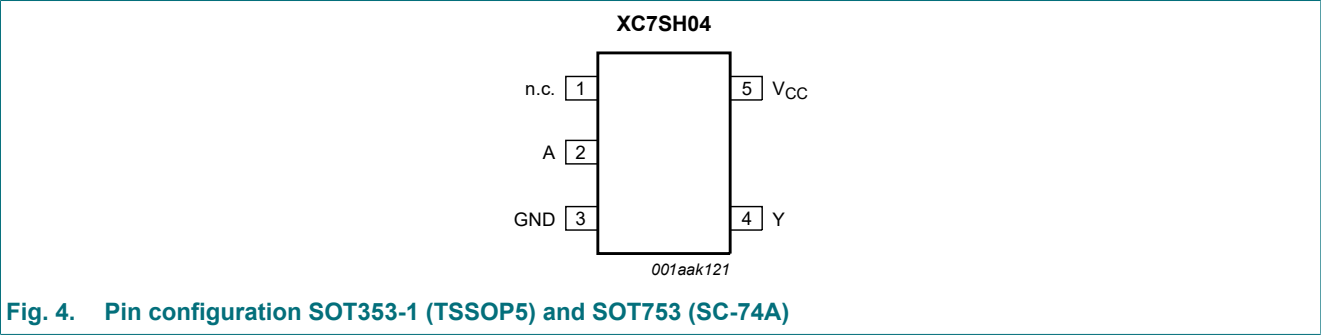


Fig. 3. Logic diagram

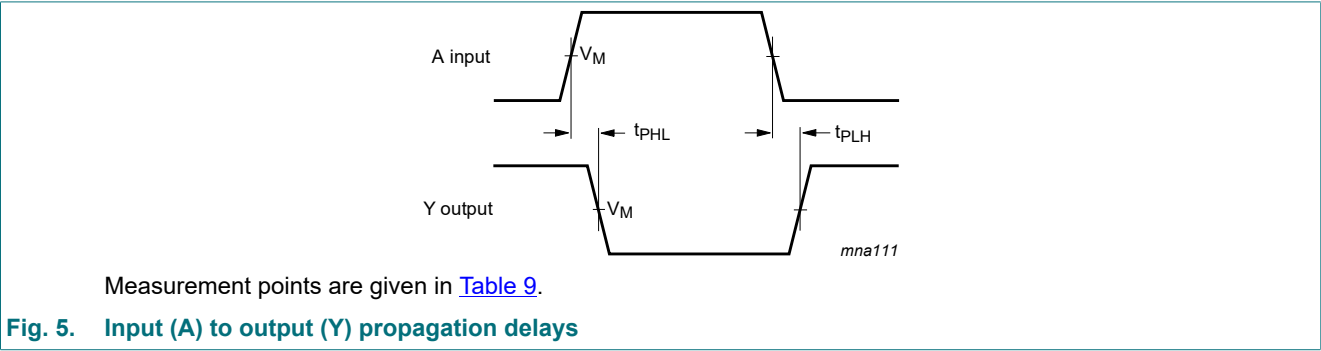

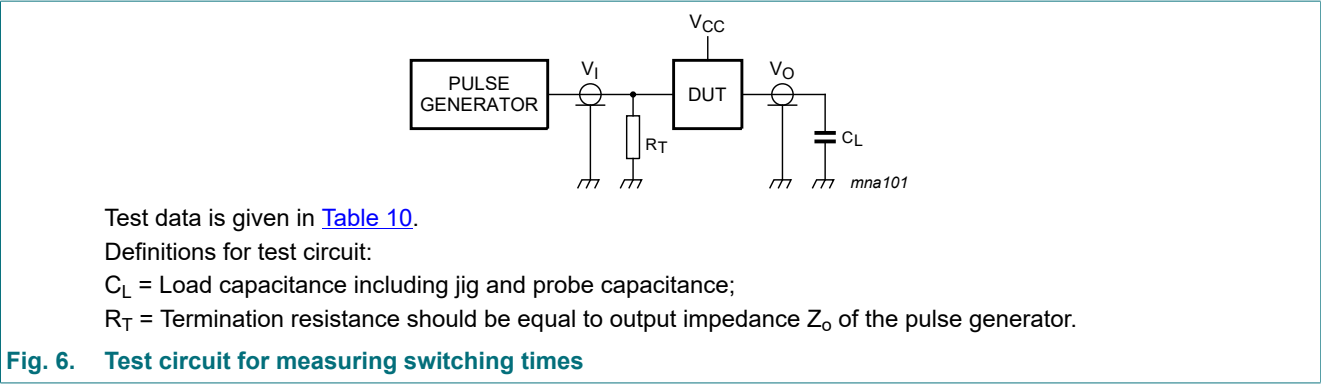

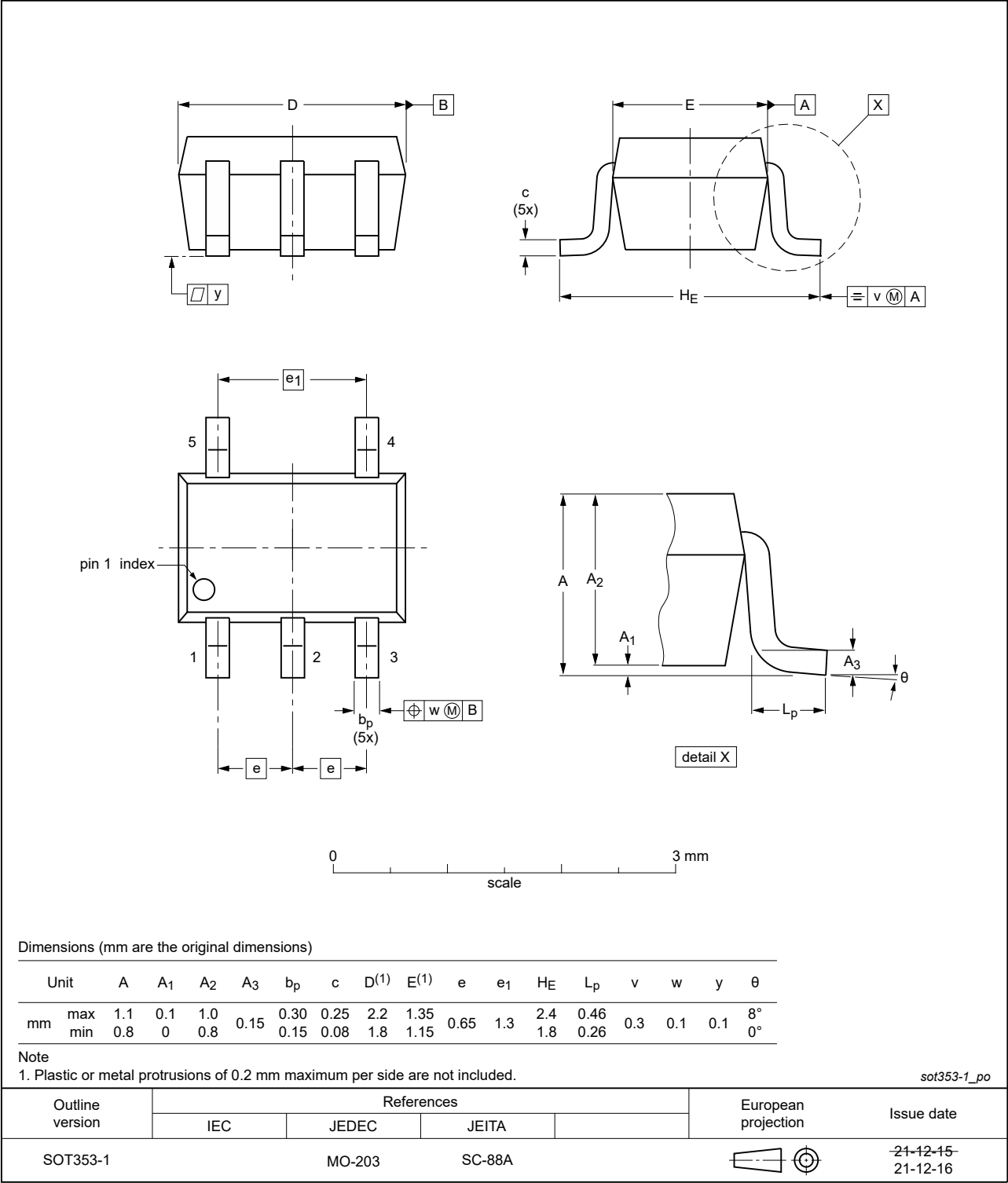


Fig. 7. Package outline SOT353-1 (TSSOP5)

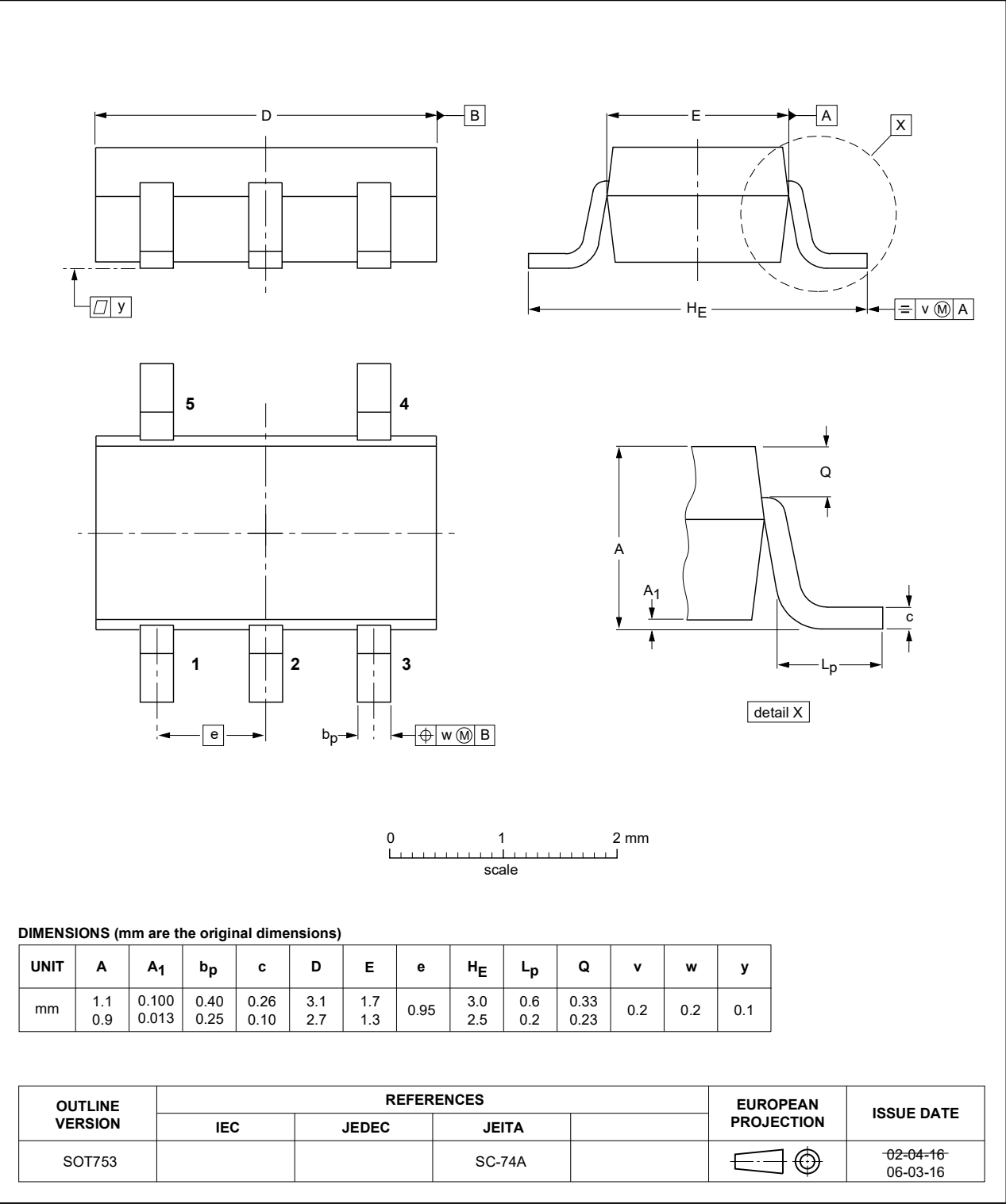


Fig. 8. Package outline SOT753 (SC-74A)
