






Fig. 3. DC current gain as a function of collector current; typical values






Fig. 4. Collector-emitter saturation voltage as a function of collector current; typical values

Off-state input voltage as a function of collector current; typical values





Fig. 7. Collector capacitance as a function of collector- Fig. 8. base voltage; typical values






