1. General description

NPN/PNP double transistor in a SOT666 ultra small and flat lead Surface-Mounted Device (SMD) plastic package.

2. Features and benefits

- 300 mW total power dissipation
- Very small 1.6 x 1.2 mm ultra thin package
- Self alignment during soldering due to straight leads
- Replaces two SC-75/SC-89 packaged transistors on same PCB area
- Reduced required PCB area
- Reduced pick and place costs.

- General purpose switching and amplification
- Complementary MOSFET driver for switch mode power supply
- Complementary driver for audio amplifiers.

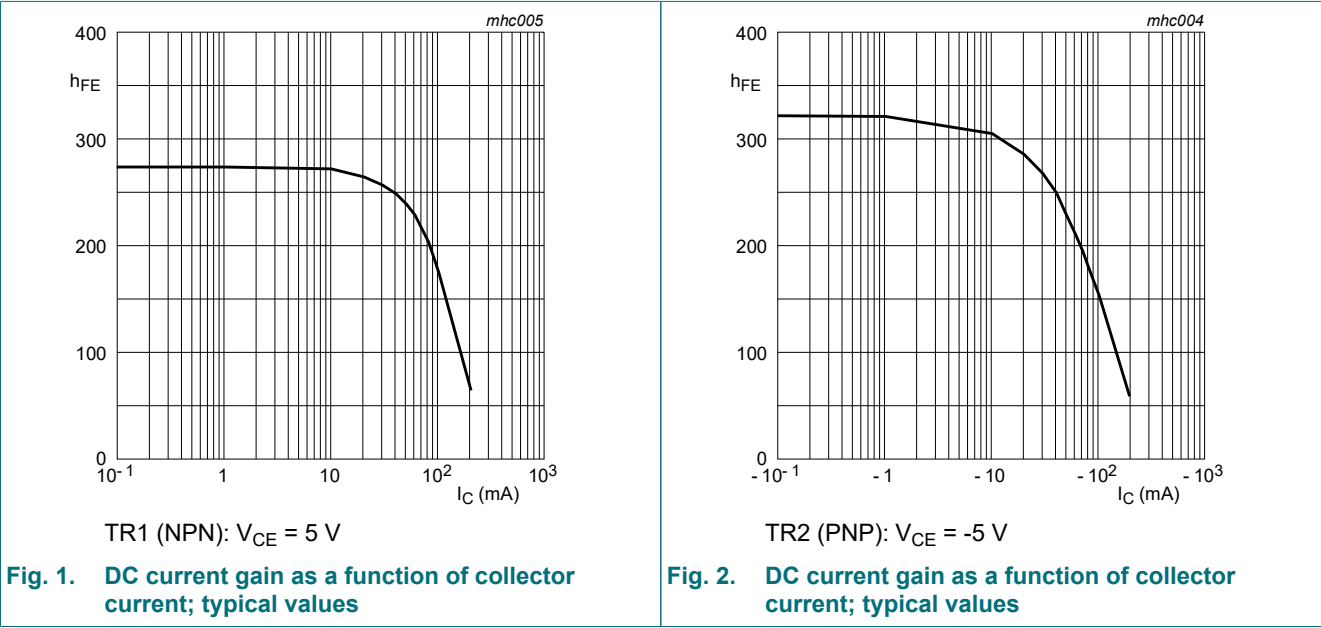

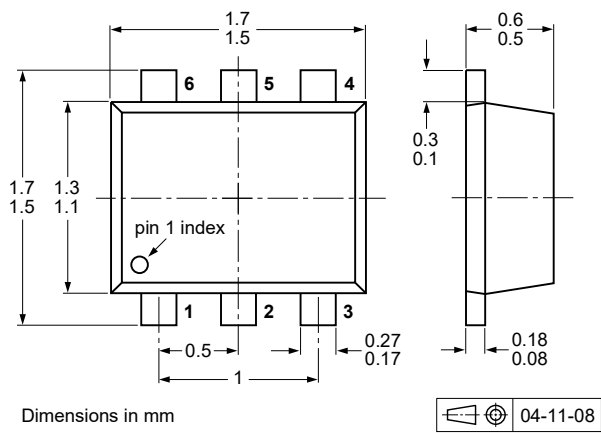


Fig. 3. Package outline SOT666

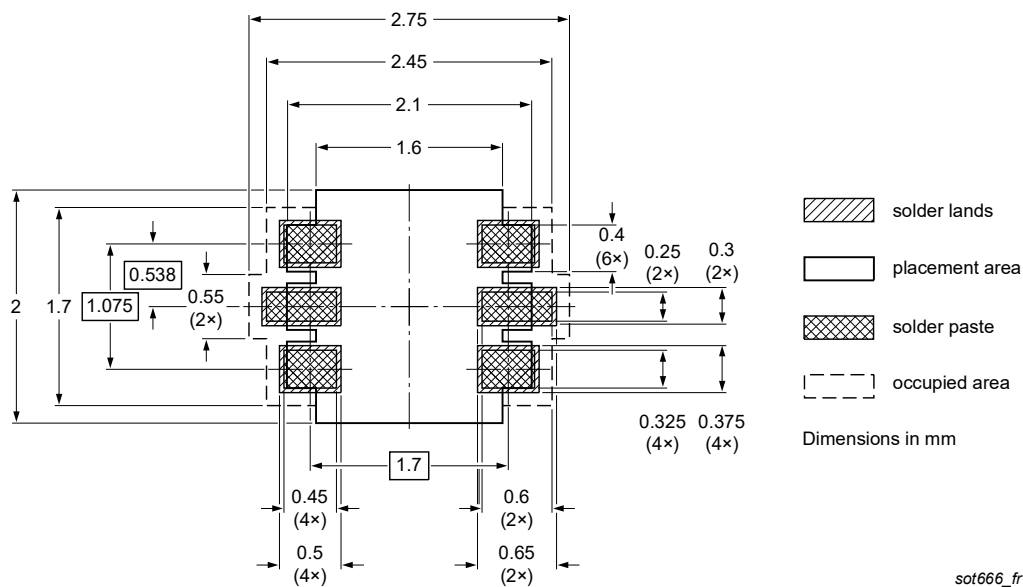


Fig. 4. Reflow soldering footprint for SOT666
