1. General description

Ultra low capacitance bidirectional double ElectroStatic Discharge (ESD) protection diode array in a SOT883 leadless ultra small Surface-Mounted Device (SMD) plastic package, designed to protect up to two signal lines from the damage caused by ESD and other transients.

- Bidirectional ESD protection of up to two lines
- Ultra low diode capacitance: $C_d = 2.9$ pF
- Ultra low leakage current: $I_{RM} = 5$ nA
- ESD protection up to 10 kV
- IEC 61000-4-2; level 4 (ESD)
- Qualified according to AEC-Q101 and recommended for use in automotive applications

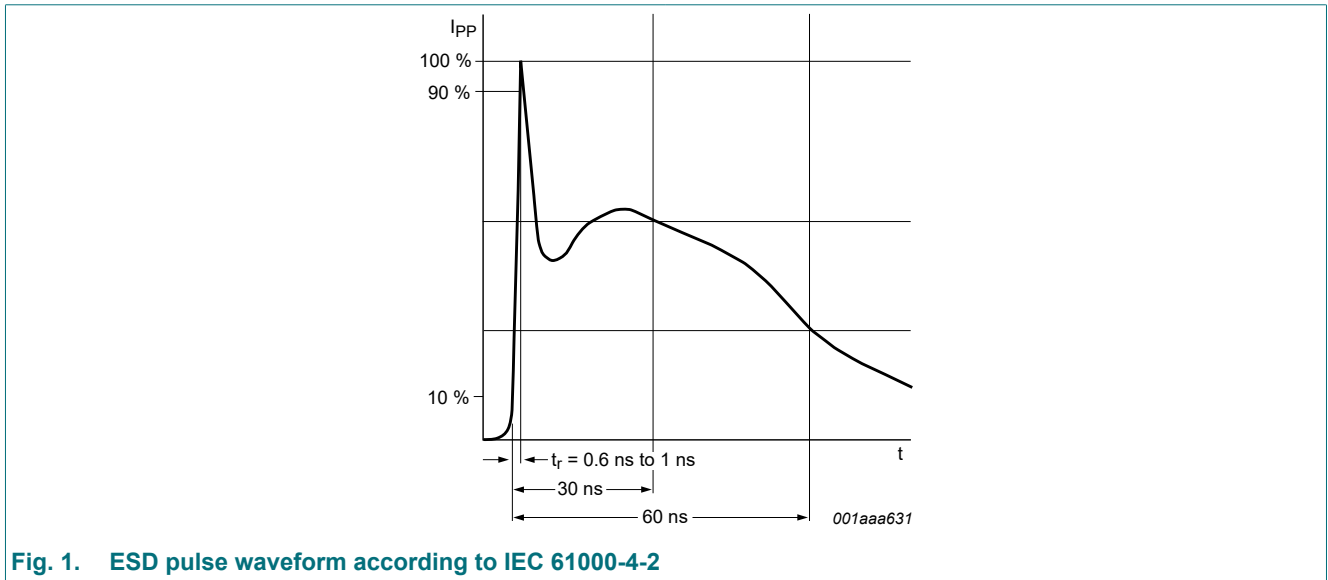
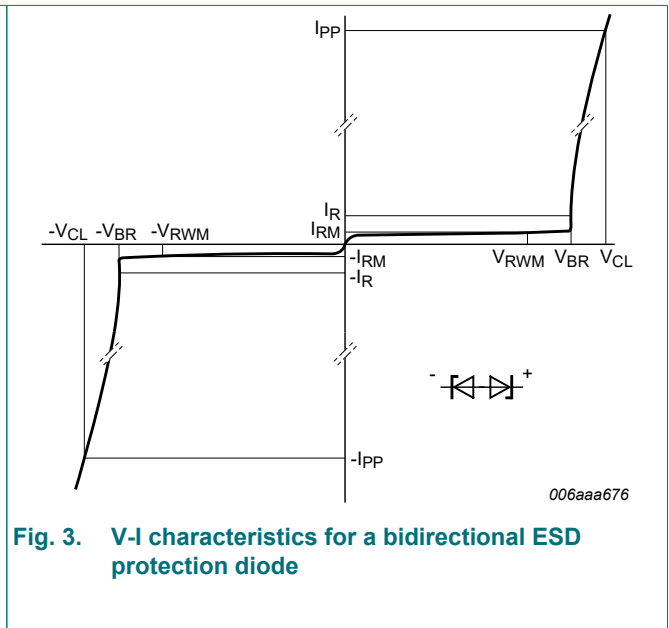
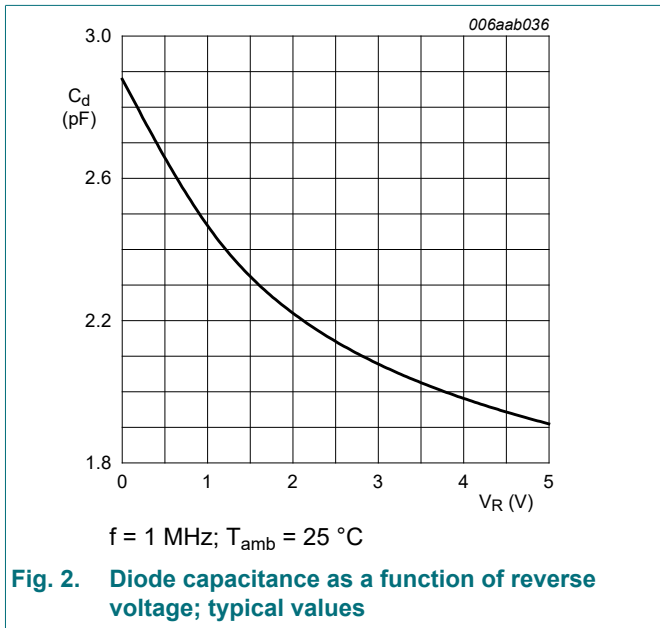


Fig. 1. ESD pulse waveform according to IEC 61000-4-2

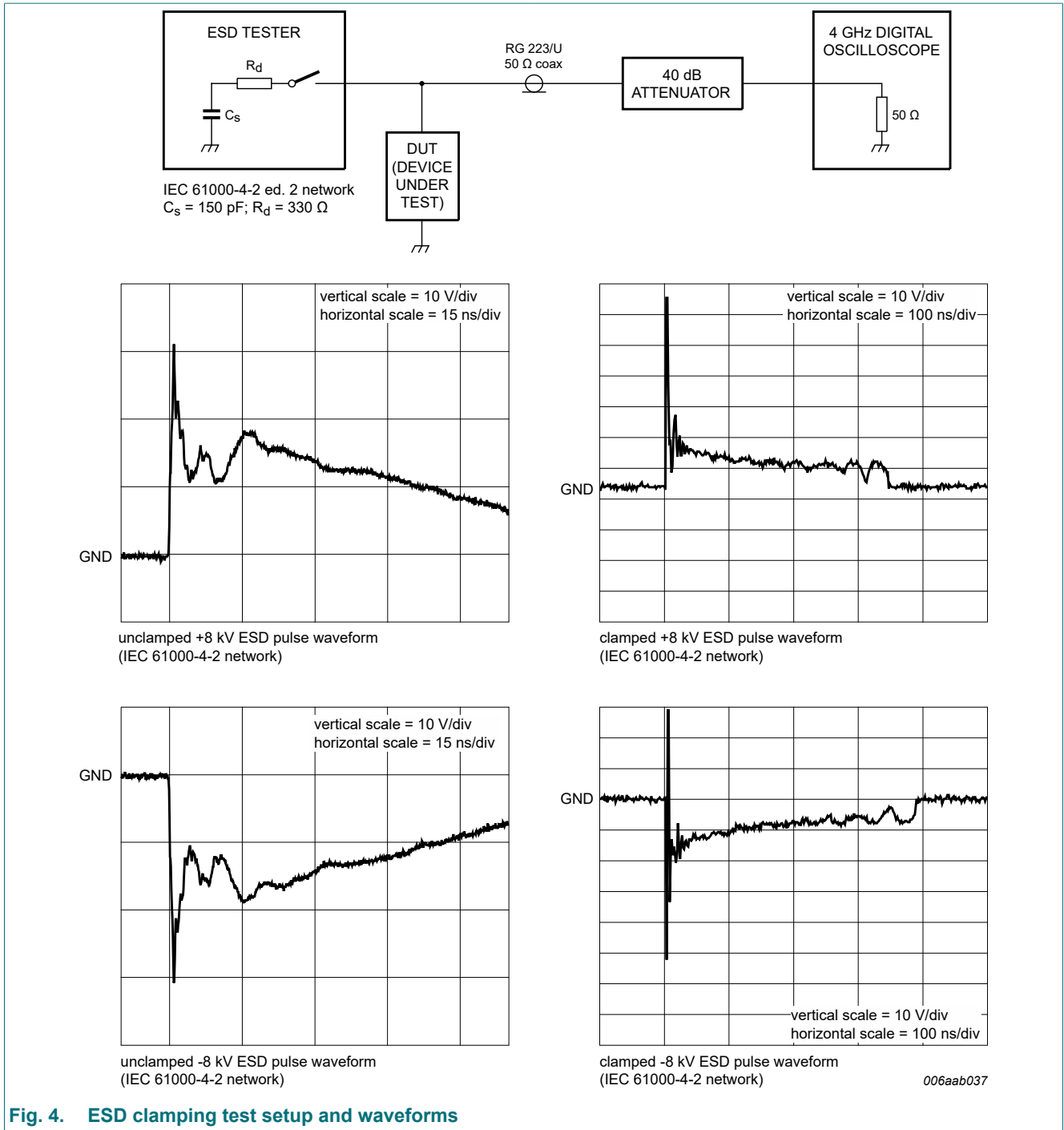

10. Application information

The device is designed for the protection of up to two bidirectional data or signal lines from the damage caused by ESD and surge pulses. The device may be used on lines where the signal polarities are both, positive and negative with respect to ground.

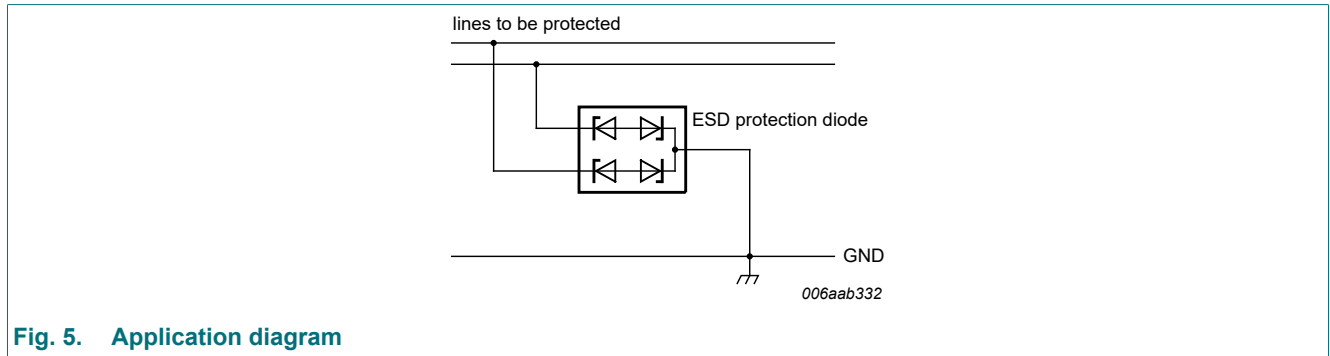


Fig. 5. Application diagram

Circuit board layout and protection device placement

Circuit board layout is critical for the suppression of ESD, Electrical Fast Transient (EFT) and surge transients. The following guidelines are recommended:

1. Place the device as close to the input terminal or connector as possible.
2. Minimize the path length between the device and the protected line.
3. Keep parallel signal paths to a minimum.
4. Avoid running protected conductors in parallel with unprotected conductors.
5. Minimize all Printed-Circuit Board (PCB) conductive loops including power and ground loops.
6. Minimize the length of the transient return path to ground.
7. Avoid using shared transient return paths to a common ground point.
8. Use ground planes whenever possible. For multilayer PCBs, use ground vias.

This product has been qualified in accordance with the Automotive Electronics Council (AEC) standard Q101 - *Stress test qualification for discrete semiconductors*, and is suitable for use in automotive applications.

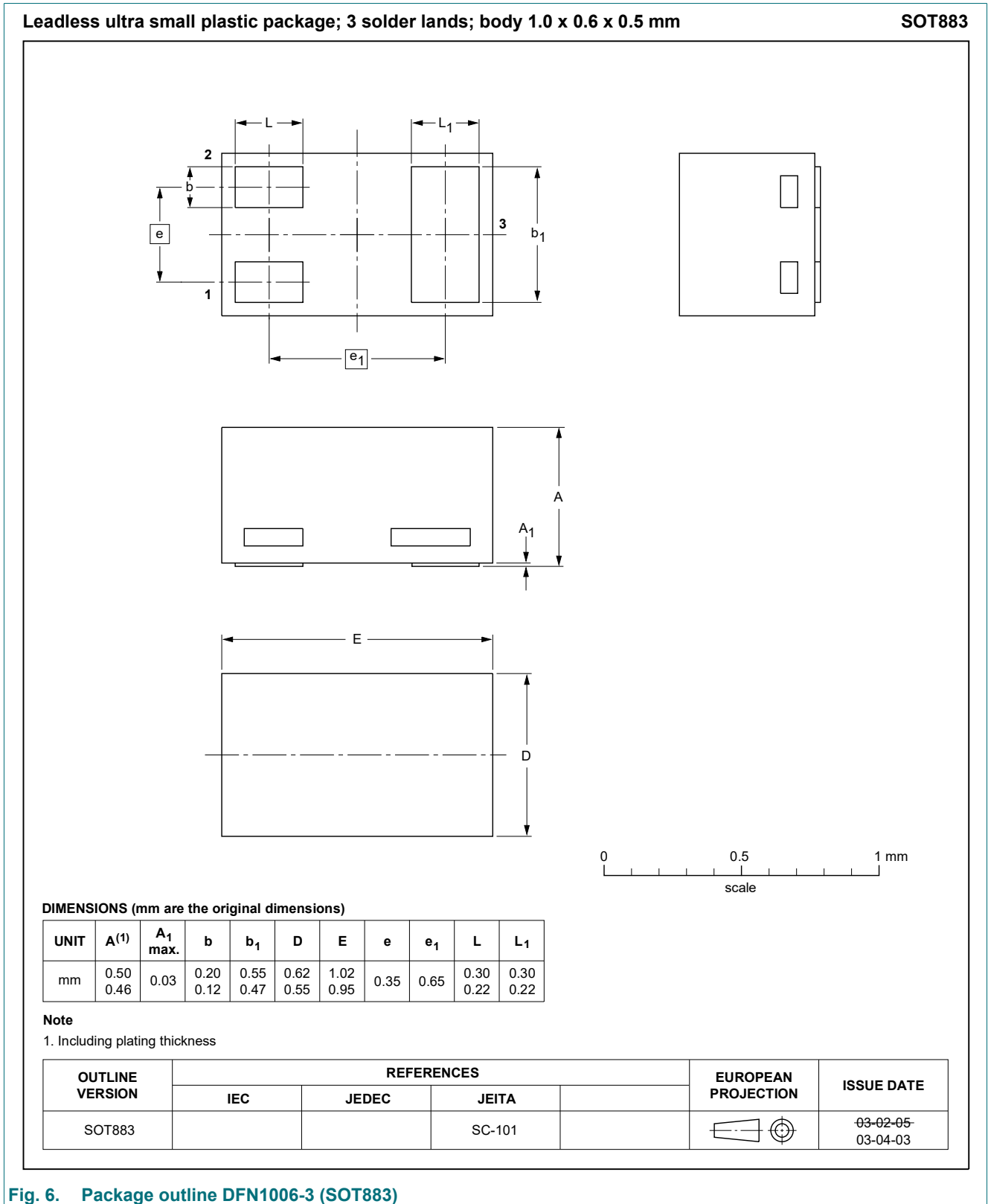


Fig. 6. Package outline DFN1006-3 (SOT883)

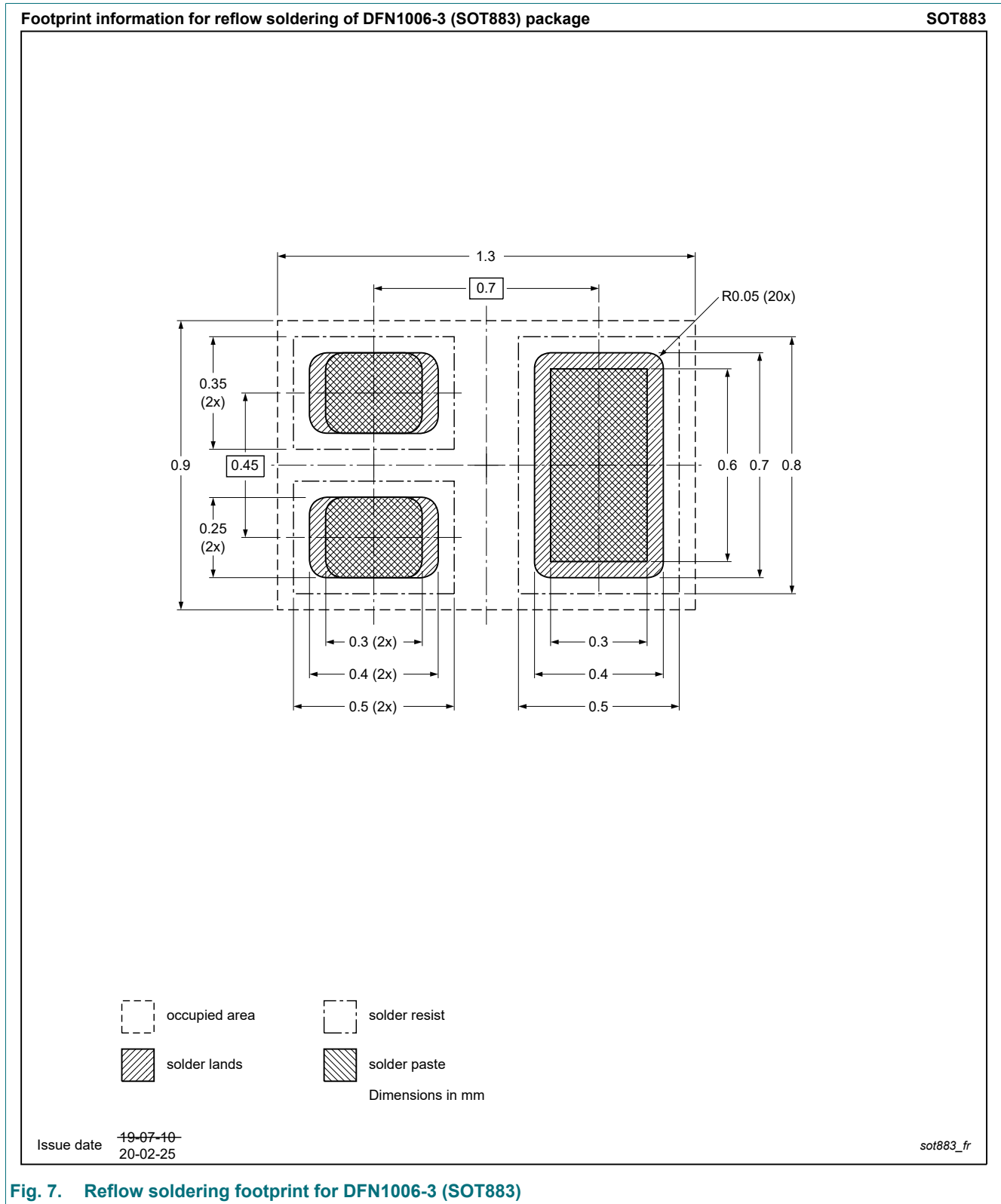


Fig. 7. Reflow soldering footprint for DFN1006-3 (SOT883)
