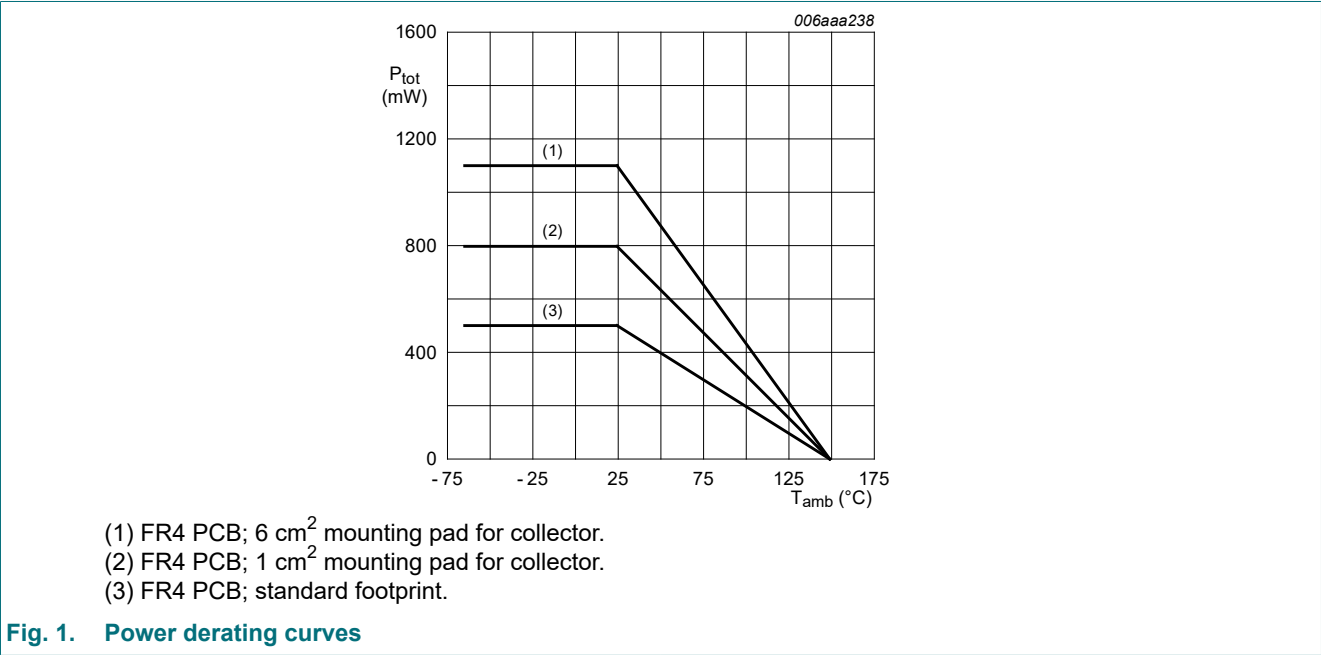

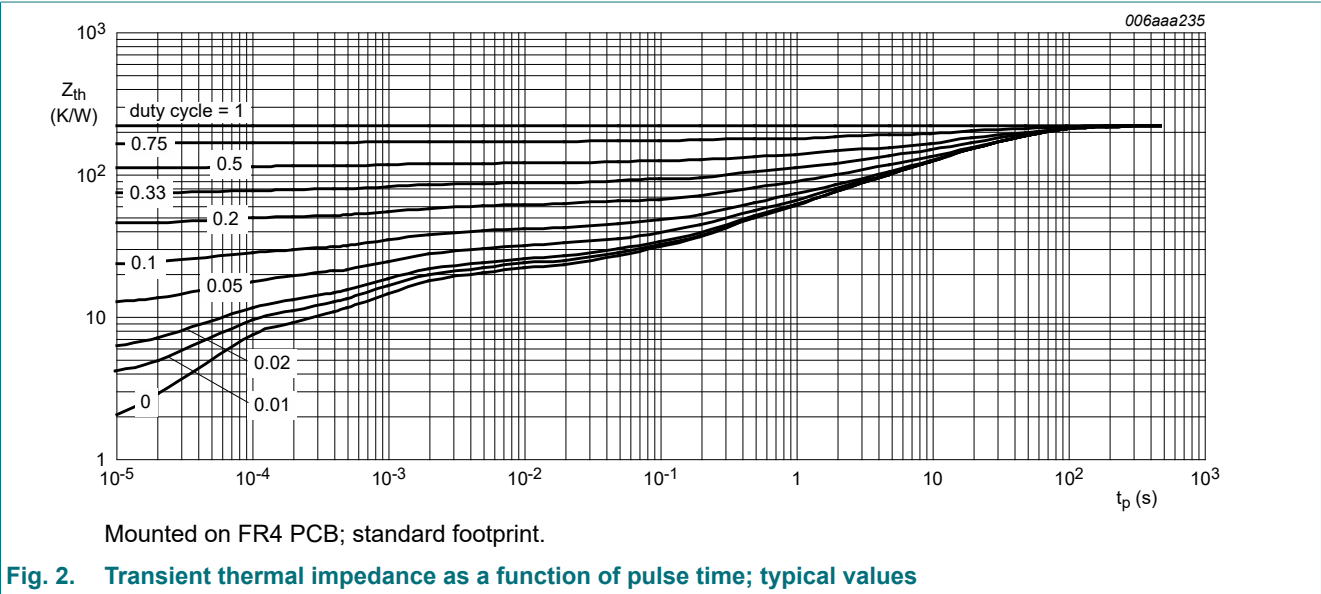


Fig. 2. Transient thermal impedance as a function of pulse time; typical values

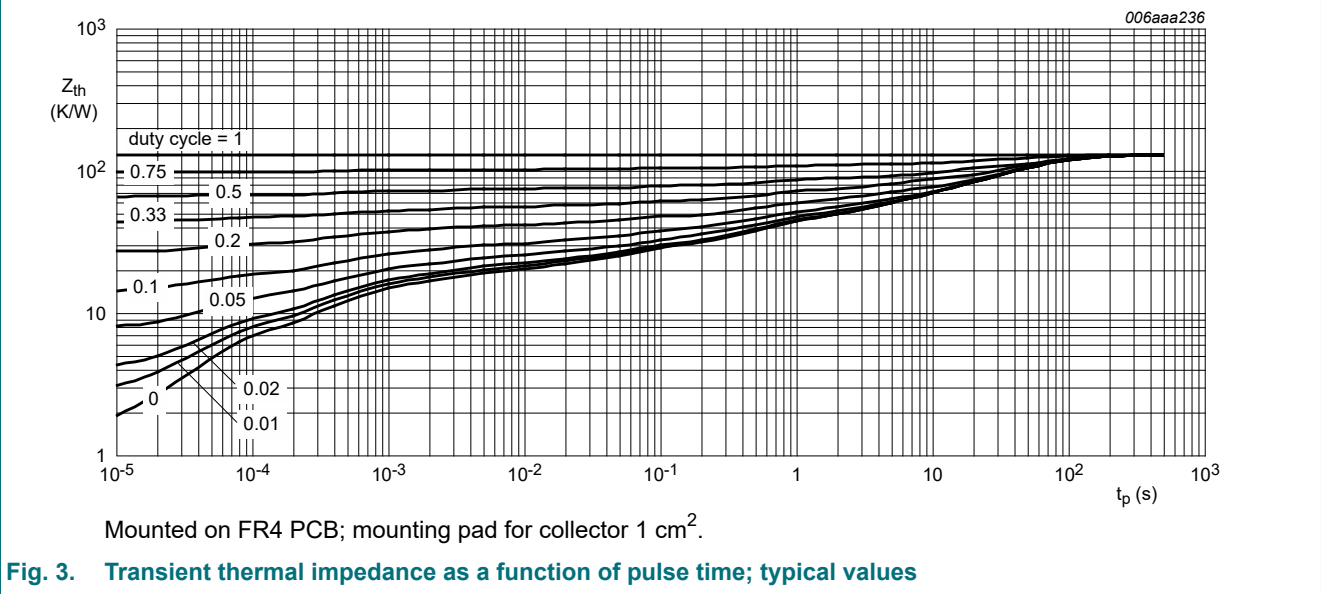


Fig. 3. Transient thermal impedance as a function of pulse time; typical values

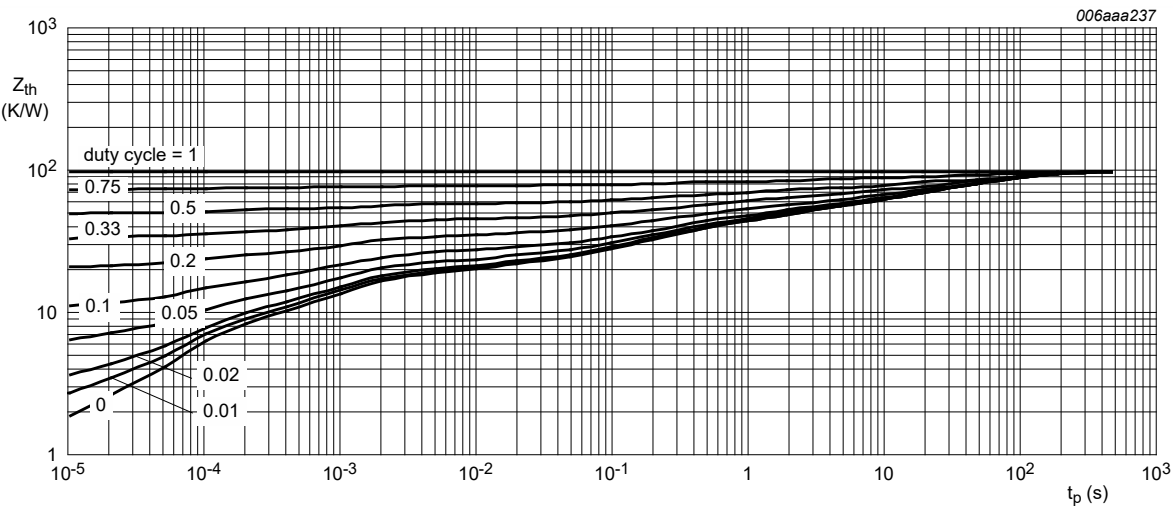


Fig. 4. Transient thermal impedance as a function of pulse time; typical values

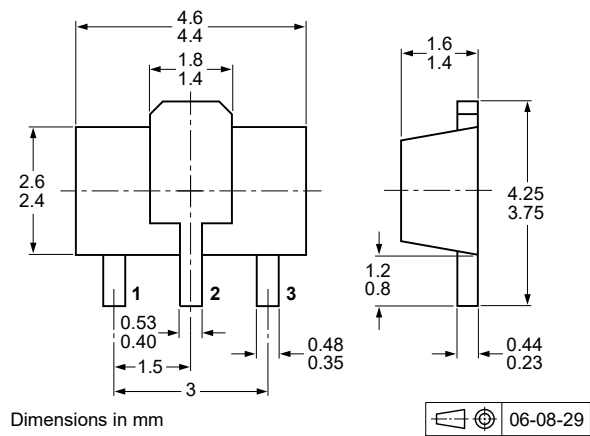


Fig. 5. Package outline SOT89

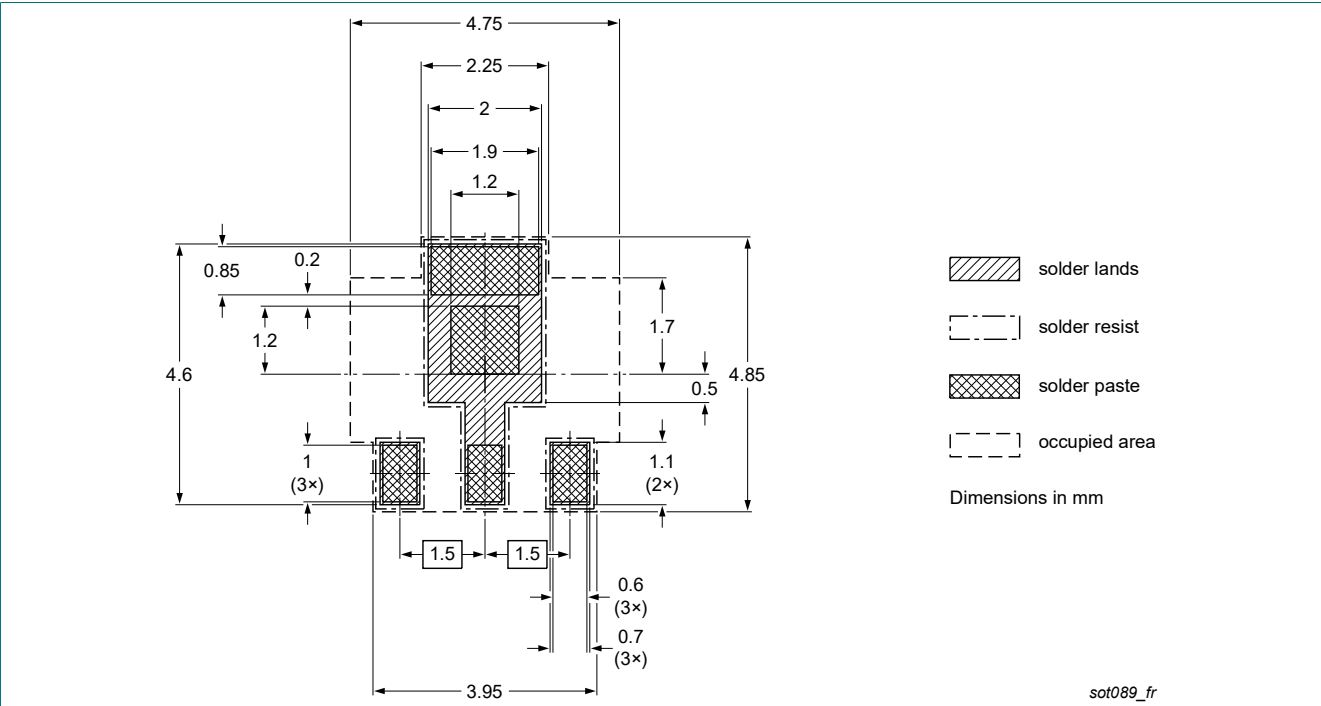


Fig. 6. Reflow soldering footprint for SOT89

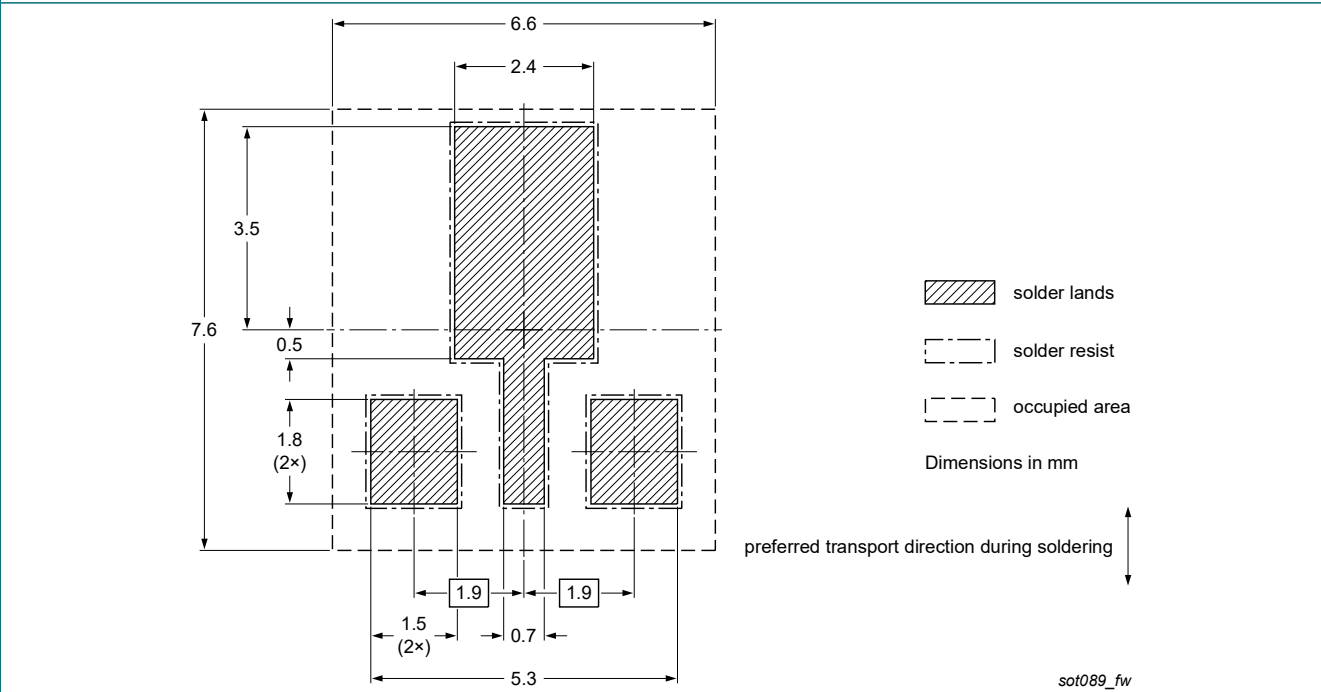


Fig. 7. Wave soldering footprint for SOT89
