



Fig. 1. Forward current as a function of forward voltage; typical values




- (1)  $T_{amb} = 85 \, ^{\circ}C$

- (3)  $T_{amb} = -40 \, ^{\circ}C$


Fig. 2. Reverse current as a function of reverse voltage; typical values


