

Fig. 1. Power derating curves





Fig. 2. Transient thermal impedance from junction to ambient as a function of pulse duration; typical values




FR4 PCB; single-sided copper; tin-plated; mounting pad for collector 1 cm<sup>2</sup>



Fig. 5. DC current gain as a function of collector current; typical values





Fig. 7. Collector current as a function of collectoremitter voltage; typical values









Fig. 11. Collector-emitter saturation voltage as a function of collector current; typical values






Fig. 14. Transition frequency as a function of collector current; typical values




