


Fig. 1. Normalized total power dissipation as a function of mounting base temperature

$$P_{der} = \frac{P_{tot}}{P_{tot(25^{\circ}C)}} \times 100\%$$





Fig. 2. Normalized continuous drain current as a function of mounting base temperature

 $T_{amb} = 25^{\circ}C; I_{DM}$ is single pulse







Fig. 6. Drain-source on-state resistance as a function of gate-source voltage; typical values






