1. General description

Standard level N-channel MOSFET in a D2PAK package qualified to 175 $^{\circ}$ C. Part of Nexperia's "NextPower Live" portfolio, the PSMN7R6-100BSE complements the latest "hot-swap" controllers - robust enough to withstand substantial inrush currents during turn on, whilst offering a low $R_{DS(on)}$ characteristic to keep temperatures down and efficiency up in continued use. Ideal for telecommunication systems based on a 48 V backplane / supply rail.




Fig. 1. Continuous drain current as a function of mounting base temperature




Fig. 2. Normalized total power dissipation as a function of mounting base temperature





Fig. 3. Single pulse avalanche rating; avalanche current as a function of avalanche time






Fig. 4. Safe operating area; continuous and peak drain currents as a function of drain-source voltage

 $T_{mb} = 25^{\circ}C$; I_{DM} is a single pulse






Fig. 6. Output characteristics; drain current as a function of drain-source voltage; typical values

 $T_j = 25^{\circ}C$




Fig. 7. Drain-source on-state resistance as a function of gate-source voltage; typical values




Fig. 8. Forward transconductance as a function of drain current; typical values

$$T_j = 25^{\circ}C; \ V_{DS} = 10V$$




Fig. 10. Sub-threshold drain current as a function of gate-source voltage

$$T_j=25\,^{\circ}C; V_{DS}=5V$$




Fig. 9. Transfer characteristics; drain current as a function of gate-source voltage; typical values

$$V_{DS} = 10V$$




Fig. 11. Gate-source threshold voltage as a function of junction temperature

$$I_D = 1 \text{ mA}; \ V_{DS} = V_{GS}$$




Fig. 12. Drain-source on-state resistance as a function of drain current; typical values

$$T_j = 25^{\circ}C$$




Fig. 14. Gate charge waveform definitions




Fig. 13. Normalized drain-source on-state resistance factor as a function of junction temperature

$$a = \frac{R_{DSon}}{R_{DSon (25^{\circ}C)}}$$




Fig. 15. Gate-source voltage as a function of gate charge; typical values

°C; $I_D = 25$ A




Fig. 16. Input, output and reverse transfer capacitances as a function of drain-source voltage; typical values






Fig. 17. Source current as a function of source-drain voltage; typical values




Fig. 18. Package outline D2PAK (SOT404)
