1. General description

The 74HC20-Q100 is a dual 4-input NAND gate. Inputs include clamp diodes. This enables the use of current limiting resistors to interface inputs to voltages in excess of V_{CC} .

This product has been qualified to the Automotive Electronics Council (AEC) standard Q100 (Grade 1) and is suitable for use in automotive applications.











Fig. 9. Package outline SOT108-1 (SO14)




Fig. 10. Package outline SOT402-1 (TSSOP14)
