### 1. General description

The 74LVC1G34 is a single buffer. Inputs can be driven from either 3.3 V or 5 V devices. This feature allows the use of these devices as translators in mixed 3.3 V and 5 V environments.

Schmitt-trigger action at all inputs makes the circuit tolerant of slower input rise and fall times.

This device is fully specified for partial power down applications using  $I_{OFF}$ . The  $I_{OFF}$  circuitry disables the output, preventing the potentially damaging backflow current through the device when it is powered down.




### 5. Functional diagram








Fig. 6. Package outline SOT353-1 (TSSOP5)




Fig. 7. Package outline SOT753 (SC-74A)




Fig. 8. Package outline SOT886 (XSON6)




Fig. 9. Package outline SOT1115 (XSON6)




Fig. 10. Package outline SOT1202 (XSON6)




Fig. 11. Package outline SOT1226-3 (X2SON5)




Fig. 12. Package outline SOT1269-2 (X2SON4)




Fig. 13. Package outline SOT8065-1 (XSON5)
