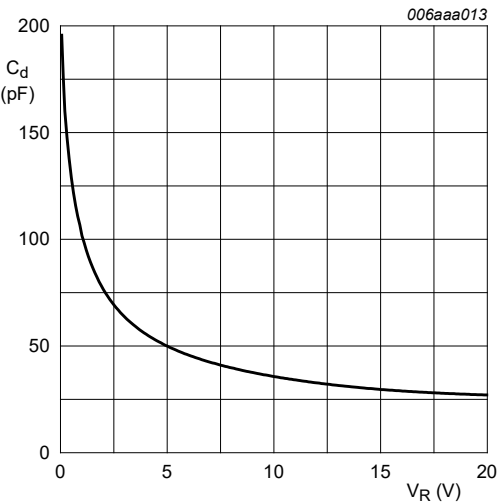

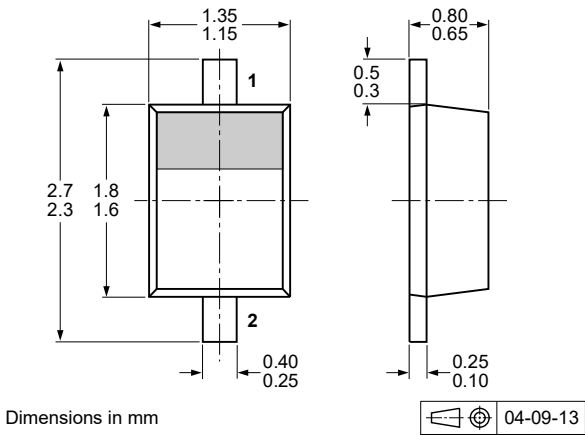
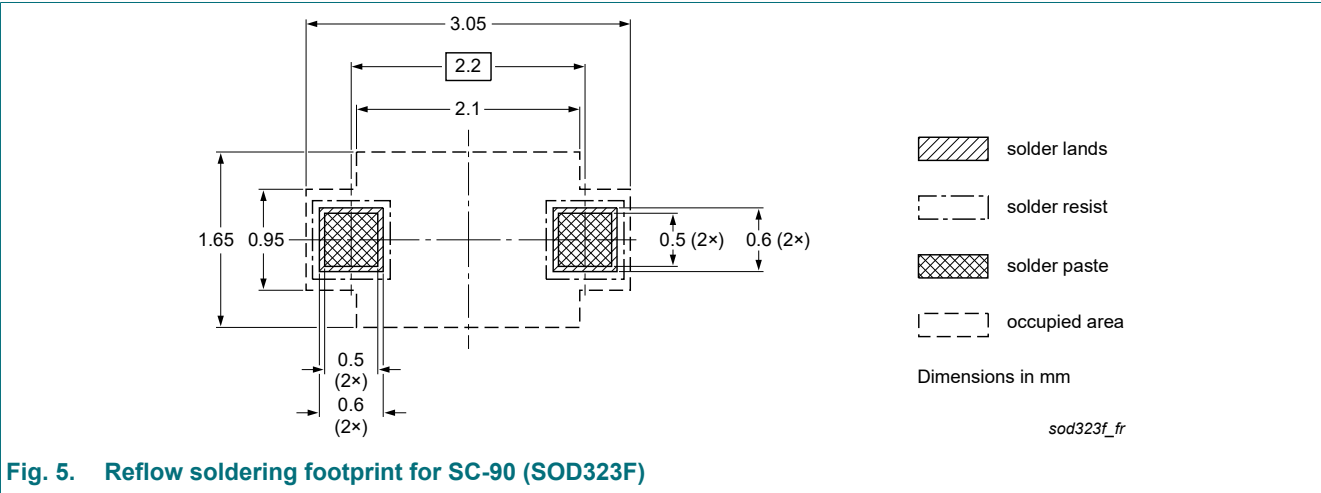


Fig. 4. Package outline SC-90 (SOD323F)
