The 74HC00; 74HCT00 is a quad 2-input NAND gate. Inputs include clamp diodes. This enables the use of current limiting resistors to interface inputs to voltages in excess of  $V_{CC}$ .







#### 10.1. Waveforms and test circuit





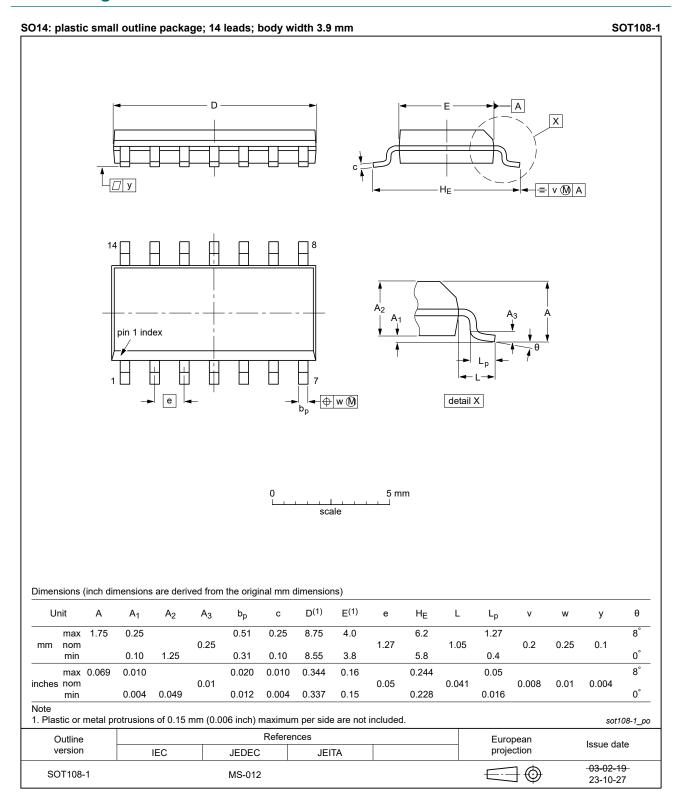


Fig. 6. Package outline SOT108-1 (SO14)




Fig. 7. Package outline SOT402-1 (TSSOP14)




Fig. 8. Package outline SOT762-1 (DHVQFN14)
