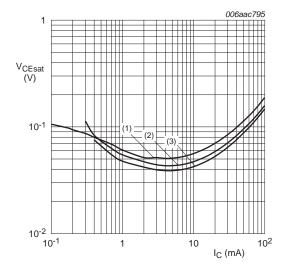

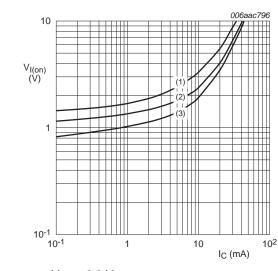

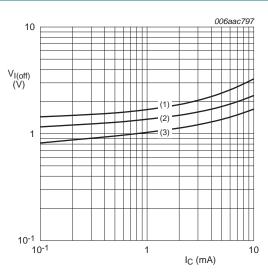

Fig 7. Off-state input voltage as a function of collector current; typical values

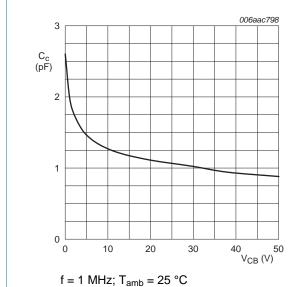
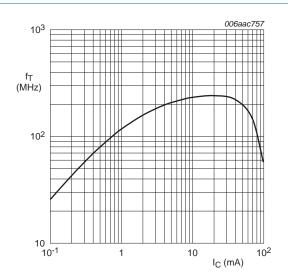


Fig 8. Collector capacitance as a function of collector-base voltage; typical values

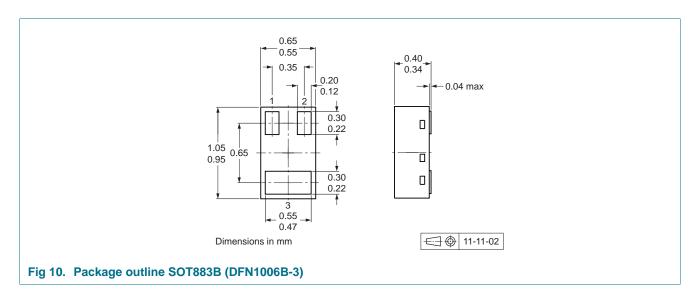

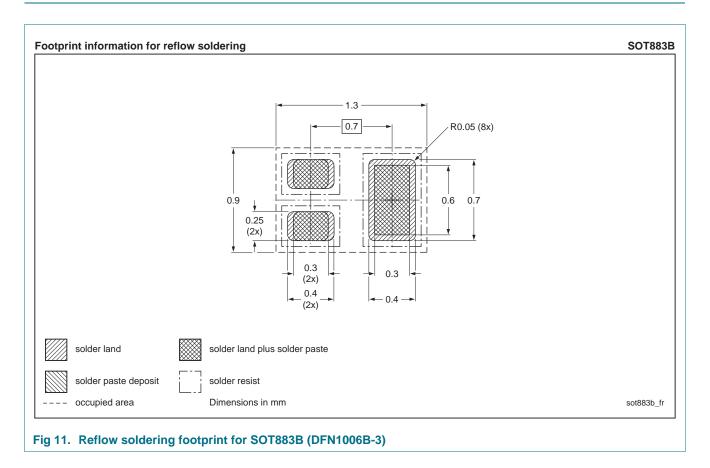
